Reason for Call In

I have looked carefully at this proposed cycle route – it goes nowhere that cannot be arrived at more simply. To either side of it, running parallel are quiet cul-de-sac roads which are suitable for cyclists, whilst the access to the service road from the path concerned requires turning left or right to meet with either of these roads – because of a hedge and ditch between the service road and Hockcliffe Road itself there is nowhere else to go!

Notwithstanding, the proposal is also dangerous on a number of counts:

- 1. All the side accesses to the proposal, of which there are several, will remain as footpaths, but these are not obvious to cyclists who will not perceive a need to slow down, whilst a walker on one of these sections with a pushchair can too easily push their charge into the path of a cyclist without realising that they are being approached.
- 2. The egress at the service road is also dangerous despite a low volume of traffic, or perhaps because of it, a cyclist entering that road is vulnerable particularly if turning right I note that such an incident was reported when the matter was first discussed on 19 Jan 2010.

Recommendations Proposed

I believe that we should leave well alone and abandon what can only be described as an ill-conceived attempt to justify spending available money for the sake of it!
