Purpose of this report

To report on the petition to extend 'Waiting Restrictions' along either the Eastern or Western side of The Pyghtle from the Sampshill Road Junction.

RECOMMENDATIONS

- 2. Accept the petition request to extend 'Waiting Restrictions' along the Eastern side of The Pyghtle.

Issues

Background Information

- Central Bedfordshire Council received a petition in November 2017 to extend the double yellow lines, on one side of The Pyghtle, from the Sampshill Road junction, to the drive of No.16. However, this petition was deemed invalid as the it was more than 6 months old.
- 2. This is a new petition which has the same statement and states is 'to improve access for emergency vehicles, refuse lorries, delivery, large vehicles, etc.'

3. The Pyghtle is a cul-de-sac serving many residential properties.

Options for consideration

- 4. The installation of waiting restrictions on the Eastern side of The Pyghtle for approximately 12m, from the junction with Sampshill Rd up to the driveway of No.16.
- 5. The installation of waiting restrictions on the Western side of The Pyghtle for approximately 12m, from the junction with Sampshill Rd up to the driveway of No.16.

Reason/s for decision

- 6. The proposal to extend the double yellow line waiting restrictions along the Eastern side of The Pyghtle is accepted for the following reasons:
 - a. Residents currently park on both sides of the road narrowing the carriageway in that location which reduces visibility upon exit and entry into The Pyghtle.
 - b. Larger vehicles may not be able to enter The Pyghtle.
 - c. Residents can park their vehicles on the Western side of the that section of the road.
 - d. Waiting restrictions along the Western side could encourage vehicles to right turn from Sampshill Rd into The Pyghtle on the opposing side of the carriageway leading to collision with vehicles exiting The Pyghtle.
