3. Bedford Borough is to establish their LINK on 1st April but it has neither elected its officers, established its committee nor has the handover from Voluntary Action Luton to Age Concern Bedfordshire taken place.

4. A piece of work by a Bedfordshire LINK member has been accepted by the British Orthopaedic Association for publication on their website. The work emphasises joint working between health and social care. It is "Guidance For Elderly Patients With Hip Fractures - Expectations of Elderly Orthopaedic Patients who have broken their hip". The National Clinical Director for Trauma Care who is charged with writing government policy is to discuss it with the Department of Health for their endorsement and integrate it into commissioner guidance
