### **RECOMMENDATIONS:**

The Committee is asked to:

- 1. Consider the results of the public consultation;
- 2. Decide whether or not to recommend that a new parish should be constituted for the area known as Fairfield;
- 3. Recommend that, if a new parish is so constituted, that it be called Fairfield Community Council;
- 4. Make any consequential changes to the area of Stotfold Town Council; and
- 5. Amend the Terms of Reference of the Review so that the second stage consultation period will be extended until 23 January 2012 and that the subsequent stages of the timetable will also be deferred by 14 days in each case.

### Background

9. At the meeting of this Committee on the 4 August 2011 it was resolved to carry out a Community Governance Review, in accordance with Local Government and Public Involvement in Health Act 2007 (the Act), of the Fairfield area of Stotfold. A Map showing the Fairfield area is attached at Appendix A. A community governance review (formerly known as a parish review) is a review

of the whole or part of a principal council's area for the purpose of making recommendations with regard to creating, merging or abolishing parishes, the naming of parishes, the electoral arrangements for parishes and grouping arrangements for parishes.

10. The principal council must consult the local government electors for the area under review and any other person or body (including a local authority) who appears to have an interest in the review. In carrying out the review every household within the parish of Stotfold was consulted together with the list of interested parties as shown at Appendix B.

### Criteria for undertaking a review

- 11. Section 93 of the Act requires principal councils to ensure that community governance within the area under review will be:
  - reflective of the identities and interests of the community in that area; and
  - effective and convenient.
- 12. When considering the criteria identified in the Act, principal councils should take into account a number of influential factors, including:
  - the impact of community governance arrangements on community cohesion; and
  - the size, population and boundaries of a local community or parish.
- 13. In considering the criteria, the impact on community cohesion is linked specifically to the identities and interests of local communities. Size, population and boundaries are linked to both but perhaps more specifically to community governance being effective and convenient.

### Consultation

- 14. Councils are required to consider representations made by local people and interested parties.
- 15. In carrying out the consultation with the Stotfold parish electorate and the interested parties all respondents were invited to agree or to disagree with the proposal to create a new Fairfield Community Council. Additionally, there was also an opportunity to add any comments. The results of the consultation together with analysis of the comments are shown at Appendix C,
- 16. Representations have also been received from Stotfold Town Council (Appendix D) with a further submission by the Fairfield Community Action Group (Appendix E).

### Timing

- 17. Principal councils are required to complete the review, including consequential recommendations to the Local Government Boundary Committee for England for related alterations to the boundaries of principal area wards, within 12 months of the start of the review.
- 18. Reorganisation of community governance orders creating new parishes, abolishing parishes or altering their area can be made at any time following a review. However, for administrative and financial purposes (such as setting up the parish council and arranging its first precept), the order should take effect on the 1 April following the date on which it is made. Electoral arrangements for a new or existing parish council will come into force at the first elections to the parish council following the reorganisation order. However, orders should be made sufficiently far in advance to allow preparations for the conduct of those elections to be made.
- 19. Parish council elections should normally take place every four years at the same time as the elections for the district/unitary authority ward. However, where a new parish is to be created, it may be necessary to altar the date of the next parish election, particularly if the next elections to the ward are not scheduled to take place for some time. Section 98 of the Act allows principal councils to modify or exclude sections of the Local Government Act 1972 so that the first election to the new parish council is held in an earlier year. This would result in councillors serving either a shortened or lengthened first term to allow the parish council's electoral cycle to return to that of the unitary ward at the next election.

### **Recommendations and Decisions**

- 20. In conducting community governance reviews (whether initiated by itself or is triggered by a valid petition), the principal council should consider the impact on community cohesion when deciding whether or not to set up a parish council.
- 21. A principal council must make recommendations as to:
  - (a) Whether a new parish or any new parishes should be constituted;
  - (b) Whether existing parishes should be abolished or whether the area of the existing parishes should be altered; or
  - (c) What the electoral arrangements for new or existing parishes, which are to have parish councils, should be.
- 22. The recommendations must take account of any representations received and should be supported by evidence which demonstrates that the recommended community governance arrangements would meet the criteria in the Act. Where a principal council has conducted a review following receipt of a petition, it will remain open to the council to make a recommendation which is different to the recommendation the petitioners wished the review to make.

- 23. In making its recommendations, the review should consider the information it has received in the form of expressions of local opinion on the matters considered by the review, representations made by local people and other interested persons, and also use its own knowledge of the local area. In taking this evidence into account and judging the criteria in the Act against it, a principal council may reasonably conclude that a recommendation set out in a petition should not be made. For example, a recommendation to abolish or establish a parish council, may negatively impact on community cohesion, either within the proposed parish area, or in the wider community within which it would be located, and therefore should not be made.
- 24. The aim of the Act is to open up a wider choice of governance to communities at the most local level. However, the Government considers that there is sufficient flexibility for principal councils not to feel 'forced' to recommend that the matters included in every petition must be implemented.

### Alternative Styles for Parishes

- 25. The Act introduced amendments to the Local Government 1972 to bring 'alternative styles' for parish councils. Three alternative styles are permitted by the Act:
  - (a) Community
  - (b) Neighbourhood
  - (c) Village
- 26. Where the review relates to a new parish, it is for the principal council, in the first instance, to make recommendations as to the geographical name of the new parish, and as to whether or not it should have one of the alternative styles.

### **Council size**

- 27. Council size is the term used to describe the number of councillors to be elected to the whole council. The Local Government Act 1972, as amended, specifies that each parish council must have at least five councillors; there is no maximum number.
- 28. Research carried out in 1992, found that the typical parish council representing less than 500 people had between five and eight councillors, and those between 501 and 2,500 had six to twelve councillors.

### **Publicising Draft Proposals**

29. Under the Act the principal council must both publish its recommendations and ensure that those who have an interest are informed of them.





### Introduction

Between August and November 2011 Central Bedfordshire Council undertook a Community Governance Review to consult residents of Stotfold Parish on the proposal to create a new Fairfield Community Council.

Residents, members of the public and interested organisations were able to give their views on the proposal during a 12 week consultation period.

Views were sought through a paper and online questionnaire. A paper copy of the questionnaire was delivered to every household in the Stotfold Parish along with an accompanying information sheet about the Community Governance Review and proposed boundary map for the proposed Fairfield area. An online questionnaire and the related information were also made available from the Central Bedfordshire Council website.

979 responses were received to the Community Governance review; 775 responses to the paper form and 204 responses to the online form.

The response to this survey represents 10% of the Stotfold Parish (2010 mid year estimates ONS population for Stotfold was 8,822<sup>1</sup>).


Whilst only a small proportion of Stotfold Parish responded to this survey, the demographic profile of respondents to the survey is broadly in line with the demographic of Stotfold parish, although older people are over represented and young people are under represented in the survey response.

The address and postcode data provided in responses has been analysed to determine the level of responses by area.

Almost all of the responses received were from residents or organisations identified themselves as being based within the existing Stotfold Parish (99%).


Just over half of the respondents indicated they were from the proposed Stotfold area and 45% of the respondents indicated they were from the proposed Fairfield area.

Less than one percent of the responses received were from Letchworth Garden City, Ampthill. Arlesey and Hitchin collectively.

### Results



73% of people responding to this Community Governance Review supported the proposal to create a new Fairfield Community Council (707 people). 27% of people responding to this review did not support this proposal (256 people).

Respondents from the proposed Fairfield area were much more likely to support the proposal to create a new Fairfield Community Council (98% responded in support of the proposal).

Respondents from the Stotfold area were more divided in their support for the proposal to create a new Fairfield Community Council, with just over half of the respondents from this area indicating support (56%).

### **Comments analysis**

396 people made a comment about the Community Governance Review. These comments have been coded into common themes and are summarised in the tables below. Comments have been analysed by respondents' views on the proposal to create a new Fairfield Community Council (in support of or against).

The most common reason for support of the proposal to create a new Fairfield Community Council were around the need **for more investment in and better use of funding for the Fairfield area** (16%, 113 comments).

Respondents feeling Fairfield **has no affinity or association to the Stotfold area** was also a popular reason for support of the proposal (9%, 62 comments). Some respondents commenting around this also said the Fairfield area has little affinity to Central Bedfordshire, with a greater connection to Hertfordshire.

Popular reasons given from respondents opposed to a new Fairfield Community council were that it would be costly to create a separate council for Fairfield and would increase bureaucracy, and that Fairfield should remain a part of Stotfold to retain

**community history and links** (17% and 16% of those opposed to a new Fairfield Community Council commented around these respectively).

Those responding from the Stotfold area (excluding the Fairfield area) who were not in support of the proposal were most likely to say **Fairfield should remain a part of Stotfold and community history and links must be retained** (18%, 38 people).

A separate Fairfield Community being costly and increasing bureaucracy were also popular reasons given from respondents within the Stotfold area who were opposed to the proposal to create a new community council for Fairfield the (16%, 34 people).

The most popular reason for support of the proposal amongst respondents from the Stotfold area was that there is that the Fairfield area **has no affinity or association to Stotfold** (10%, 26 people).

The most popular reasons for support of the proposal to create a new Fairfield community Council was the need for **more investment in Fairfield and better use of funding for the Fairfield area** (23%, 95people) and having **no affinity or association to the Stotfold area** (8%, 34 comments).





### Appendix 4: Respondents' profile


Just over half of the respondents to this consultation were Male (54%). The level of responses by gender were broadly representative to the population of the existing Stotfold Parish overall (including Fairfield Park), with male respondents just slightly over represented in the responses to this consultation.




The largest proportion of respondents to this consultation were aged between 30-59 year old (52%). Looking at the population age of the existing Stotfold Parish overall (including Fairfield Park), the level of responses by respondents aged between 30-59 year is in line with the age profile of the area (54% aged 30-59 years).

Over 60 year olds accounted for the second largest proportion of responses (39%). This age group is over represented in the responses to this consultation when compared to the age profile of the existing Stotfold Parish overall (20% are aged over 60 years).

Under 20 year olds are significantly under represented in the responses to this consultation with this age group representing just 1% of the survey responses (25% of the existing Stotfold Parish are aged under 20 year olds).



8% of respondents said they considered themselves to be disabled (physical or mental impairment which has a sustained and long-term adverse effect on ability to carry out normal day to day activities). This is slightly under representative of the proportion of existing Stotfold Parish overall (including Fairfield park) with a disability (14%).



The majority of respondents indicated their ethnicity as being White British (93%). This is broadly in line with the ethnicity profile of the existing Stotfold Parish overall (including Fairfield) (96%).

Stotfold ratepayers have always paid rates based on the entire area and have never been able to "pick and chose" which parts to pay and which to leave. Neither should Fairfield residents be able to do so now. Fairfield park is NOT one isolated corner of the Parish, if the changes went ahead it would in fact annex a substantial acreage beyond its boundary towards North Herts. Stotfold Parish received a pitiful Section 1 06 allowance from the developers of Fairfield Park so have not benefitted from its existence, on the contrary it has caused Stotfold to have a By-Pass in the wrong place simply to facilitate its building. Residents of Fairfield Park know (or should have known) the charges applied by the developer for maintenance and upkeep prior to them purchasing, in addition they would have also been informed of the precept for Stotfold parish. It is unacceptable for this to be used as a reason for divorce from the Town of Stotfold, Fairfield residents WILL continue to make use of Stotfold and indeed Central Bedfordshire facilities including the new Leisure centre (if its built). This too is unacceptable.

Yes	Since I moved to Fairfield Park in October 2010 I have been impressed with a strong feeling of community in the area. I do not feel in any way part of Stotfold community and sincerely doubt whether any Stotfold resident feels any affinity to Fairfield Park. The two communities are separated geographically by green fields and a busy road and I seldom if ever visit Stotfold for any reason. Therefore, this charge shouldn't be considered as a valid reason for changing the Stotfold boundaries. 3. The proposed boundary for the Fairfield parish seems very large and will significantly reduce the size of Stotfold. I feel guite niggled that Stotfold town council receive so much income from Fairfield and yet do little to improve the guality of services and provisions for Fairfield residents. We have a beautiful new community centre which we have longed to be opened, we have many teenagers at the park who have outgrown the playparks and require a full time youth worker to coordinate activities / run a youth centre and possibly even build a skate park. We have literally hundreds of little children who would benefit from play groups and activities that could be run at the community centre if it was open and had better funding for equipment. I hope that you will seriously consider this petition and see the benefits for Fairfield residents if a new community council is Yes permitted. I have never considered the Fairfield Estate to be part of Stotfold. Now that they have their own school, shop, etc. I think that many residents will rarely ever come into Stotfold itself. Now that there are 3,000 people Yes living there they should be independent of Stotfold. Fairfield Park and surrounding area has a separate identity to that of Stotfold. Separated by the A507 it now has its own shops, schools, and recreation facilities. Stotfold Council has failed to contribute to the improvement of Fairfield despite 30% of their budget being raised from Fairfield Park. The green areas, play areas and walk/cycle ways need a lot of upkeep because of the number of people who use them which are paid in the form of a service charge by the residents. Despite having received £94,000 Stotfold Town Council has contributed very little to the park. The money paid to them would be better used for the benefit of Fairfield Park residents if administered by a new Fairfield Community Council.
Yes	I think that we pay enough taxes not to have to support Fairfield plus would not wish to pay extra.
Yes	In my view, Fairfield is a community with a different demographic to the village of Stotfold, being chiefly comprised of youngish couples and young families. No	Given the current set of communication on this issue, it seems that the basis for the move is based solely on financial considerations. I am a Fairfield past resident – I think it is a nice place to live and accept that this comes at a cost. The Fairfield Community Action communications have been dire to say the least, looking largely in fact and dealing mainly in opinion. My opinion differs from theirs. No	Letchworth Town Council situation. I accept that these are the rules as laid out. Fairfield is part of Stotfold or Arlesey and has been for as long as I can remember. Arlesey had a railway station named Three Counties and a railway line from what was Three Counties, and as borders were changed if was integrated into Stotfold As for the A507 cutting Fairfield Park off, this argument would be correct for any number of villages or towns in this area with main roads passing through them. If, when Fairfield was developed the planning permission was for a new village called Fairfield Park, I feel many more objections would have been raised against this development. Fairfield park residents agreed to pay rent/service charges when they signed their deeds along with accepting the development was part of Stotfold. No	This will not benefit Fairfield Park residents as the amount they pay to Stotfold Town Council, they will still have to pay to Fairfield Park councillors. If there is a shortfall in funds for their councillors it will be paid by the general tax payer. Yes I know that the councillors don't get a wage but still make this up with expenses. This will add another 5 councillors' expenses in a time when cutbacks are being made. It needs to be itemised exactly what extra items that Fairfield have to pay in their rent agreement. No	The map accompanying this correspondence seems somewhat unclear as to proposed boundaries but would seem to include an area larger than the Fairfield development. I think a division of this type would be detrimental to Stotfold. Surely it would be preferable to integrate with us and work for an improved town as a whole. When buying their houses they were aware of the charge on their properties in accordance with their deeds. I note that they say they are not part of Stotfold because of the A507, but the underpass was built at great expense to make access to the main part of Stotfold easy.
	Let us stand united and be proud. This does not appear to make economic sense to either party. A new Fairfield Community Council would be of no benefit to anyone and would be more likely to cause greater
No	segregation.
No	Many of the Fairfield residents benefit and utilise the facilities within Stotfold. They contribute to the increased traffic on the roads, they utilise the town's amenities and resources. Whilst I can see why they would want to set up a separate parish it seems they do not want to contribute to the amenities they enjoy within Stotfold. What effect will this have on the Stotfold budget and capability to continue to upkeep the town's amenities with a lesser budget? At this time of austerity this is not the time to reduce the budget or separate these two parishes.

In reply to Q3(d) it is well known in the surrounding area that Stotfold has community events all year round/sometimes as much as three at one time, weekends and evenings. Coffee mornings, table top sales, jumble sales, mill weekends, Stotfold Festival Week as well as lots of youth organisations, such as football, Scouts, Guides, also Memorial Hall, pubs and restaurants - clubs, which would be only too pleased and would welcome the Fairfield residents to come along and be part of our community as the Stotfold residents are more than a
No	friendly bunch and always have been.
No	I do not agree to create a new Fairfield Parish Council. In this time of austerity and cost efficiency led Councils, I cannot see this would be a cost effective idea. The bottom lime for all councils and businesses is that we should be finding cost savings and better efficiencies of services. This needs to be actioned everyday to create a smooth efficient business. I have been in Stotfold for 3 years and am quite happy with things.
No	I would like to keep Stotfold and Fairfield as one to work together financially and economically.
No	The more the merrier. Small communities should stick together. One day Fairfield may well need our support (the other side of the A507) for whatever reason.
No	Arlesey Town Council has no opinion one way or the other. There is a diverse range of views across council members. Generally it's an issue the Town Council does not want to get involved with
No	Fairfield should stay in Stotfold. To give governance to the Fairfield group would give them power to take the Fairfield development into Letchworth and with the re-arrangement of the political map will allow a route and easy passage - the address - Fairfield Village, Letchworth GC a much better selling address worth another couple of K's.
No	Stotfold Town council is perfectly capable of the total management of Stotfold another expensive management group is not required.
No	Fairfield has always been a part of Stotfold. It is a great shame that some Fairfield residents feel they have no natural affinity with the local area. Stotfold has many groups which everyone is free to join. Maybe if those residents joined in they would regard themselves as Stotfold residents and this review would not be happening. All facilities are available to all residents ie. Parks, if people choose not to use them that should not mean that they do not have to pay for them - that would be unfair. When moving to Fairfield Park, I believe, residents were informed of the management fee etc. If they were not happy about this, they would presumably not have gone ahead with the move. Maybe their argument is with the developers.
No	Reasons given at Q3(b) & 9d) are closely related - there can be no doubt that for a considerable period of history the Fairfield site has been (and is) within the Parish of Stotfold - until the Hospital was closed down a large proportion of the population were involved directly or indirectly with the site. It is expected that a development on this scale would bring many new residents from "other" areas who initially would have little natural "affinity" for the area - this can only develop over time as all age groups progressively integrate with the itinerant population - a separate parish status would work against, rather than toward that aim. At Q3(c) the submission merely confirms arrangements all property buyers have knowingly and willingly entered into with developers to create "Private" ownership of various amenities. Until development is completed and residents are managing these amenities then neither Stotfold Town Council nor Central Bedfordshire Council can consider alternative systems to the benefit of Fairfield Residents. At Q8 it is proposed that an area around 3 times the size of the well defined Fairfield development should be "gifted" by Stotfold to the new "Parish". If the true aim is for self-governance & Fairness for all then why is all of the proposed additional land needed? This open farmland is needed equally or more so to maintain the outer aspects of the Town - the loss of this to Stotfold would have a creat aesthetic impact.

No	disappointed with this view. Thank you for allowing the people of Stotfold for their opinion. Having taken note of information from both 'sides' of this proposal (i.e. Stotfold Town Council and the proposers of the new Fairfield Community Council), I am not convinced that enough has been done to address the concerns of each side, in advance of making such a SIGNIFICANT change to the first tier of local government in each community. I understand that Fairfield has only recently taken up Councillor roles on the Town Council, to enable the Fairfield voice to be considered as part of the wider Stotfold community. the Fairfield campaign website (http://fairfieldcommunityaction.co.uk) seems to very boldly accuse the Town Council of not spending enough of the Fairfield portion of the town Council precept on Fairfield projects. However, I can find no evidence of any history of dialogue which might suggest that Fairfield concerns have been considered objectively by and with the Town Council. As a Stotfold resident watching events, it almost appears to be an antagonistic dispute rather than a focused, forward thinking, co-operative dialogue. As such, I think it would be foolhardy to make such a drastic change without first exploring options IN FULL. In the longer term I am not averse to the idea of Fairfield separating to its own Community Council, IF it can be evidenced that separation would be beneficial to all. However, Fairfield Park is a relatively new development

and I am not convinced that sufficient time has passed to evaluate whether separation is appropriated and the contral Bedfordshire Council document 'Core Strategy and Development Management Policies (November
2009)' includes the following at Paragraph 3.17.1: "The permitted southern expansion of Stotfold and
remaining areas of development at Fairfield Park are due to be built out and will take time to assimilate into the life of the town". This seems to acknowledge that it will take time and effort for the communities to
integrate with each other. The full effect of separation has also not been adequately and formally quantified
such that all parties are clearly aware of the consequences of such a change. For example, the potential for such a change to jeopardise Stotfold's infrastructure development by loss of S106 payments due from
Fairfield developers, or to cuts in Stotfold Town Council services by loss of revenue from Fairfield residents. I
also have some scepticism as to the sincerity of interest in forming a Community Council by the proposers.
Information provided on an official bulletin from Stotfold Town Council states: "In the Special Town Council meeting to determine the Town Council's views of the Fairfield Park petition, a Councillor who lives on the
Park intimated that 'if the Town Council would give them £50,000 towards the Community Hall, there would be
no need to form a Fairfield Community Council". If this is true (and given that it has been officially released by
the Town Council, I must assume that it is) then this may indicate that the proposers' are working towards an ulterior motive rather than having strong belief in the validity of forming a Community Council. Any new
Council must surely be proposed with the absolute belief in its necessity and validity; to suggest that the idea
would be dropped in exchange for funding towards a different community project is a significant concern.
Resultant increases to local pre4cept for all parties may also make it a false economy on the longer term; current drivers are towards cost reduction in government, not increase. Rather than facilitating the set up of a
Community Council at this state, I believe Central Bedfordshire's efforts would be better spent in facilitating
dialogue between Stotfold town Council and Fairfield residents, to iron out a mutually agreeable way forward
that benefits all residents. For this reason, I do not support the creation of Fairfield Community Council at this stage.

If they feel they want to go it alone, please can they not use Stotfold's facilities, i.e. Doctors, Schools, Library's etc.
We have no problem with Fairfield Park becoming a separate parish. Residents do not appear to have any interest in becoming part of the village community. We find the map a little difficult to read, but if the proposed boundary lines are as we believe them to be, then we whole-heartedly object to the extent of land being subsumed into the Fairfield parish
It is wrong that a person has been born in Stotfold lived here all his/her life for 70 years then had to go out of Stotfold because the Council sold all the old peoples homes and left a block of old people homes empty for
nearly 10 years at the end of their life, have to pay extra £1000 to be buried in Stotfold and this Council are
going to let people from Fairfield be buried after living in Fairfield for such a short time just be buried in Stotfold. As usual Council members do not think things though properly.
 Where will the money to pay the Councillors come from?
 Undecided. Need more information.
The decision needs to consider future planned/likely residential development for the area. For example, if further develo0pment occurs along the A507 bypass, e.g. Between the Hitchin Road and Arlesey roundabouts (on the south side), will these properties be part of Stotfold, Fairfield Park or Arlesey? So, make sure the

# Stotfold Town Council's response to Central Bedfordshire Council's request for comments

# October 2011





#### Introduction

The Town Council were made aware some months ago that a group of Fairfield residents were investigating the financing of the Town Council and then of their intention to set up a separate "parish" council for that area of Stotfold.

We understand that this has come about because of the realisation that, due to the adopted management system of the park, financial equalities could place a larger burden on some residents of the park over others. This also applies to funding of the community building, ideally for use by all residents, where finance would actually come only from the residents of the housing area of the Park. They have submitted their request for a Governance Review and it is now, after receipt of this proposal and its details, appropriate for Stotfold Town Council to express their opinion.

The proposals document was copied to all members to read and consider before a Full Town Council meeting held on Thursday 8<sup>th</sup> September 2011. The outcome of the meeting was that, "the Council does not support the formation of a new Fairfield Community Council". Production of an information leaflet and more detailed response were decided upon, the latter to go before the October meeting of the Council for discussion.

A leaflet was produced to inform Stotfold residents of the Council's opinion. A copy of which is reproduced in the following pages. This leaflet was printed and distributed to all houses in Stotfold.

This response document was authorised at the October meeting of the Stotfold Town Council.

#### "Our Submission"

#### "Fairfield is now an area large enough for self-governance"

The management companies perform most of the functions that a parish council would perform particularly the one for the housing estate. They already have a form of governance recognised by the Boundary Commission in 'The Local Government Boundary Commission for England – Guidance on Community Governance Reviews' document, sections 136 to 146 (appended). There is very little extra that a new Parish Council could do.

#### "Fairfield is not part of Stotfold"

Fairfield is very much part of Stotfold and has been since the Civil Parish was created, the farmland being recorded in the Doomsday book and beyond. There are many historic connections between the town and the hospital with locals working, playing, performing amateur dramatics, taking part in social events or perhaps being a patient there. The hospital, along with its grounds, has long been regarded as an integral part of the community.

Stotfold Town Council has been influential in the design and development of the site. It is regrettable that, to date, relatively few Fairfield residents have taken advantage of the 120 or so established clubs and community organisations around the town which, over time, will assist the social integration of individuals across the whole area,

The fact that a major road crosses a parish does not mean it has to separate into individual parishes. Although the A507 by-pass travels across between the main part of Stotfold and Fairfield development, an underpass for pedestrians and cyclists provides safe access between the two areas unaffected by vehicular traffic flow.

Henlow is also separated by the A507 into the settlements of Henlow and Henlow Camp (which also includes a large housing estate bordering the A600). Sandy is separated by the A1 from the settlements of Beeston Green, Girtford and Seddington. The two parts of Tempsford are separated by the A1. Many Civil Parishes in this part of Central Bedfordshire are comprised of several settlements within the same parish.

"Under the terms that Fairfield was set up by the Government and Mid-Bedfordshire District Council there is financial inequity..."

Neither the Government nor Mid-Bedfordshire District Council had any part in setting up the financial system that residents pay to the management companies for the services that a parish council would have normally provided. The developers themselves decided to do this.

On 15<sup>th</sup> April 1998, Mr A Kendrick of Michael Burrows Associates, for the developers, told Stotfold Town Council members that a Fairfield Trust would be formed in order to run the infrastructure of the development. He stated that the trust would have the responsibility of controlling the budget, and a great deal of income will be needed to sustain the long term maintenance of the site. Mr Phillips, of Phillips Planning Services, spoke at a town council Planning Committee meeting on 17<sup>th</sup> December 2003 saying that the decision had been made by the principal developers to make a private management company responsible for the whole site. In the event they created three management companies.

#### **Campaign Background**

The three management companies cover separate areas of the Fairfield Development.

The smallest is the Middlemarch Residents Association Ltd which has been transferred to residents, three of whom are Directors of the Company. Middlemarch covers the area where the farm buildings were to the northwest of the Hall.

The Fairfield Hall Management Company we are unsure about, and have not yet been able to find any registered resident directors under that name or similar names at Companies House. It could therefore still be under the Developers as Fairfield Hospital Management Company Ltd. This covers the Hall and a defined surrounding area including landscaped areas within the setting of the listed building.

The final management company is Fairfield Park Residents Company Ltd. Its Directors are developer appointments and will not be transferred to the residents until the last house is occupied. It covers the rest of the site except for the part to be transferred to Central Bedfordshire Council for a business park.

The Action Group of 5 residents submitting the proposal for a new Parish are one from Middlemarch and the other four from the Park area.

They are concerned about the "financial inequality" of paying the Stotfold Town Council rate as well as their own fixed and variable rent charge. But it is not as simple as that. The charges currently being levied by each company are different, because of their varying responsibilities.

The Middlemarch Company is responsible for the maintenance of its amenity areas, car parks and access areas.

The Hall Company is responsible for a sinking fund, common areas in the Hall, maintenance of amenity areas, car parks and access areas.

The Park Company is responsible for open spaces, footpaths (not footways), play areas, woodlands and the surrounding hedge and tree boundary, and the Community Building. The outlay and possible losses to run the Community Building were the catalyst for the group to consider alternatives. The Community Building has not yet been handed over by the Developers.

The Action Group have never entered into informal or formal discussions with Stotfold Town Council jointly to explore ways of addressing some of their perceived 'inequalities' and 'unfairnesses', prior to expressing to the Town Council their wish to become a separate Parish.

They reached a two solution conclusion.

"a) For all affected residents to agree to amendment of their property purchase deed to allow all public assets to pass to Stotfold Town Council, provided that body agreed."

Or

"b) To canvass support for Fairfield to become a parish in its own right"

On advice from the Tree Officer of Mid-Bedfordshire District Council (now Central Bedfordshire Council) the Town Council decided not to take over the surrounding tree belt and woodland. The Town Council had not reached any decision about other transferable assets, although we had confirmed to Mr Phillips that we were interested in adoption of the green spaces, play areas and cemetery. Mr Phillips' (previously referred to) speech to the Town Council Planning Committee stopped all further consideration of this matter.

However a) presumes that everything has to be transferred to the Town Council. This is not so. The open areas with the play areas and or the Community Hall could be considered for transfer.

But until the Parks' Resident Directors are in place there is no-one with authority to make such a decision. (Except the developers' Directors, they are most unlikely to even consider it). The Resident Directors of the management companies have in their Memorandum and Articles that they can transfer, sell and otherwise dispose of assets.

Their second option b) to become a new parish has unnecessary set up, administrative and reserve allocation costs of £38,975 i.e. 42% in the projected draft budget of £92,525. There is nothing that a new council could do that Stotfold Town Council could not do, a separate council is unnecessary. It is premature in relation to any possible transfer of assets to Stotfold Town Council.

The Action Group sent out 39 letters of notification of intent and invitations to comment. It is noted that absent from the list of addresses are the secretaries of the three residents associations and the company secretaries of the three management companies. There is no mention in the submission of meetings of these bodies or feedback of their opinions regarding the Governance Review proposals.

#### **Detail and Documentation**

"A Fairfield Community Council could act as a unifying body to the three Management Companies."

Each of the four bodies listed above are independent and sovereign within their own spheres. If the three management companies have matters in common to discuss they could and would do that without reference to any parish council. Neither a Fairfield Community Council nor Stotfold Town Council would have any control over the management companies or residents associations.

It may well be that some people see Fairfield Park as a village. This does not mean that it should become a separate new parish. In 1985 the two separate villages with their own settlement envelopes of Lower Stondon and Upper Stondon came together to form the Civil Parish of Stondon. We have been informed that across the country parishes are being encouraged to join together forming larger units with an economy of scale and a saving of administrative costs.

*"It is apparent that the population of Fairfield is more cosmopolitan than adjoining communities"* 

This statement is equally applicable to the rest of Stotfold where there are a large number of commuters involved in a variety of occupations and professions and a considerable number of people frequently work from home.

It is equally true that many people from the rest of Stotfold do work, shop, or go for entertainment to Letchworth or Hitchin and often further afield.

This is a problem that has been acknowledged by Central Bedfordshire Council in its Core Strategy and Development Management Policies document. The document notes that; "Stotfold has relatively poor levels of local service provision. In terms of population, Stotfold (which includes Fairfield Park) is projected to have the second largest population in the Mid-Bedfordshire area (Central Bedfordshire North). To improve sustainability and

self-sufficiency for Stotfold, increased and improved service provision has therefore been planned in for Stotfold, with the vision being to provide new employment opportunities and an increase in local shops and services, improved green infrastructure, library, community, youth and health facilities, additional allotments, recreational open space and facilities, and cemetery space".

#### **Proposed Boundary**


This section is only necessary to consider if Central Bedfordshire Council is minded to approve the formation of a new Parish called Fairfield Community Council.

Stotfold Town Council has considered the proposed boundary and does not accept it.

In particular after Planning Officers accepted the demolition of a large industrial area to the north of the town we were promised replacement and additional employment land to address the loss and existing shortfall in provision. Part of this new provision is the site of the former Pig Development Unit in Hitchin Road. If this is included in a new parish it will not address the loss and shortfall in Stotfold but will be a further loss. We already had a shortfall before the Fairfield development started.

That leaves three options:

- Option 1. To keep the new parish within the tree and hedge boundary as determined by the Planning Inspector as the envelope for development.
- Option 2. To include the land to the south of the site with the eastern boundary as an extension of the Hertfordshire boundary on the hedge line to the west edge of the road footway. (Including its two property deviations remaining in Hertfordshire)
- Option 3 As Option 2 but to include land to the north of the site to the A507 with the roadside boundary continued to the Hitchin Road roundabout.

It should be noted that neither under the Action Group's proposal nor ours is the land within the Fairfield Development that is in Arlesey parish included in the boundary options.

The Town Council has voted to support Option 1 as the boundary if Central Bedfordshire Council is minded to approve the request for a new parish.

#### Financing

The summary of events on pages 15, 16 and the first paragraph of page 17 of the Action Groups submission are a fair outline of the usual process adopted by Mid-Bedfordshire Planning Department and the outcome for Stotfold Town Council. It should again be noted that the Developers had expressed their intention to have a private solution as far back as our meeting with Mr Kenerick in 1998, before any houses had been built and occupied.

At the first meeting with Mr Kenerick and the last meeting with Mr Phillips, their intention appeared to be for one management trust for the whole site. It was the developers who set up three management companies and therefore introduced the financial and responsibility inequities across the site. The likely reason for this is that the Hall, as with all large blocks of flats or apartments, would essentially be a 'leasehold' property needing its own sinking fund, common area cleaning, caretaking, and maintenance of surrounding lands, car parks and driveways, paid for by a charge on the residents. Since major items of this relate to the Hall only it would be unfair to burden other Fairfield residents with it. The surprise is that they then created two other management companies rather than one. Hence there are three.

In appendix E, 2: Fairfield Park Residents TP1, of the submission, section 13 Variable Rent Charge states the commitment of residents to pay their charges and any parochial taxes. The company (Fairfield Park residents Company Ltd) describes their commitments to the residents and in 13.8 they detail the paying of all rates and taxes. At the end they also state that the paying of parochial rates is the responsibility of the owners of the dwellings. So residents have always known they are to pay both their rent charges and the local precept and have signed into it. The fact that they are given an 18 month free period from their rent charges on first purchase of a property means the realisation of the impact of their situation is delayed.

The crux of the problem is not just between the Action Group and Fairfield residents as rate payers to Stotfold Town Council, all three management companies on the site charge different amounts to their individual residents. The amounts reflect each company's commitments. Also if the houses outside the site are included in a new parish council there will be a fourth level of payment. There are a large number of tenants throughout the site. These people pay their landlords rent, the management companies' charges and a Parish precept. As tenants they are not shareholders of the management companies, so although they have to make all payments they are not owners of the assets they pay for.

The submission includes a list of the Variable rent charges for the Park area of housing. This is the area said to be covered by Fairfield Park Residents Company Ltd, but the submission says the budget was set by Fairfield Redevelopments Ltd (FRL). This explains why the last accounts submitted to Companies House for Fairfield Park Residents Company Ltd (whose directors have been appointed by the developers) shows no current assets, no liabilities, no capital reserves and no shareholders funds. The accounts were approved by the Board on 29/3/11.

It is not known by us why the developers are not using the management company prior to it passing to Resident Directors.

The following table shows an estimate of the impact on residents of their variable rent charge, Stotfold current year rates and the best current estimate of what the Fairfield new Parish rate would be. This later rate is based on the Band D equivalent for Fairfield of 1063 supplied by Central Bedfordshire Officers near the end of October. Since

December 2010 the equivalent of 130 Band D properties have been occupied in Stotfold, mainly from the Fairfield and Land South of Stotfold developments. The following calculations use the current year precept figure for all of Stotfold and the draft budget figure supplied by the Action Group for the new Parish for the next financial year. The calculation includes the extra 130 Band D equivalent properties which has the effect of lowering the Stotfold rates as compared to the actual rate charged last year. This is the best comparison we are able to make at this time.

A further assumption is made, that the Fairfield information supplied to us in which there are no Band A and no Band H properties. That leaves the six bands between A and H. The FRL charge is based on numbers of bedrooms from 1 to 6, the assumption for this illustrative calculation is that these correspond to the six bands.

Ampthill Town Council has playing fields, play areas, civic buildings and Ampthill Park to administer. Its Council tax is £175.04 for a Band D property. At Fairfield the joint total with Stotfold is estimated as £252.22 and with the new Council is estimated as £260.65.

On these figures for the precepts the new Council is a 10.7% increase over the whole of Stotfold precept, and the rest of Stotfold without Fairfield would immediately suffer a 37.2% increase in their parish tax. Based on the actual Stotfold Band D for this financial year, which does not include the 130 Band D equivalent properties occupied during the year, the increases are 7.1% and 32.6% increase for the rest of Stotfold without Fairfield. The financial implications for the rest of Stotfold are now quite clearly devastating and give the Town Council an immense problem as we will not know Central Bedfordshire Council's decision until after the date for us to send in our next year's precept request.

"The only possible benefit to Fairfield Residents will be cheaper resident rates at Stotfold Cemetery."

All residents of Stotfold are able to use the facilities we provide and own. They are able to tap into the knowledge of our staff for town matters, as a link to Central Bedfordshire Council, the Police and CAB. There is an expansive list on the third page of our leaflet to residents reproduced within this document.

The Town Council's Planning Committee has worked tirelessly for the benefit of our residents who now live in Fairfield.

#### "Fairfield people will never be in a position to benefit (from paying Stotfold's rate)"

When the Resident Directors of Fairfield Park Residents Company are appointed and the assets are transferred, then and only then will the Town Council and Fairfield Park have people with authority who are able to discuss and decide whether any assets can be transferred to the Town Council so that the costs can be spread over all of Stotfold.

#### "Stotfold Town Council made no effort with their budget to provide funds..... silence could be termed neglect".

The developer even now still owns the Community Building and has not transferred it. It was and is for them to provide the building. At no point was the Town Council involved in the design of this building or the Section 106 Agreement between the developers and Mid-Bedfordshire District Council about its design and fitting out. It turns out to have been a flawed agreement with design faults. If there has been neglect it lies elsewhere and not with the Town Council. The Town Council would not pay developers for work and items they should be providing anyway. There is also the assumption that the Resident Directors of Fairfield Park Residents Company will agree to a Charitable Trust to run the Community Hall. That cannot be certain until the transfer to that company has been made and they are in a position to consider the matter and make a decision.

The Action Group refers to the protection of the Orchards, as part of the setting of the listed building. A legal agreement already exists protecting it in perpetuity. Certain developers have tried to ignore this but Stotfold Town Council's Planning Committee knew of it and reminded Planning Officers of it in our very robust objections to developments in that area. A service we provide for the benefit of Stotfold residents.

#### Conclusion

- The application is premature until development is complete and 'ownerships' are clear, allowing the three management companies' Resident Directors to consider any possible transfer of assets to Stotfold Town Council. Thus spreading the costs over the whole of Stotfold as would normally happen with any new estate.
- There can be no doubts that Fairfield has been and is geographically within the Parish of Stotfold.
- There have been no formal discussions with Stotfold Town Council to explore alternatives.
- The 'self-governance' desire does not require or justify expansion beyond the already defined site boundary to come about or to be effective.
- The perceived 'inequities' identified across the site will not be solved by this proposal.
- Areas within a Parish can have individual community identities without having to be separated.
- The nature of work, leisure, shopping habits across all of Stotfold are very similar.
- The future ownership/management of the Community Building will not be decided until after full adoption from the developers.
- There has been every opportunity for residents from the Fairfield area to have direct input on Stotfold Town Council and its policies by putting up and standing for election as Stotfold Town Councillors. This did not happen until May of this year.
- A town with projected population of 13,000 would command better overall provision of and investment in infrastructure by Central Bedfordshire Council than two smaller settlements.
- Central Bedfordshire Council's Local Development Framework Core Strategy states that 'Fairfield Park...will take time to assimilate into the life of the town'. Therefore Central Bedfordshire Council recognises that integration of new residents takes time. Therefore not enough time has elapsed.

• If Central Bedfordshire Council decides in favour of a new council for Fairfield with elections in 2012, then the financial implications for the rest of Stotfold are clear, an increase in the town rates of 33% is inevitable. We would need time to adjust. The advice from the Boundary Commission, that if elections have just taken place then no further elections should take place for three years is sound advice, otherwise we will need some form of transitional arrangements.



Guidance on community governance reviews

Published31 March 2010

Extract from Section 4:

#### Other (non-parish) forms of community governance

- 136. In conducting a community governance review, principal councils must consider other forms of community governance as alternatives or stages towards establishing parish councils. Section 93(5) of the 2007 Act states that "In deciding what recommendations to make [in the community governance review] the principal council must take into account any other arrangements... that have already been made or that could be made for the purposes of community representation or community engagement in respect of the area under review". The following paragraphs consider other types of viable community representation which may be more appropriate to some areas than parish councils, or may provide stages building towards the creation of a parish council. There is sometimes evidence locally of an existing community governance infrastructure and of good practice which are successfully creating opportunities for engagement, empowerment and co-ordination in local communities.
- 137. However, what sets parish councils apart from other kinds of governance is the fact they are a democratically elected tier of local government, independent of other council tiers and budgets, and possess specific powers. This is an important distinction to make. Parish councils are the foundation stones for other levels of local government in England. Their directly elected parish councillors represent local communities in a way that other bodies, however worthy, cannot since such organisations do not have representatives directly elected to those bodies.
- 138. The 2006 white paper recommended that local communities should be able to take more responsibilities for local issues affecting their area. Key to this approach is community empowerment, and the ability of various existing organisations themselves to see through specific projects to tackle local issues. Structures such as local residents' associations, community or neighbourhood forums and area committees have an important role to play in local community governance.
- 139. At the neighbourhood level, there are various initiatives in existence, which through being representative and accountable can effectively empower local people. They have varying degrees of power and influence, and commensurate levels of transparency and accountability.

#### Area committees

140. Area committees are part of the structure of some principal councils (e.g. district, unitary and London borough), where they choose to have them. Area committees are a key initiative for enabling local government to fulfil community governance roles and also to deliver government policy on issues affecting social inclusion in local communities. Principal councils also provide resources for area committees, and their councillors are commonly integral to their constitution. Area committees can cover large areas and exist to advise or make decisions on specific responsibilities that can include parks, off-street parking, public toilets, street cleaning, abandoned vehicles and planning applications amongst others. Also, more widely, they contribute to shaping council services and improving local service provision.

#### Neighbourhood management

- 141. Neighbourhood management programmes are similarly set up by principal councils and may be led by one of a number of bodies. The expansion of neighbourhood management was promoted in the 2006 White Paper as a tool to enable local authorities to deliver more responsive services through their empowerment of citizens and communities. Their purpose is to create the opportunity for residents to work with local agencies, usually facilitated by a neighbourhood manager, to improve services at the neighbourhood level.
- 142. Neighbourhood management arrangements aim to improve 'quality of life' through implementation of (rather than advising or making decisions on) better management of local environment, increasing community safety, improving housing stock, working with young people, and encouraging employment opportunities, supported strategically by relevant stakeholders and Local Strategic Partnerships. They tend to cover smaller populations than area committees. The 2006 white paper recommends that take up of neighbourhood management should be encouraged and that Government should work with local authorities pioneering the approach, to raise the profile of achievements and promote adoption elsewhere.

#### Tenant management organisations

143. The 2006 white paper makes a series of proposals that facilitate the empowerment of residents through tenant management organisations (TMOs). Tenant management organisations are established by the local housing authority; they usually function on urban housing estates and can take responsibility for housing services (such as collecting rents and service charges and organising repairs and maintenance) from the local housing authority under the Housing (Right to Manage) (England) Regulations 2008. The 2006 white paper promoted the role of TMOs and recommended simplifying and extending their scope; enabling them to take on additional services and undertake further representation of residents within neighbourhoods. A TMO is an independent legal body and usually elects a tenant-led management committee to the organisation; they can also enter into a legal management agreement with landlords.

#### Area/community forums

144. Area or community forums (including civic forums) can be set up by the principal council, or created by local residents to act as a mechanism to give communities a say on principal council matters or local issues. Sometimes forums are set up to comment on a specific project or initiative that will impact upon the local area, and so may be time-limited. They increase participation and consultation, aiming to influence decision making, rather than having powers to implement services. They vary in size, purpose and impact, but membership usually consists of people working or living in a specific area. Some forums also include ward councillors, and representatives from the council and relevant stakeholders can attend meetings.

#### Residents' and tenants' associations

145. Residents' and tenants' associations enable local people to participate in local issues affecting their neighbourhood or housing estate, including the upkeep of the local environment, crime, sometimes dealing with anti-social behaviour matters, or on some estates, housing management. They can be set up by any group of people living in the same area and can choose who members will be; how they will be represented and what they want to achieve. In the case of tenants' and residents' associations on estates, they may be established with direct support from the principal council, as a mechanism for communicating with the tenants and residents on its estates. To engage effectively with other organisations, residents' and tenants' associations must be able to show that they are accountable and represent the views of the whole community, rather than narrow self interests of just a few local people.

#### Community associations

146. Community associations offer a particular and widespread democratic model for local residents and local community-based organisations in a defined neighbourhood to work together for the benefit of that neighbourhood. They can use a model constitution registered with the Charity Commission. The principal council may also be represented on the association's committee. They usually manage a community centre as a base for their activities. Membership is open to everyone resident in the area.

# FAIRFIELD COMMUNITY GOVERNANCE REVIEW

#### Dear Stotfold residents

In August we received from Central Bedfordshire Council, the timetable of consultation about the submission prepared by five people from Fairfield Park, Stotfold, concerning their desire to form a new separate Parish Council in that area.

They are all either connected with the Fairfield Park Residents Association or the Community Hall Steering Group. Two of them, at the May elections became Stotfold Town Councillors, and with the other Councillors can be contacted by any resident from any part of Stotfold.

Many people in Stotfold have connections with the Fairfield site from; working there, playing bowls, cricket, football, being in amateur dramatics, having relatives who did these things or perhaps having been a patient there. Some patients were allowed to walk about Stotfold and were no problem. Stotfold people regarded the Hospital as an integral part of Stotfold. New residents to the town have been discovering the 120+ clubs, groups and associations in the town. These are listed on the Council's website <u>www.stotfoldtowncouncil.gov.uk</u> in the community pages.

Central Bedfordshire Council, in the document Local Development Framework (LDF) Core Strategy 3.17.1 states "Stotfold is one of the district's Minor Service Centres and is located close to the A1 and A507. The permitted southern expansion of Stotfold and the remaining areas of development at Fairfield Park are due to be built out and will take time to assimilate into the life of the town ... 3.17.2 In terms

One thousand plus registered electors, mostly from Fairfield, signed acknowledging to Central Bedfordshire Council that the Fairfield Park Governance Review should take place. This does not necessarily imply that they all agree with the applicants aims.

of population, Stotfold (including Fairfield Park) will be the second-largest settlement in Mid Bedfordshire by 2011". Therefore Central Bedfordshire Council recognises that integration of new residents takes time. Not enough time has yet elapsed.

The Town Council, as the Parish in which Fairfield falls, has been involved in the development of Fairfield Park since 1992. It responded as a consultee to two public inquiries and has dealt with nearly 1400 planning documents for the site.

The developers decided not to hand over the public areas and community building to the Town Council, but to administer them through three Management Companies and charge the Fairfield homeowners directly for these facilities. Had they been passed to the Town Council we would have appointed contractors and the costs would have been spread across Stotfold including the town rate that Fairfield residents also pay. The Town Council will shortly be taking over the play areas at Queen Street and also the public areas on the land south of Stotfold. The Fairfield developers decided on Management Companies because they needed one for the Hall, as happens with most blocks of flats, and treated the rest of the site in the same way with the other two management companies.

The Town Council does not agree that the Fairfield site and adjoining areas should be removed from the town. The rest of this document gives further details about the Town Council's position.

In their submission the 5 proposers have said that the Band D equivalent for the Fairfield area of Stotfold is 1140. A figure they obtained from Central Bedfordshire Council. For the purposes of calculating Council Tax no matter what band from A to H your property actually is, it is converted into a notional equivalent number of Band D properties. The number 1140 was a raw figure and did not take into account, single occupancy discount, second home discount etc. Central Bedfordshire Council have sent a closer estimate, 719, shown in Table 1. They are working on a more accurate estimate, but we have not yet received it.

The Proposers have sent to Central Bedfordshire Council a draft budget for the first year; in fact if Central Bedfordshire Council agrees to set up Table 1 - Tax Base - equivalent number a Fairfield Council they will decide the first budget figure. The draft of Band D properties budget is for £92,525 divided by their 1140 gives a Band D precept figure of £81.62. The Town Council's precept for the whole of Stotfold is £81.30.

Table 1 shows the Band D equivalent for Fairfield only as 719 this divided into £92,525 give a Band D precept figure of £128.68. This would be the 4<sup>th</sup> highest parish rate in the whole of Central

Bedfordshire. It is beaten by Ampthill at £175.04, Dunstable at £139.65 and Houghton Regis at £128.69. For residents of Fairfield this would be paid on top of the Variable Rent Charge for the services that a Town or Parish normally provides.

The impact this would have on Rounded 3792.00 719.00 3073.00 ratepayers is shown in Table 2 if

this had happened this tax year. The Fairfield area would be paying more because of the higher draft budget demand, and the remainder of Stotfold would pay more because of the loss of what Fairfield currently contributes. If the boundary remains as in the proposal, Stotfold Residents who live on Hitchin Road (Fairfield side of the roundabout) and those off Stotfold Road beyond Fairfield would pay more than they are currently paying.

The remaining part of Stotfold could see their Council Tax increase depending on which Band your property falls within (see Table 2) by £12.68 for Band A (£66.88 - £54.20) to £38.04 for Band H properties.



#### "No youth facilities at Fairfield"



Scouts, Guides, Army Cadets, St John Youth Section, Church youth groups, Stotfold Junior Football Club (boys and girls) exist in Stotfold and are available for more youngsters from Fairfield to join. In terms of the difficult to reach youths the old County Council withdrew from youth provision in Stotfold many years ago and the only youth work in this category has been done by the Aragon Housing Association Youth Worker.

Central Bedfordshire Council has recently considered youth provision, there was none allocated for Stotfold but some based at Arlesey Youth Centre. So this is not just a problem at Fairfield, but throughout all of Stotfold.

#### Green spaces and play areas

If Stotfold Town Council had been given the open green areas including play areas, then the maintenance of those areas would have been added to our existing contracts. Maintenance schedules already exist for Fairfield and could continue but in our experience the number of grass cuts is increasing with the milder general weather. Our play equipment is inspected weekly in-house and inspected annually by ROSPA. The Directors of the Management Companies have it within their powers to transfer these areas to the Town Council, so when Fairfield Park Residents Company Ltd has Directors who live on the



site they will have the authority to act, until then none of the residents have that authority. The only registered Directors we are aware of are those from the Middlemarch Residents Association Ltd.

#### What Fairfield residents can and have benefited from within Stotfold



Allotments, Cemetery, hiring of the Simpson Centre and Memorial Hall, four other equipped play areas, open spaces: Hitchin Road Recreation Ground, The Green, Riverside Playing Field, Millennium Green, Centenary Wood, and the MUGA and skate park facilities. The Town Council owns the Brook Street bowling green, library building, Stotfold Football Club ground. Services provided in the office, experienced and qualified staff, contact point for the public with Central Bedfordshire Council, police, Citizens Advice Bureau, and general enquiries and concerns.

As Central Bedfordshire Council statutory planning consultees, the Town Council's Planning Committee has considered every planning application relating to Fairfield Park. For each application Central Bedfordshire Council notifies adjacent

neighbours that the Town Council will be making comment and that copies of plans are available for inspection at the Town Council offices. The Town Council welcomes public participation in the planning process by either sending

your comments in writing to the Council or coming to the meeting and speaking directly to Councillors. All comments are taken into consideration by the Planning Committee in making its observations to Central Beds Planning. In particular, with regard to the recent applications for the West Orchard site, the Committee made robust comments in opposition to the applicant's plans. We brought to the attention of current Planning Officers the proof of evidence from a former Planning Officer to

the Planning Inspector that there is a clear long-term intention from the Planning Authority to protect the setting of the Listed Building at Fairfield in perpetuity. This is contained in a legal agreement between the developers (and their successors) and the former Mid Beds District Council (and their successors).



Boundary to the proposed Fairfield Council area

A Councillor was concerned that the boundary shown in the submission covered too great an area of Stotfold. The Planning Inspector had determined that Fairfield Park should be contained within its tree and hedge line boundary. It was advocated that this should remain as the boundary to the Fairfield Community Council, if Central Bedfordshire Council decides to create it.

increase in local shops and services, improved green infrastructure, library, community, youth and health facilities, additional allotments, recreational open space and facilities and cemetery space.

Any reduction in the population of Stotfold may consequently have a detrimental impact on the facilities and services for the town, resulting

in a reduced provision of much needed infrastructure.

After debate at a Special Town Council meeting on Thursday 8<sup>th</sup> September 2011, Members voted and it was resolved that this Council does not support the formation of a new Fairfield Community Council.

#### Re: Community Governance Review - Stotfold Parish - Area of Fairfield

We submitted our main arguments when we presented our petition in July calling for a Governance review. Throughout the consultation period we have listened closely to the views expressed on social network sites and by Stotfold Council. We have heard nothing that changes our view; indeed our opinion that Fairfield should be separated from Stotfold has been strengthened.

We would underline the following points.

#### 'The submission was the work of five people'

Our submission was made following wide consultation with the Residents Associations on Fairfield as well as members of the Potential Directors Committee who will form part of the Residents Company once assets are handed over. We also have had a meeting with a representative of Fairfield Redevelopment Company that is currently responsible for the assets on Fairfield Park.

STC have persistently tried to portray the submission as being the act of five people and consistently ignore the fact that more than 1,200 residents supported it.

#### 'The Action Group have never entered into informal or formal discussions with STC'

Two of our members had an informal meeting with the (now) Mayor in September 2010 and then, as a group, we met with the Mayor and Deputy Mayor and the clerk at a formal meeting in January. Subsequently there has been no request from Stotfold Council to discuss with the group the outcome of a split, although that possibility was left open at our meeting in January.

#### STC, led by the Mayor, have knowingly deceived Residents of the town

We were surprised and disappointed that STC, in their response sent to residents, used figures that they had accepted at their meeting were inaccurate and misleading. Subsequently Central Bedfordshire Council have supplied revised figures that support those expressed by the Action Group. However, STC has not seen fit to inform the residents they serve, of the important errors.

#### Financial impact

STC only consider the impact a split will have on the remaining part of Stotfold and not the huge impact on the Fairfield community. The figures show that Fairfield residents have been subsiding Stotfold residents for the past five years, currently by £83,000 per annum. All this when there is an urgent requirement for facilities to be provided for children, teenagers and seniors.

During the recent round of budget meetings STC has at no time considered or allowed for the needs or requirements of Fairfield. In other words STC has no plans to spend money on Fairfield in the financial year 2012-2013.

This underlines our view and request that it is vital a Fairfield Community Council be set up from April next year. This date is allowed under the current legislation. We don't accept that Stotfold will be unduly disadvantaged as there are a very large number of new houses built, being built and about to be built, which will instantly replace the precept from Fairfield. We can see no reason why Fairfield residents should continue to pay this subsidy when they have urgent issues of their own to address.

#### **Boundaries**

In suggesting a new boundary the Action Group followed closely the recommendations in the document *Guidance on Community Governance reviews*.

STC has suggested three options on a proposed boundary should Central Bedfordshire agree with the request for a change in the boundary. We oppose all three on the following grounds:

**Option 1** is undemocratic since it attempts to place Fairfield in a sort of municipal isolation ward or ghetto. **Option 2** is undemocratic since it would give STC more consultative influence over future potential development of the immediately adjoining territory to the north and east of extant Fairfield development than would be enjoyed by Fairfield Community Council,

**Option 3** is undemocratic since it will

a) isolate the few dwellings on the East side of Hitchin Road that are, even in the eyes of the most prejudiced observer, more a part of the Fairfield community than they will ever be part of Stotfold community and who supported our petition

b) give STC more consultative influence over known probable development of the immediately adjoining territory to the east of extant Fairfield development than would be enjoyed by Fairfield Community Council.

We also do not see that the creation of a Fairfield Community Council changes anything in terms of employment opportunity for Stotfold residents as we have not proposed changes to the Core Strategic Plan.

STC has dwelt heavily on history and produced crocodile tears, as they have made no suggestions as to how they will remedy the current situation or that they recognise an inequity.

Generally, we feel that the STC response shows that they are not only out of touch with the electors they serve but very much out of touch with the views and demands of the people on Fairfield.

STC clearly believe that finance is the basis of our request for a Governance Review and have totally missed the point that residents of Fairfield are now ready and anxious to take control of their own community. They consistently refuse to acknowledge the true views of Stotfold residents on Fairfield.

Those views were well summed up at the October full meeting of the STC by resident Douglas Rule, who used his statutory rights to tell councilors that he had never before lived in the UK for longer than two years and had never thought about local government before. He stated that his community is Fairfield and he is interested in solving the problems he sees there and is thus supporting the new council. He sees Fairfield as new and different from Stotfold with its long history.
