Council Priorities:

This proposal supports the Central Bedfordshire Council priority of providing value for money by ensuring that the Council makes best use of the funding available for capital expenditure.

Background

- 12. At present, the Council's Constitution permits the Executive to add new schemes to the Capital Programme where these are estimated to cost less than £500,000 (whole life cost). New capital schemes that cost more than £500,000 (whole life cost) must be approved by the Council.
- 13. This report proposes extending the Executive's power to allow schemes to be added from a list of reserve schemes that has been approved by the Council or where the costs of the scheme will be met from external funding, provided that the associated revenue costs can be accommodated within the approved revenue budget for financing the Capital Programme.

The Proposal

- 14. The proposal concerns paragraph 4.10.10 of the Council's Code of Governance (see Appendix A). At present, this permits the Executive to add new schemes to the Capital Programme, provided that the whole life cost of the scheme is estimated to cost less than £500K. Schemes costing more than £500K require the approval of the Council.
- 15. The amendment would permit the Executive to add new schemes from a reserve list approved by the Council or where the costs of the scheme are to be met in full from external sources and provided that the effect of adding these schemes does not result in expenditure in excess of the approved budget for financing the Capital Programme.

Conclusion and Next Steps

16. The Committee is asked to consider this matter and determine the appropriate way forward.

Proposed Amendment to Part I2 of the Constitution

4.10 Capital Programme

4.10.10 In year, the Executive may approve new Capital Schemes that have not previously been included in the Capital Programme, but which are included in the Capital Programme Reserve list approved by Council or which are to be funded in full from external sources, subject to the production of Outline and Detailed Business Cases and provided that the revenue cost of such schemes can be accommodated within the approved revenue budget for the Capital Programme in the relevant financial year, as confirmed by the Chief Finance Officer and the Executive Member for Corporate Resources.
