- 3. The decision taken was that no funding be provided by the Council to Nirah Holdings Ltd in response to its request for financial support in respect of legal action being pursued by the company.
- 4. The alternative considered and rejected was the provision of the requested funding to Nirah to support legal action being pursued by the company.
- 5. This decision was urgent and therefore not subject to call-in. The Chairman of the Sustainable Communities Overview & Scrutiny Committee has given his consent to the decision being treated as a matter of urgency both for the purposes of Rule 16 of the Access to Information Procedure Rules and Rule 10.13 of the Overview and Scrutiny Procedure Rules.
