Appendix A

Consultation on the proposed closure of Brewers Hill Middle School, Aldbanks, Dunstable.

Monday 24 February 2014 - Monday 7 April 2014

1. Introduction

Councils have a duty to ensure there are enough suitable school places for children aged 5-16 (as per Section 14 of the Education Act 1996). The Council's role is to promote parental choice, diversity, high standards and fair access to education (Education and Inspections Act 2006).

To help meet these duties a Council has the power to close schools where no other viable options are available.

Possible reasons for closing a school include where:

- it is surplus to requirements (e.g. as a result of an area-wide reorganisation and/or there are sufficient places in neighbouring schools to accommodate displaced pupils)
- it is to be amalgamated/ merged with another school
- it is failing and there is no viable sponsored academy solution
- it is to acquire, lose or change religious character or
- it is being replaced by a new school.

Central Bedfordshire Council is proposing to close Brewers Hill Middle School because the current and projected pupil numbers make the school unviable.

This document explains the reasons for proposing to close the school and how you can have your say.

The Council is also currently consulting on proposals to close two other middle schools in the Dunstable area for the same reasons. You can also have your say, by responding to the separate consultations, on the proposals to close:

- Ashton Church of England Voluntary Aided (CofE VA) Middle School (High Street North, Dunstable) and
- Streetfield Middle School (Dunstable Road, Caddington).

2. Background

There have been lots of changes taking place in Dunstable and Houghton Regis schools over the last few years; many have taken advantage of greater powers given to them by Government to change their school, in response to parental demand. The governing bodies of maintained schools in the area, which have approached the Council for permission to consult on a change of age range, were able to provide proof of parental support at that early stage in response to their initial surveys. This support was further demonstrated during the consultation process for each proposal and was one of the factors that were considered by the Council when approving a requested change of age range.

Likewise, for academies that were required to ask the Secretary of State for Education for permission to change their age range, the level of parental support was again one of the factors that were considered when approving the proposal.

In both Dunstable and Houghton Regis there has been a shift from the three tier system dage 5 lower, middle and upper schools towards a two tier primary and secondary school model as a result of these changes.

This shift has led to many of the previous feeder schools converting to primary schools. This has led to fewer pupils applying to middle schools for the intake at Year 5. Also the four former upper schools have extended their age ranges, meaning that some pupils are leaving middle schools to start secondary school in year 7. The combination of these factors means that pupil numbers at Brewers Hill Middle School have fallen significantly as a result of these changes. We have now reached a point where falling pupil numbers means the Council needs to consider the future viability of the school.

The funding that schools receive comes to the Council from Central Government and is passed directly to the Council's maintained schools in accordance with our local funding formula (academies receive their funding direct from Central Government). A maintained school's funding allocation is predominantly based upon the total number of pupils they have on roll and the total number of pupils that are due to move in and out of the school during that academic year. Because of falling pupil numbers, the budget for Brewers Hill Middle School is due to fall by 13.6% for 2014/15 alone and this decrease, and projected decreases going forward places the school in a financially unviable position. With such a significantly reduced budget, the school will find it difficult to employ sufficient teachers to enable the delivery of a full curriculum.

The table below sets out the current pupil numbers at Brewers Hill Middle School, the projected numbers in September 2014 based on actual applications, and projected numbers for September 2015 based on assumptions regarding applications. Brewers Hill Middle School has a Published Admission Number of 120 which is the total number of children that the school is able to admit for each year group.

The projected figures are based upon applicants' 'first preferences'. There are sufficient places within Brewers Hill Middle School to admit all of the children who have applied for a place, in year 5, at the school as a 'first preference'. Due to the places that are currently available within other Dunstable middle schools, children who have applied for a place within an alternative Dunstable middle school as their 'first preference' and have named Brewers Hill Middle School as their 'second preference' will be allocated a place within their

'first preference' school. Second and third preferences for Brewers Hill Middle School will Page 6 not therefore need to be considered.

As described above, low pupil numbers make the school no longer educationally or financially viable and keeping this school open would not be in the best educational interests of their pupils.

3. Our proposal

The Council is proposing to close Brewers Hill Middle School. The Council has considered other options (see question the Frequently Asked Questions on page seven) but the fall in pupil numbers, both current and projected, means that the school is not able to deliver the full curriculum and the school is unviable.

Should the proposal go forward and the closure of the school be approved, the timeframe and process would be as follows. Please note that this timescale would need to be reviewed nearer the time depending on actual numbers at the school.

September 2014	
Year 5	Children for the new Year 5 group are admitted.
Year 6	Parents of Year 6 children are invited to apply for transfer to a secondary school in Year 7 (to transfer in September 2015).
Year 7	Year 7 operates, but on a reduced size of year group.
Year 8	Parents of Year 8 children are invited to apply for transfer to a secondary school in Year 9 (to transfer in September 2015). This will be the last Upper transfer in Dunstable.

April 2015	
Year 7	Parents of Year 7 children are invited to consider making an application to transfer to a secondary school in Year 8 (to transfer in September 2015).
	This is known as an in-year application as it happens outside of the normal transfer point.

September 2015	
Year 5	No new pupils are admitted.
Year 6	Parents of Year 6 children are invited to apply for transfer to a secondary school in Year 7 (to transfer in September 2016).
Year 7	Year 7 operates, but on a reduced size of year group.
Year 8	Year 8 operates, but on a reduced size of year group.

April 2016	
Year 6	Any Year 6 children whose parents haven't made an application to transfer to a secondary school will be sent an application to state a preference for a school. If no application is received by the end of May a place at the nearest Secondary school with places will be allocated.
Year 7	Parents of Year 7 children are invited to consider making an application to transfer to a secondary school in Year 8 (to transfer in September 2015). This is known as an in-year application as it happens outside of the normal transfer point. If no application is received by the end of May a place at the nearest Secondary school with places in Year 8 for September will be allocated.
Year 8	Parents of any Year 8 children remaining in the school are invited to apply for a place in Year 9 at a secondary school (to transfer in September 2016). If no application is received by the end of May a place at the nearest Secondary school with places in Year 9 for September will be allocated.

We recognise that this proposal to close the school may be unsettling for pupils, staff, parents and carers and we are keen to hear from all those people who want to have their say on the proposals during the consultation. You will find a full list of Frequently Asked Questions (FAQs) starting on page seven of this document which may help to address some immediate concerns that you have. You are also welcome to raise queries via the School Admissions helpline on T. 0300 300 8037 or at the public meeting that is being held at the school on Tuesday 4 March (see page six for details).

4. The consultation process

The Council is required to consult with a range of people and organisations including:

- Parents and carers of the children in the school
- The school's governing body
- The school's teachers and other staff
- The governing bodies, teachers and staff of other schools that may be affected
- Parents and carers of children at other schools that may be affected e.g. at feeder schools
- The local diocese and other faith groups
- Neighbouring local authorities
- Members of Parliament

You can have your say online at www.centralbedfordshire.gov.uk/consultations or you can complete pages 13 and 14 of this document and return them to the FREEPOST address provided at the end of the form. As well as providing feedback on the Council's proposed closure of Brewers Hill Middle School, you can also submit an alternative

proposal for the school. All responses should be returned by 5.00pm on Monday 7 April Page 8 2014.

We will also hold a public meeting at Brewers Hill Middle School on **Tuesday 4 March 2014** at 7.00 pm which is open to all interested parties. We are also meeting with the staff, union representatives and governors of Brewers Hill Middle School.

The timetable for the consultation and decision making process is set out below. At the end of this consultation, if the Council decides to pursue closure of the school, it would then have to go through another stage of consultation (a Statutory Notice period) before any final decision could be made in August.

5. Frequently asked questions (FAQ's)

Q – Does this consultation mean that the Council has already decided that Brewers Hill Middle School will close?

A – No. The Council's Executive committee has approved the start of a consultation on the proposal to close the school, based upon the school's financial and educational viability. The final decision will not be made until 19 August 2014.

Q – Has the Council considered any alternative solutions other than the proposed closure of Brewers Hill Middle School?

A – Yes. We have considered converting the school to either a primary or a secondary school but we do not need any additional primary or secondary places. The school also worked with the Barnfield Federation to investigate a conversion to academy status as part of that organisation but unfortunately this was unsuccessful.

Q – To give parents a real choice, could the Council keep just one of the 3 middle schools open?

A – Unfortunately, due to the total number of pupils currently in Brewers Hill, Ashton CofE VA and Streetfield Middle Schools, and the number of projected pupils moving forward, this is not a viable option.

Q – Why is the Council proposing to close Brewers Hill Middle School, which is a 'Good' school (Ofsted February 2013) when 2 of the 3 upper/secondary schools in Dunstable 'require improvement'?

A –Although we recognise that the school has improved significantly over recent years, the proposed closure is based upon the school's education and financial viability and is not based upon standards. However standards will inevitably fall if, due to the significantly reduced budget, the school cannot employ sufficient teaching staff to enable the delivery of a full appropriate curriculum for all year groups.

Q – What is the Council's response to the accusation that by proposing to close 3 middle schools in Dunstable you are reducing parental choice?

A – Parental choice and support was demonstrated to us within the proposals that were brought forward to the Council by the schools that wished to expand their age range. This has been further demonstrated by the number of parents who have not applied for a middle school place for September 2014 but are choosing to keep their child within a primary school. There are still middle school options available in the area:

- Barnfield Vale has expanded and is a Primary and Middle school for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Caddington Village School is for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Priory Academy is expanding from 9-13 years to 9-16 years from September 2014 and admits children in the Middle transfer round to Year 5 as their normal point of entry.

Q – How can the Council be sure that the projected figures are correct?

A – The projected number of pupils for September 2014 for Brewers Hill Middle School is based upon the total number of applications received by the School Admissions Team, by the national closing date of 15 January 2014, that requested a year 5 place in the school.

Q- Would there be sufficient places in Dunstable upper/secondary schools to take any potential displaced children?

A – Yes. The Council is legally obliged to provide sufficient places for all children aged 5-16 years.

Q – Following the conversion of many Dunstable lower schools to primary status, is there now a surplus of primary school places within the town?

A – Yes. There is currently a 17% surplus of places in year R (reception) to year 5 and a surplus of between 63% and 65% surplus of places in years 5 to 8 within the local area.

Q – Historically, some Dunstable parents have chosen to send their children to schools outside of the local area. Is this still the case?

A – The admissions process allows for parental preference and parents can select any school they wish their child to attend whether that is their local school or one some distance away. In previous years some parents in the Dunstable and Houghton Regis area have opted for Middle and Upper schools in the Leighton Buzzard or Harlington areas or have chosen to send their children to schools in Luton.

Q – Will the new homes planned for Frenches Avenue in Dunstable potentially increase demand for places at Brewers Hill Middle School?

A – Although every new housing development creates pressure on schools, the number of new homes planned for Frenches Avenue will only equate to a very small number of children, estimated at just 8 per year group.

Q – Are the school staff also being consulted as part of the consultation process?

A – School staff and trade union representatives are being consulted throughout this consultation process. Should a decision be made to issue statutory notices to close the school, staff and trade unions would be further consulted. The Council and the school's Human Resources provider will work with the governing body, the staff group and trade unions to ensure all staff have access to appropriate advice and support and will ensure that the relevant policies and procedures of the Council are followed.

Q - Should a decision to close the school be made, how would the Council retain the staff that would be needed until the school closed completely?

A - Should a decision be made to close the school, the governing body of the school would consider a staffing structure that would reflect the pupil numbers and the educational and pastoral needs of pupils at the school until it's closure. The Council would work with the governing body and their Human Resources provider when considering the staffing structure.

Q- Is the Council able to place staff from the schools under consultation in other local schools that may have vacancies?

A – In accordance with education legislation, each school's governing body is responsible for appointing its own staff therefore vacant posts in other schools are unable to be ring fenced to staff in those schools under consultation. The Council has a redeployment procedure for school based staff and would support the redeployment of suitably qualified and experienced staff where possible.

Q- Why did the Council not forewarn parents of this proposal?

A – Because it is only a proposal at this stage. A decision has not been made yet. The data upon which this proposal is based was not available until after 15 January 2014, when the closing date for middle school applications had passed.

Q – My child is due to transfer into Brewers Hill Middle school this September from their lower / primary school – if the proposal is approved, what would this mean for my son/daughter?

A – If the proposal to close the school is approved, all children who are due to start Brewers Hill Middle School in September 2014 would still be able to take up their place. By 31 October 2015 you would need to make an application for your child for a year 7 place at a Secondary school in September 2016. Brewers Hill Middle School would be closed by the end of the academic year in the summer of 2016.

Q – My child is currently attending Brewers Hill Middle School – if the proposal is approved, what would this mean for him/her?

A – If the decision is taken to close the school then the following would apply:

Child is currently in Year 5	Could continue at the school and make an application in September 2014, when in Year 6, to transfer to year 7 in secondary school in September 2015.
	Or alternatively child could continue into Year 7 in September 2015 but would need to make an 'in-year' application in the summer of 2016 to transfer into Year 8 at an alternative school i.e. Secondary school or Priory Academy or Barnfield Vale.
Child is currently in Year 6	You would need to make either a late application for a Secondary school to start Year 7 in September 2014.
	Or apply 'in-year' for a place in Year 8 in the summer of 2015 to start in September 2015.
Child is currently in Year 7	Could continue at the school and make application in September 2014, when in Year 8, to transfer to Upper school as normal for September 2015.
	Or make an 'in-year' application for a place in a secondary school either to start in the academic year of 2014/15 as a Year 7 pupil, or at the end of Year 7 to start in Year 8 at a secondary school.
Child is currently in Year 8	Would transfer to Upper or secondary school in September 2014 as per usual process.

Q – What happens at the end of this consultation period?

A - This consultation period will end on Monday 7 April. The responses to the consultation, plus any other alternative proposals that are submitted as part of the consultation process, will be considered at a meeting of the Children's Services Overview and Scrutiny Committee on Wednesday 7 May. This meeting will be held at the Grove Theatre in Dunstable at 7.00 pm. As with all Council meetings, the public are welcome to attend and

to speak at this meeting. For advice on how to apply to speak at a council meeting, please 12 see the guidance on page 11.

The Council's Executive Committee will then consider the results of the consultation plus any other viable options, along with the recommendations from the Children's Services Overview and Scrutiny Committee, at their meeting on Tuesday 27 May. This meeting will be held at the Council's offices, Priory House, in Chicksands at 9.30 am. The public are welcome to attend and to speak at this meeting. For advice on how to apply to speak at a council meeting, please see the guidance on page 11.

If a decision is made by the Executive to proceed with the proposal to close Brewers Hill Middle School, the Council would move to the next stage of the process, which is the publication of a statutory proposal and this would be published on Monday 9 June.

Q – If the Executive decide that an alternative viable option has been submitted for the future of Brewers Hill Middle School, what would happen then?

A - The Council would be required to carry out a consultation process for the alternative proposal, following the same procedure as this consultation.

Q – What is a statutory proposal and what would happen if it is published?

 ${\bf A}$ – A statutory proposal is the second part of the process that the Council is obliged to carry out for proposed prescribed alterations to its maintained schools. A full representation (description) of the proposal would be published on Monday 9 June along with a summary of the proposal, which is referred to as a statutory notice.

Once published, all interested parties would have an opportunity to respond and make their views known to the Council regarding whether or not they support the proposal to close the school. Any comments or concerns they may have can be submitted during this period. This part of the process would last for 4 weeks and would end on Monday 7 July.

Q – When would the decision be taken to either keep the school open or close it?

A –The Council's Executive would consider all of the responses received during the statutory notice period, and would determine whether or not to close the school at their meeting on 19 August 2014. This meeting, which the public are welcome to attend, will be held at the Council's offices, Priory House, in Chicksands at 9.30 am. For advice on how to apply to speak at this council meeting, please see the guidance on page 11.

Q – Could the Governing Body of Brewers Hill Middle School or anybody else appeal against the Executive's decision?

A -. Within four weeks of the decision being made by the Council, the following can apply to the Schools Adjudicator against the decision

- The local Church of England Diocese
- The local Roman Catholic Diocese
- The governing body of the school that is subject to the proposal
- The Trustees of a foundation, foundation special or voluntary school that is subject to the proposal

On receipt of an appeal, the Schools Adjudicator would request the Council to submit, within one week, the proposal, the responses received and the reason for the decision made. There is no right of appeal on any determination made by the Schools Adjudicator.

Q – What would happen to the building and land if the school was to close?

A – No decision has been made regarding this. The land and buildings would remain as Council assets. The school's playing fields are used by Dunstable Town Football Club and

this agreement would continue. If the Council decided to submit the buildings and land fage 13 disposal, the Secretary of State could insist that they are used for educational purposes.

Q – Why has the Council allowed this situation to happen within Dunstable?

A – Following Central Government's decision to allow academies (which are outside of the Council's control) to change their age ranges, in order to give maintained schools (schools which are within the Council's control) the same flexibility, Central Bedfordshire Council has allowed schools, with evidence of parental support, to bring forward their proposals to improve their schools and, through this, the outcomes for their pupils. The changes that have subsequently occurred in schools and academies throughout

The changes that have subsequently occurred in schools and academies throughout Dunstable and Houghton Regis have led to the situation that we now have.

New Government regulations, which came into effect at the end of January 2014, have given more freedoms to maintained schools; they are now able to change their age range by up to two years without following a statutory process and without the Council's consent.

Q – Has the consultation that Brewers Hill Middle School carried out previously, regarding a conversion to Barnfield Park Academy, had any bearing on this consultation?

A – No. In 2011 Brewers Hill Middle School governing body and Head teacher approached Barnfield Academy Trust with a view to becoming an Academy, with the intention to change their age range to become a primary school, with plans for a future studio school to be established (Studio schools are for pupils aged 14-19 years olds that have a new approach to learning which includes teaching through enterprise projects and real work). With the impact of the changing pattern of provision in the area, Barnfield Academy Trust eventually identified that there would not be sufficient demand for a further primary school.

The governing body of Brewers Hill Middle School may launch a further consultation regarding an alternative proposal. Information will be available on the school's website - http://www.brewershillmiddle.co.uk/

Consultation on the proposed closure of Streetfield Middle School, Dunstable Road, Caddington.

Monday 24 February 2014 - Monday 7 April 2014

1. Introduction

Councils have a duty to ensure there are enough suitable school places for children aged 5-16 (as per Section 14 of the Education Act 1996). The Council's role is to promote parental choice, diversity, high standards and fair access to education (Education and Inspections Act 2006).

To help meet these duties a Council has the power to close schools where no other viable options are available.

Possible reasons for closing a school include where:

- it is surplus to requirements (e.g. as a result of an area-wide reorganisation and/or there are sufficient places in neighbouring schools to accommodate displaced pupils)
- it is to be amalgamated/ merged with another school
- it is failing and there is no viable sponsored academy solution
- it is to acquire, lose or change religious character or
- it is being replaced by a new school.

Central Bedfordshire Council is proposing to close Streetfield Middle School because the current and projected pupil numbers make the school unviable.

This document explains the reasons for proposing to close the school and how you can have your say.

The Council is also currently consulting on proposals to close two other middle schools in the Dunstable area for the same reasons. You can also have your say, by responding to the separate consultations, on the proposals to close:

- Brewers Hill Middle School (Aldbanks, Dunstable) and
- Ashton CofE VA Middle School (High Street North, Dunstable).

2. Background

There have been lots of changes taking place in Dunstable and Houghton Regis schools over the last few years; many have taken advantage of greater powers given to them by Government to change their school, in response to parental demand. The governing bodies of maintained schools in the area, which have approached the Council for permission to consult on a change of age range, were able to provide proof of parental support at that early stage in response to their initial surveys. This support was further demonstrated during the consultation process for each proposal and was one of the factors that were considered by the Council when approving a requested change of age range.

Likewise, for academies that were required to ask the Secretary of State for Education for permission to change their age range, the level of parental support was again one of the factors that were considered when approving the proposal.

In both Dunstable and Houghton Regis there has been a shift from the three tier system Rage 25 lower, middle and upper schools towards a two tier primary and secondary school model as a result of these changes.

This shift has led to many of the previous feeder schools converting to primary schools. This has led to fewer pupils applying to middle schools for the intake at Year 5. Also the four former upper schools have extended their age ranges, meaning that some pupils are leaving middle schools to start secondary school in year 7. The combination of these factors means that pupil numbers at Streetfield Middle School have fallen significantly as a result of these changes. We have now reached a point where falling pupil numbers means the Council needs to consider the future viability of the school.

The funding that schools receive comes to the Council from Central Government and is passed directly to the Council's maintained schools in accordance with our local funding formula (academies receive their funding direct from Central Government). A maintained school's funding allocation is predominantly based upon the total number of pupils they have on roll and the total number of pupils that are due to move in and out of the school during that academic year. Because of falling pupil numbers, the budget for Streetfield Middle School is due to fall by 24.3% for 2014/15 alone, and this decrease, and projected decreases going forward, places the school in a financially unviable position. With such a significantly reduced budget, the school will be find it difficulty to employ sufficient teachers to enable the delivery of a full curriculum.

The table below sets out the current pupil numbers at Streetfield Middle School, the projected numbers in September 2014 based on actual applications, and projected numbers for September 2015 based on assumptions regarding applications. Streetfield Middle School has a Published Admission Number of 130 which is the total number of children that the school is able to admit for each year group.

The projected figures are based upon applicants' 'first preferences'. There are sufficient places within Streetfield Middle School to admit all of the children who have applied for a place, in year 5, at the school as a 'first preference'. Due to the places that are currently available within other Dunstable middle schools, children who have applied for a place within an alternative Dunstable middle school as their 'first preference' and have named Streetfield Middle School as their 'second preference' will be allocated a place within their

'first preference' school. Second and third preferences for Streetfield Middle School will Rage 26 therefore need to be considered.

As described above, low pupil numbers make the school no longer educationally or financially viable and keeping this school open would not be in the best educational interests of their pupils.

3. Our proposal

The Council is proposing to close Streetfield Middle School. The Council has considered other options (see question the Frequently Asked Questions on page seven) but the fall in pupil numbers, both current and projected, means that the school is not able to deliver the full curriculum and the school is unviable.

Should the proposal go forward and the closure of the school be approved, the timeframe and process would be as follows. Please note that this timescale would need to be reviewed nearer the time depending on actual numbers at the school.

Year 5	Children for the new Year 5 group are admitted.
Year 6	Parents of Year 6 children are invited to apply for transfer to a secondary school in Year 7 (to transfer in September 2015).
Year 7	Year 7 operates, but on a reduced size of year group.

- The governing bodies, teachers and staff of other schools that may be affected
- Parents and carers of children at other schools that may be affected e.g. at feeder schools
- The local diocese and other faith groups
- Neighbouring local authorities
- Members of Parliament

5. Frequently asked questions (FAQ's)

Q – Does this consultation mean that the Council has already decided that Streetfield Middle School will close?

A – No. The Council's Executive committee has approved the start of a consultation on the proposal to close the school, based upon the school's financial and educational viability. The final decision will not be made until 19 August 2014.

Q – Has the Council considered any alternative solutions other than the proposed closure of Streetfield Middle School?

A – Yes. We have considered converting the school to either a primary or a secondary school but we do not need any additional primary or secondary places.

$\mathbf{Q}-\mathbf{To}$ give parents a real choice, could the Council keep just one of the 3 middle schools open?

A – Unfortunately, due to the total number of pupils currently in Streetfield, Ashton CofE VA and Brewers Hill Middle Schools, and the number of projected pupils moving forward, this is not a viable option.

Q – Is the Council proposing to close Streetfield Middle School because it 'requires improvement' as per the last Ofsted report (dated December 2013)?

A –No. The closure is proposed because the current and projected pupil numbers make the school unviable. The school is currently being supported through the Council's School Intervention Strategy due to its performance.

Q – What is the Council's response to the accusation that by proposing to close 3 middle schools in Dunstable you are reducing parental choice?

A – Parental choice and support was demonstrated to us within the proposals that were brought forward to the Council by the schools that wished to expand their age range. This has been further demonstrated by the number of parents who have not applied for a middle school place for September 2014 but are choosing to keep their child within a primary school. There are still middle school options available in the area:

- Barnfield Vale has expanded and is a Primary and Middle school for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Caddington Village School is for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Priory Academy is expanding from 9-13 years to 9-16 years from September 2014 and admits children in the Middle transfer round to Year 5 as their normal point of entry.

Q – How can the Council be sure that the projected figures are correct?

A – The projected number of pupils for September 2014 for Streetfield Middle School is based upon the total number of applications received by the School Admissions Team, by the national closing date of 15 January 2014, that requested a year 5 place in the school.

Q- Would there be sufficient places in Dunstable upper/secondary schools to take any potential displaced children?

A – Yes. The Council is legally obliged to provide sufficient places for all children aged 5-16 years.

Q – Following the conversion of many Dunstable lower schools to primary status, is there now a surplus of primary school places within the town?

A – Yes. There is currently a 17% surplus of places in year R (reception) to year 5 and a surplus of between 63% and 65% surplus of places in years 5 to 8 within the local area.

Q – Historically, some Dunstable parents have chosen to send their children to schools outside of the local area. Is this still the case?

A – The admissions process allows for parental preference and parents can select any school they wish their child to attend whether that is their local school or one some distance away. In previous years some parents in the Dunstable and Houghton Regis area have opted for middle and upper schools in the Leighton Buzzard or Harlington areas or have chosen to send their children to schools in Luton.

Q – Are the school staff also being consulted as part of the consultation process?

A – School staff and trade union representatives are being consulted throughout this consultation process. Should a decision be made to issue statutory notices to close the school, staff and trade unions would be further consulted. The Council and the school's Human Resources provider will work with the governing body, the staff group and trade unions to ensure all staff have access to appropriate advice and support and will ensure that the relevant policies and procedures of the Council are followed.

Q - Should a decision to close the school be made, how would the Council retain the staff that would be needed until the school closed completely?

A - Should a decision be made to close the school, the governing body of the school would consider a staffing structure that would reflect the pupil numbers and the educational and pastoral needs of pupils at the school until it's closure. The Council would work with the governing body and their Human Resources provider when considering the staffing structure.

Q- Is the Council able to place staff from the schools under consultation in other local schools that may have vacancies?

A – In accordance with education legislation, each school's governing body is responsible for appointing its own staff therefore vacant posts in other schools are unable to be ring fenced to staff in those schools under consultation. The Council has a redeployment procedure for school based staff and would support the redeployment of suitably qualified and experienced staff where possible.

Q- Why did the Council not forewarn parents of this proposal?

A – Because it is only a proposal at this stage. A decision has not been made yet. The data upon which this proposal is based was not available until after 15 January 2014, when the closing date for middle school applications had passed.

Q – My child is due to transfer into Streetfield Middle School this September from their lower / primary school – if the proposal is approved, what would this mean for my child?

A – If the proposal to close the school is approved, all children who are due to start Streetfield Middle School in September 2014 would still be able to take up their place. By 31 October 2015 you would need to make an application for your child for a year 7 place at a Secondary school in September 2016. Streetfield Middle School would be closed by the end of the academic year in the summer of 2016.

Q – My child is currently attending Streetfield Middle School – if the proposal is Page 31 approved, what would this mean for him/her?

A – If the decision is taken to close the school then the following would apply:

Child is currently in Year 5	Could continue at the school and make an application in September 2014, when in Year 6, to transfer to year 7 in secondary school in September 2015.
	Or alternatively child could continue into Year 7 in September 2015 but would need to make an 'in-year' application in the summer of 2016 to transfer into Year 8 at an alternative school i.e. Secondary school or Priory Academy or Barnfield Vale.
Child is currently in Year 6	You would need to make either a late application for a Secondary school to start Year 7 in September 2014.
	Or apply 'in-year' for a place in Year 8 in the summer of 2015 to start in September 2015.
Child is currently in Year 7	Could continue at the school and make application in September 2014, when in Year 8, to transfer to Upper school as normal for September 2015.
	Or make an 'in-year' application for a place in a secondary school either to start in the academic year of 2014/15 as a Year 7 pupil, or at the end of Year 7 to start in Year 8 at a secondary school.
Child is currently in Year 8	Would transfer to Upper or secondary school in September 2014 as per usual process.

Q – What happens at the end of this consultation period?

A - This consultation period will end on Monday 7 April. The responses to the consultation, plus any other alternative proposals that are submitted as part of the consultation process, will be considered at a meeting of the Children's Services Overview and Scrutiny Committee on Wednesday 7 May. This meeting will be held at the Grove Theatre in Dunstable at 7.00 pm. As with all Council meetings, the public are welcome to attend and to speak at this meeting. For advice on how to apply to speak at a council meeting, please see the guidance on page 11.

The Council's Executive Committee will then consider the results of the consultation plus any other viable options that have been submitted, along with the recommendations from the Children's Services Overview and Scrutiny Committee, at their meeting on Tuesday 27 May. This meeting will be held at the Council's offices, Priory House, Chicksands at 9.30 am. The public are welcome to attend and to speak at this meeting. For advice on how to apply to speak at a council meeting, please see the guidance on page 11.

If a decision is made by the Executive to proceed with the proposal to close Streetfield Middle School, the Council would move to the next stage of the process, which is the publication of a statutory proposal and this would be published on Monday 9 June.

Q – If the Executive decide that an alternative viable option has been submitted for age 32 the future of Streetfield Middle School, what would happen then?

A - The Council would be required to carry out a consultation process for the alternative proposal, following the same procedure as this consultation.

Q – What is a statutory proposal and what would happen if it is published?

 \mathbf{A} – A statutory proposal is the second part of the process that the Council is obliged to carry out for proposed prescribed alterations to its maintained schools. A full representation (description) of the proposal would be published on Monday 9 June along with a summary of the proposal, which is referred to as a statutory notice.

Once published, all interested parties would have an opportunity to respond and make their views known to the Council regarding whether or not they support the proposal to close the school. Any comments or concerns they may have can be submitted during this period. This part of the process would last for 4 weeks and would end on Monday 7 July.

Q – When would the decision be taken to either keep the school open or close it?

A –The Council's Executive would consider all of the responses received during the statutory notice period, and would determine whether or not to close the school at their meeting on 19 August 2014. This meeting, which the public are welcome to attend, will be held at the Council's offices, Priory House, Chicksands at 9.30 am. For advice on how to apply to speak at this council meeting, please see the guidance on page 11.

Q – Could the Governing Body of Streetfield Middle School or anybody else appeal against the Executive's decision?

A -. Within four weeks of the decision being made by the Council, the following can apply to the Schools Adjudicator against the decision

- The local Church of England Diocese
- The local Roman Catholic Diocese
- The governing body of the school that is subject to the proposal
- The Trustees of a foundation, foundation special or voluntary school that is subject to the proposal

On receipt of an appeal, the Schools Adjudicator would request the Council to submit, within one week, the proposal, the responses received and the reason for the decision made. There is no right of appeal on any determination made by the Schools Adjudicator.

Q – What would happen to the building and land if the school was to close?

A – No decision has been made regarding this. The land and buildings would remain as Council assets. If the Council decided to submit the buildings and land for disposal, the Secretary of State could insist that they are used for educational purposes.

Q – Why has the Council allowed this situation to happen within Dunstable?

A – Following Central Government's decision to allow academies (which are outside of the Council's control) to change their age ranges, in order to give maintained schools (schools which are within the Council's control) the same flexibility, Central Bedfordshire Council has allowed schools, with evidence of parental support, to bring forward their proposals to improve their schools and, through this, the outcomes for their pupils.

The changes that have subsequently occurred in schools and academies throughout Dunstable and Houghton Regis have led to the situation that we now have.

New Government regulations, which came into effect at the end of January 2014, have given more freedoms to maintained schools; they are now able to change their age range by up to two years without following a statutory process and without the Council's consent.

Q – How does the consultation that Streetfield Middle School is currently undertaking, regarding a change of age range, affect the Council's consultation?

A –The consultation process that the Governing Body of Streetfield Middle school is currently undertaking is to enable the school to feedback into the Council's consultation with, what the governing body believe, will be an alternative viable proposal to the school's proposed closure.

At the close of the meeting the Acting Head teacher of Streetfield Middle School gave his view of the current situation and how it has arisen.

He advised of the alternative proposal that the school is currently consulting on, in response to the Council's proposed closure; this is to change the range of the school from 9-13 years to 4-11 years, with the addition of Nursery provision for 6 months -4 years. He encouraged everyone to respond to both the Council's and to the school's consultations.

1. Introduction

Councils have a duty to ensure there are enough suitable school places for children aged 5-16 (as per Section 14 of the Education Act 1996). The Council's role is to promote parental choice, diversity, high standards and fair access to education (Education and Inspections Act 2006).

To help meet these duties a Council has the power to close schools where no other viable options are available.

Possible reasons for closing a school include where:

- it is surplus to requirements (e.g. as a result of an area-wide reorganisation and/or there are sufficient places in neighbouring schools to accommodate displaced pupils)
- it is to be amalgamated/ merged with another school
- it is failing and there is no viable sponsored academy solution
- it is to acquire, lose or change religious character or
- it is being replaced by a new school.

Central Bedfordshire Council is proposing to close Ashton Church of England Voluntary Aided (CofE VA) Middle School because the current and projected pupil numbers make the school unviable.

This document explains the reasons for proposing to close the school and how you can have your say.

The Council is also currently consulting on proposals to close two other middle schools in the Dunstable area for the same reasons. You can also have your say, by responding to the separate consultations, on the proposals to close:

- Brewers Hill Middle School (Aldbanks, Dunstable) and
- Streetfield Middle School (Dunstable Road, Caddington).

2. Background

There have been lots of changes taking place in Dunstable and Houghton Regis schools over the last few years; many have taken advantage of greater powers given to them by Government to change their school, in response to parental demand. The governing bodies of maintained schools in the area, which have approached the Council for permission to consult on a change of age range, were able to provide proof of parental support at that early stage in response to their initial surveys. This support was further demonstrated during the consultation process for each proposal and was one of the factors that were considered by the Council when approving a requested change of age range.

Likewise, for academies that were required to ask the Secretary of State for Education for permission to change their age range, the level of parental support was again one of the factors that were considered when approving the proposal.

In both Dunstable and Houghton Regis there has been a shift from the three tier system Rage 45 lower, middle and upper schools towards a two tier primary and secondary school model as a result of these changes.

This shift has led to many of the previous feeder schools converting to primary schools. This has led to fewer pupils applying to middle schools for the intake at Year 5. Also the four former upper schools have extended their age ranges, meaning that some pupils are leaving middle schools to start secondary school in year 7. The combination of these factors means that pupil numbers at Ashton CofE VA Middle School have fallen significantly as a result of these changes. We have now reached a point where falling pupil numbers means the Council needs to consider the future viability of the school.

The funding that schools receive comes to the Council from Central Government and is passed directly to the Council's maintained schools in accordance with our local funding formula (academies receive their funding direct from Central Government). A maintained school's funding allocation is predominantly based upon the total number of pupils they have on roll and the total number of pupils that are due to move in and out of the school during that academic year. Because of falling pupil numbers, the budget for Ashton CofE VC Middle School is due to fall by 29.8.% for 2014/15 alone and this decrease, and projected decreases going forward, places the school in a financially unviable position. With such a significantly reduced budget, the school will find it difficult to employ sufficient teachers to enable the delivery of a full curriculum.

The table below sets out the current pupil numbers at Ashton CofE VA Middle School, the projected numbers in September 2014 based on actual applications, and projected numbers for September 2015 based on assumptions regarding applications. Ashton CofE VA Middle School has a Published Admission Number of 155 which is the total number of children that the school is able to admit for each year group.

The projected figures are based upon applicants' 'first preferences'. There are sufficient places within Ashton CofE VA Middle School to admit all of the children who have applied for a place, in year 5, at the school as a 'first preference'. Due to the places that are currently available within other Dunstable middle schools, children who have applied for a place within an alternative Dunstable middle school as their 'first preference' and have named Ashton CofE VA Middle School as their 'second preference' will be allocated a

place within their 'first preference' school. Second and third preferences for Ashton Coft **Page 46** VA Middle School will not therefore need to be considered.

As described above, low pupil numbers make the school no longer educationally or financially viable and keeping this school open would not be in the best educational interests of their pupils.

3. Our proposal

The Council is proposing to close Ashton CofE VA Middle School. The Council has considered other options (see Frequently Asked Questions on page seven) but the fall in pupil numbers, both current and projected, means that the school is not able to deliver the full curriculum and the school is unviable.

Should the proposal go forward and the closure of the school be approved, the timeframe and process would be as follows. Please note that this timescale would need to be reviewed nearer the time depending on actual numbers at the school.

September 2014	
Year 5	Children for the new Year 5 group are admitted.
Year 6	Parents of Year 6 children are invited to apply for transfer to a secondary school in Year 7 (to transfer in September 2015).
Year 7	Year 7 operates, but on a reduced size of year group.
Year 8	Parents of Year 8 children are invited to apply for transfer to a secondary school in Year 9 (to transfer in September 2015). This will be the last Upper transfer in Dunstable.

April 2015	
Year 7	Parents of Year 7 children are invited to consider making an application to transfer to a secondary school in Year 8 (to transfer in September 2015).
	This is known as an in-year application as it happens outside of the normal transfer point.

September 2015	
Year 5	No new pupils are admitted.

We recognise that this proposal to close the school may be unsettling for pupils, staff, parents and carers and we are keen to hear from all those people who want to have their say on the proposals during the consultation. You will find a list of Frequently Asked Questions (FAQs) starting on page seven of this document which may help to address some immediate concerns that you have. You are also welcome to raise queries via the School Admissions helpline on T.0300 300 8037 or at the public meeting that is being held at the school on Monday 3 March (see page six for details)

4. The consultation process

The Council is required to consult with a range of people and organisations including:

- Parents and carers of the children in the school
- The school's governing body
- The school's teachers and other staff
- The governing bodies, teachers and staff of other schools that may be affected
- Parents and carers of children at other schools that may be affected e.g. at feeder schools
- The local diocese and other faith groups
- Neighbouring local authorities
- Members of Parliament

As well as providing feedback on the Council's proposed closure of Ashton CofE VA Middle School, you can also submit an alternative

We will also hold a public meeting at Ashton CofE VA Middle School on **Monday 3 March 2014** at 7.00 pm which is open to all interested parties. We are also meeting with the staff, union representatives and governors of Ashton CofE VA Middle School.

At the end of this consultation, if the Council decides to pursue closure of the school, it would then have to go through another stage of consultation (a Statutory Notice period) before any final decision could be made in August.

5. Frequently asked questions (FAQ's)

Q – Does this consultation mean that the Council has already decided that Ashton CofE VA Middle School will close?

A – No. The Council's Executive committee has approved the start of a consultation on the proposal to close the school, based upon the school's financial and educational viability. The final decision will not be made until 19 August 2014.

Q – Has the Council considered any alternative solutions other than the proposed closure of Ashton CofE VA Middle School?

A – Yes. We have considered converting the school to either a primary or a secondary school but we do not need any additional primary or secondary places.

Q – To give parents a real choice, could the Council keep just one of the 3 middle schools open?

A – Unfortunately, due to the total number of pupils currently in Ashton CofE VA, Brewers Hill and Streetfield Middle Schools, and the number of projected pupils moving forward, this is not a viable option.

Q – Is the Council proposing to close Ashton CofE VA Middle School because it 'requires improvement' as per the last Ofsted report (dated December 2013)?

A – No. The closure is proposed because the current and projected pupil numbers make the school unviable. The school is currently being supported through the Council's School Intervention Strategy due to its performance.

Q – What is the Council's response to the accusation that by proposing to close 3 middle schools in Dunstable you are reducing parental choice?

A – Parental choice and support was demonstrated to us within the proposals that were brought forward to the Council by the schools that wished to expand their age range. This has been further demonstrated by the number of parents who have not applied for a middle school place for September 2014 but are choosing to keep their child within a primary school. There are still middle school options available in the area:

- Barnfield Vale has expanded and is a Primary and Middle school for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Caddington Village School is for children aged 4-13 years and admits children in both Year R and Year 5 as these are their normal points of entry.
- Priory Academy is expanding from 9-13 years to 9-16 years from September 2014 and admits children in the Middle transfer round to Year 5 as their normal point of entry.

Q – How can the Council be sure that the projected figures are correct?

A – The projected number of pupils for September 2014 for Ashton CofE VA Middle School is based upon the total number of applications received by the School Admissions Team, by the national closing date of 15 January 2014, that requested a year 5 place in the school.

Q- Would there be sufficient places in Dunstable upper/secondary schools to take Page 50 any potential displaced children?

 $\bf A$ – Yes. The Council is legally obliged to provide sufficient places for all children aged 5-16 years.

Q – Following the conversion of many Dunstable lower schools to primary status, is there now a surplus of primary school places within the town?

A – Yes. There is currently a 17% surplus of places in year R (reception) to year 5 and a surplus of between 63% and 65% surplus of places in years 5 to 8 within the local area.

Q – Historically, some Dunstable parents have chosen to send their children to schools outside of the local area. Is this still the case?

A – The admissions process allows for parental preference and parents can select any school they wish their child to attend whether that is their local school or one some distance away. In previous years some parents in the Dunstable and Houghton Regis area have opted for middle and upper schools in the Leighton Buzzard or Harlington areas or have chosen to send their children to schools in Luton.

Q – Are the school staff also being consulted as part of the consultation process?

A – School staff and trade union representatives are being consulted throughout this consultation process. Should a decision be made to issue statutory notices to close the school, staff and trade unions would be further consulted. The Council and the school's Human Resources provider will work with the governing body, the staff group and trade unions to ensure all staff have access to appropriate advice and support and will ensure that the relevant policies and procedures of the Council are followed.

Q - Should a decision to close the school be made, how would the Council retain the staff that would be needed until the school closed completely?

A - Should a decision be made to close the school, the governing body of the school would consider a staffing structure that would reflect the pupil numbers and the educational and pastoral needs of pupils at the school until it's closure. The Council would work with the governing body and their Human Resources provider when considering the staffing structure.

Q- Is the Council able to place staff from the schools under consultation in other local schools that may have vacancies?

A – In accordance with education legislation, each school's governing body is responsible for appointing its own staff therefore vacant posts in other schools are unable to be ring fenced to staff in those schools under consultation. The Council has a redeployment procedure for school based staff and would support the redeployment of suitably qualified and experienced staff where possible.

Q- Why did the Council not forewarn parents of this proposal?

A – Because it is only a proposal at this stage. A decision has not been made yet. The data upon which this proposal is based was not available until after 15 January 2014, when the closing date for middle school applications had passed.

Q – My child is due to transfer into Ashton CofE VA Middle School this September from their lower / primary school – if the proposal is approved, what would this mean for my child?

A – If the proposal to close the school is approved, all children who are due to start Ashton CofE VA Middle School in September 2014 would still be able to take up their place.

By 31 October 2015 you would need to make an application for your child for a year 7 place 51 at a Secondary school in September 2016. Ashton CofE VA Middle School would be closed by the end of the academic year in the summer of 2016.

Q – My child is currently attending Ashton CofE VA Middle School – if the proposal is approved, what would this mean for him/her?

A – If the decision is taken to close the school then the following would apply:

Child is currently in Year 5	Could continue at the school and make an application in September 2014, when in Year 6, to transfer to year 7 in secondary school in September 2015. Or alternatively child could continue into Year 7 in September 2015 but would need to make an 'in-year' application in the summer of 2016 to transfer into Year 8 at an alternative school i.e. Secondary school or Priory Academy or Barnfield Vale.
Child is currently in Year 6	You would need to make either a late application for a Secondary school to start Year 7 in September 2014. Or apply 'in-year' for a place in Year 8 in the summer of 2015 to start in September 2015.
Child is currently in Year 7	Could continue at the school and make application in September 2014, when in Year 8, to transfer to Upper school as normal for September 2015. Or make an 'in-year' application for a place in a secondary school either to start in the academic year of 2014/15 as a Year 7 pupil, or at the end of Year 7 to start in Year 8 at a secondary school.
Child is currently in Year 8	Would transfer to Upper or secondary school in September 2014 as per usual process.

Q – What happens at the end of this consultation period?

A - This consultation period will end on Monday 7 April. The responses to the consultation, plus any other alternative proposals that are submitted as part of the consultation process, will be considered at a meeting of the Children's Services Overview and Scrutiny Committee on Wednesday 7 May. This meeting will be held at the Grove Theatre in Dunstable at 7.00 pm. As with all Council meetings, the public are welcome to attend and to speak at this meeting. For advice on how to apply to speak at a council meeting, please see the guidance on page 11.

The Council's Executive Committee will then consider the results of the consultation plus any other viable options, along with the recommendations from the Children's Services Overview and Scrutiny Committee, at their meeting on Tuesday 27 May. This meeting will be held at the Council's offices, Priory House, Chicksands at 9.30 am. The public are welcome to attend and to speak at this meeting. For advice on how to apply to speak at a council meeting, please see the guidance on page 11.

If a decision is made by the Executive to proceed with the proposal to close Ashton Coffee 52 VA Middle School, the Council would move to the next stage of the process, which is the publication of a statutory proposal and this would be published on Monday 9 June.

Q – If the Executive decide that an alternative viable option has been submitted for the future of Ashton CofE VA Middle School, what would happen then?

A - The Council would be required to carry out a consultation process for the alternative proposal, following the same procedure as this consultation.

Q – What is a statutory proposal and what would happen if it is published?

A – A statutory proposal is the second part of the process that the Council is obliged to carry out for proposed prescribed alterations to its maintained schools. A full representation (description) of the proposal would be published on Monday 9 June along with a summary of the proposal, which is referred to as a statutory notice.

Once published, all interested parties would have an opportunity to respond and make their views known to the Council regarding whether or not they support the proposal to close the school. Any comments or concerns they may have can be submitted during this period. This part of the process would last for 4 weeks and would end on Monday 7 July.

Q – When would the decision be taken to either keep the school open or close it?

A –The Council's Executive would consider all of the responses received during the statutory notice period, and would determine whether or not to close the school at their meeting on 19 August 2014. This meeting, which the public are welcome to attend, will be held at the Council's offices, Priory House, Chicksands at 9.30 am. For advice on how to apply to speak at this council meeting, please see the guidance on page 11.

Q – Could the Governing Body of Ashton CofE VA Middle School or anybody else appeal against the Executive's decision?

A -. Within four weeks of the decision being made by the Council, the following can apply to the Schools Adjudicator against the decision

- The local Church of England Diocese
- The local Roman Catholic Diocese
- The governing body of the school that is subject to the proposal
- The Trustees of a foundation, foundation special or voluntary school that is subject to the proposal

On receipt of an appeal, the Schools Adjudicator would request the Council to submit, within one week, the proposal, the responses received and the reason for the decision made. There is no right of appeal on any determination made by the Schools Adjudicator.

Q - What would happen to the building and land if the school was to close?

A – No decision has been made regarding this. The land occupied by Ashton CofE VA Middle School is owned by the Ashton Foundation and the school is a St Albans Diocese School. Should a decision be taken to close the school, the Ashton Foundation would need to consider the future use of the land.

Q – Why has the Council allowed this situation to happen within Dunstable?

A – Following Central Government's decision to allow academies (which are outside of the Council's control) to change their age ranges, in order to give maintained schools (schools which are within the Council's control) the same flexibility, Central Bedfordshire Council has allowed schools, with evidence of parental support, to bring forward their proposals to improve their schools and, through this, the outcomes for their pupils.

The changes that have subsequently occurred in schools and academies throughout Dunstable and Houghton Regis have led to the situation that we now have.

New Government regulations, which came into effect at the end of January 2014, have Page 53 given more freedoms to maintained schools; they are now able to change their age range by up to two years without following a statutory process and without the Council's consent.

${\bf Q}-{\bf Has}$ the consultation that Ashton CofE VA Middle School carried out previously, regarding a change of age range, had any bearing on this consultation?

A – No. In March 2013, Ashton CofE VA Middle School launched a consultation regarding a proposal to change the age range of the school from 9-13 years of age to 4-11 years of age, and to also change the name of the school. At the end of the consultation the governing body decided not to proceed with the proposal.

Q – How does the consultation that Ashton CofE VA Middle School is currently undertaking (launched in January 2014), regarding a change of age range, affect the Council's consultation?

 ${\bf A}$ – As a Voluntary Aided school, the Governing Body are able to consult on a proposed change of age range (in excess of two years) without the permission of the local Council. However, at the end of the two part consultation process, the governing body is required to submit its findings to the Council and request a determination on its proposal.

Brewers Hill Middle School Second Consultation & Questionnaire (2014)

School Context

Brewers Hill has operated as a Community Middle School within Dunstable serving the North Dunstable community. The School plans under the Academies Conversion Programme to convert by August 2014 to Academy status, as Brewers Hill School.

Why convert to an Academy?

The Governors and Staff at Brewers Hill are committed to improving the educational provision for the children and families of Dunstable; to provide an educational provision that is at least good that is at the forefront of educational developments in the region through the development of an innovative school structure and curriculum that is responsive to local need thereby improving the opportunities and success of the area's children and young people. The move to becoming an Academy not only provides the school with access to the generic academy benefits of greater operational flexibility and scope for more innovative curriculum delivery; but also enables the school to develop and grow.

Over the last five years the school has maintained in size despite a fall in the local demographic and contrary to the cohorts in other local middle schools most of which have fallen dramatically. The School is led by a stable and established leadership team and experienced and committed governors.

Our Vision and Ethos

Our aim is to build upon the existing strengths of the school to deliver an 'outstanding' all-through educational pathway for Dunstable's children. The new Academy will provide a healthy, safe and caring environment, with excellent teaching and learning and a focus on exceptional student behaviour, progress and attainment. In response to the changing local educational environment Brewers Hill School will develop over time into both a centre for Early Years / Primary education, as well as building upon its existing curriculum strengths of mathematics, science, physical education and technology to create a new 11-18 age group, Key Stage 3, blended academic vocational provision. We would wish to extend our age range to year 13 (18 years old) from September 2015 as well as commencing the primary provision at the same time.

Consultation process

Following the confirmation by the Ministerial approval of the Academy Order which was granted in December 2011, the school has already consulted widely about its ambitions but because of the delay in being granted Academy Status is required to do so once more.

This paper is a summary of the proposed consultation process, and is in direct response to comments from parents asking for a 4-18 provision. The Academy is committed to undertaking a robust consultation process starting in February 2014 and concluding May 2014. The School is committed to reflecting the needs of its community; and as part of this process the school management team will be holding a series of open evenings and one-to-one meetings which will offer converting and prospective parents, converting staff, local residents and affected educational authorities the opportunity to discuss and inform the on-going development, educational vision, policies, procedures and admissions arrangements.

The new Academy will be able to provide a continuity of middle school provision alongside its transition to a Primary and Key Stage 3 model, with the provision planned to continue until the academy order is approved. We would then apply to change the age range from September 2015. The School can confirm that it will continue to offer Year 5 middle school places for entry as long as there is demand from parents to do so. This will be alongside admissions at primary and secondary ages. This is in response to the 'mixed economy developing in the Dunstable and Houghton Regis area with a commitment to continue this provision through for the full four middle school years and beyond if that is the choice of parents. The introduction of primary provision will be undertaken in a phased approach, with initially single phase primary provision being available, rising over time to a three phase primary roll. The Academy plans to utilise its existing facilities creating a dedicated area for Nursery and Early Years provision, as well as retaining its specialist areas, enabling it to provide a unique primary based curriculum model with the advantage of specialist teachers and facilities as the pupils move to key stage 3 and key stage 4 and sixth form.

The new Academy will work closely with secondary and higher education providers to allow a real and quality level of choice for pupils at the point of transition either at the end of key stage 2 or the end of key stage 3. After the outcome of the first consultation we have listened to the majority and this new provision, delivered at the Academy site, will provide education for pupils 13-18 which is in addition to the current site age range. Developed in partnership with the region's key local employers, the curriculum will enable young people to access and attain high levels of academic and vocational qualifications directly matched to the skills and competency needs of the region's employment growth areas. The Key Stage 3 provision will bridge the gap between the end of Primary and the Year 10 Key Stage 4 entry point. The provision will cater for students with a broad range of academic ability, offering a robust educational base whilst enabling the students to experience a unique blend of academic and vocational education, linked to local Key Stage 4 provision.

The Brewers Hill motto is 'Achievement for All'; that everyone has the capability of achieving great things, the all- through 4 to 18 pulls together the key components of success, offering smaller than average class sizes, targeted support and mentoring, specialist teaching and resources.

The new Academy will further build up its ethos of supporting all pupils developing lively and enquiring minds with an ability to challenge and argue rationally. The Academy will work to utilise its existing facilities more effectively, enabling it to develop the new range of provision.

The new Academy will aim to:

Offer smaller than average class sizes.

Offer a unique all-through model.

Allow for a real choice of points in pupil transition, as well as offering an extended time in one location.

Have a planned and tailored approach to each individual pupil learning needs.

Have an emphasis on life skills including the importance of courtesy and respect.

Focus on sports, ICT, maths, technology and science as key subjects to stimulate pupil engagement and attainment.

Provide specialist science and technology areas, equipped to provide distinctive opportunities in the primary curriculum model.

Offer drama, dance and creative arts programmes which will also be distinctive in the primary provision.

Provide an environment that is safe and enjoyable, with excellent learning spaces, where children of all abilities and varied cultures can achieve their full potential and enjoy learning

This, coupled with a belief in smart, functional school uniform, blurs the lines of social and ethnic background and forges a strong sense of unity and common purpose as a platform for achievement.

Academy Admissions

The new Academy will continue to draw its pupils from within a combined catchment area defined by the postcodes associated with its existing catchment area. The application process for the new Brewers Hill School for September 2014 onwards will continue to be at year 5; once we have approval for the adoption of an alternative model it will be in accordance with Central Bedfordshire Authority's co-ordinated admissions arrangements at primary and secondary level. These will be made on the common Application Form provided and administered by the Central Bedfordshire LA.

Consultation on the Funding Agreement

The Funding Agreement is the document that sets out the obligations of the Trust to the Secretary of State for Education in running the School. It states that the Secretary of State will fund the Academy Trust to establish, open and maintain the new Academy, providing that the school delivers a balanced and broadly based curriculum, provides education for pupils of different abilities and that it draws its students wholly or mainly from the area defined within its admissions procedures. Your completion of the associated new Academy questionnaire will support the school's leadership team in formalising the Funding Agreement with the Department for Education.

With the addition of Nursery Provision for 6 months – 4 years to provide feedback to the Council's consultation regarding the closure of the school.

PURPOSE OF THIS CONSULTATION DOCUMENT

The purpose of this document is to ask for your views regarding our proposal to close Streetfield Middle School from 9 -13 to re-open as a 4 - 11 years, purpose built Primary School and to include Nursery Provision for 6 months – 4 years on the same site. This will enable us to contribute an alternative, viable proposal in response to the Council's consultation regarding the closure of the school.

As part of this consultation we would also like to propose renaming Streetfield Middle School as 'The Streetfield Lyceum'.

BACKGROUND

Streetfield Middle School provides well for its pupils. 50% of our pupils come from outside our catchment area from Dunstable, its surrounding areas and villages. We also provide a 6 pupil specialist provision for pupils with Autistic Spectrum Disorder.

We believe that, given the complicated way in which the town has changed age ranges generally, our current children and future generations of children and families would benefit from the stability of a primary school on the same site/campus as the likely destination secondary school (Manshead Secondary School).

Our proposal provides a very clear 'learning journey' path for parents, tidies up transfer and transition issues and brings them into line with the primary/secondary model being adopted elsewhere in the town.

Contextual Position

There has been much change in the organisation of schooling in Dunstable, with a significant number of schools now being Academies and a move to a two-tier system of education.

- St. Mary's Catholic Lower School, Hadrian Academy, St. Christopher's Academy
 and Barnfield Vale Academy were granted permission to become 4-11 primary
 schools from September 2013. All Saints Academy, a 13-18 upper school was
 granted permission by the Secretary of State to extend its age range to 11-18
 from September 2013.
- Ardley Hill, Lark Rise and St. Augustine's Academies, Kensworth VC and Ashton St. Peter's lower schools were granted permission to become 4-11 primary schools from September 2014.
- Manshead Upper and Queensbury Academy were granted permission to become 11-18 secondary schools from September 2014.

PROPOSAL

The Governing Body is requesting that Central Bedfordshire Council consider its request to change the age range structure of the school to enable it to provide primary schooling for pupils from 4-11 years together with nursery and pre-school provision aged 6 months -4 years.

The proposed process will begin in September 2015. It provides for a three year transition programme for those pupils who joined the school expecting a 'middle school 9-13 experience'. Pupils who enrol in September 2014 (and those who enrolled in 2013, 2012 and 2011) can remain in a middle school environment at Streetfield if that is their wish. From September 2018 Streetfield will have fully converted to a 4-11 primary school with nursery provision for 6 months – 4 years.

It is proposed that there would be the following stages of implementation starting in September 2014:

The figures/numbers used for 2013/2014 all years and 2015 Year 6, 7 and 8, 2016 Years 7 and 8 and 2017 Year 8 – are based on projected numbers provided by CBC.

Projections for Years 7 and 8 from 2016 onwards are subject to change with regard to in- year admissions and exit to secondary schools.

- September 2014 It is estimated that around half of our current Year 6 pupils will
 move to secondary school at the end of the school year. (Though CBC data indicates
 more than half may transfer the fact remains that the collection of this data did
 not allow for parents changing their minds or double booking so it is unclear if CBC
 numbers are accurate.) The remaining Year 7 children will complete their middle
 school education in the current setting.
- September 2015 Open enrolment for Nursery, Early Years and Years 1-6. Current Year 5 children to remain in present setting and move into Year 6. Remaining Year 7 pupils and Year 8 pupils continue their middle school education.
- September 2016 Remaining Year 7 and 8 pupils continue their middle school education if they so wish. Pupils in Year 6 will transfer to secondary school.
- September 2017 Remaining Year 8 pupils complete their middle school education and transfer to their chosen secondary provider.
- September 2018 Streetfield Lyceum has pupils from ages 6 months 11 years only.

Throughout this transition period 2015 - 2018:

We will continue to take children who have moved to the area from another school or who do not have a school provision through the usual mid phase admissions process providing we do not exceed our admission number.

OBJECTIVES OF PROPOSAL

- To significantly improve the learning journey for pupils from 6 months to 18 years by ensuring the continuity of provision that two-tier systems bring on a single campus.
- To improve the academic performance of all pupils at the end of Key Stage 2 and thus at GCSE (or equivalent) by being wholly responsible and accountable for the learning and teaching of reading, writing, communication and maths in addition to general subjects and social, emotional and behavioural development.
- To significantly improve the 'personal development' outcomes for children.
- To provide a unique and innovative learning journey using state of the art, well equipped and fully functioning specialist facilities and teaching for science, sport, food, textiles, design, art, wood, metal, plastics, electronics and computing, that will combine the best of Primary and Middle School models for learning.
- To sustain high standards of education and maintain children's wellbeing by offering secure transition from primary to secondary providing secure continuity potentially from 6 months to 18 years on one campus.
- To enable more collaborative and positive partnerships to ensure high quality, localised educational provision.
- To offer all pupils in the Early Years Foundation Stage, Key Stage 1 and Key Stage 2 an exciting and innovative curriculum provision that meets their developmental and academic needs.

• To improve the quality of available parental choice so that a primary and secondary education from nursery to age 18 can be achieved on the same campus and to ease the difficulty of parents transporting children of different ages to and from school.

We believe that this move will also:

- Help to raise standards and improve outcomes by the end of Key Stage 2.
- Ensure that we provide specialist attention and expertise to groups of children who
 are talented, able and gifted or who have special educational needs, are vulnerable,
 or are in some way under performing at the time that they most need it Early
 Years and Key Stage 1.
- Provide stability, consistency and continuity for children in their primary years, through our ethos, curriculum, teaching and learning organisation.
- Ensure our school is based around Dunstable community's needs.
- Provide equal access for all pupils to the highest quality primary school education regardless of faith, creed or culture.
- Provide specialist teaching primary education for all children.
- Improve transition for children on transfer.

Special Educational Needs

Changing age range will have a positive impact for pupils with special educational needs and disabilities and for vulnerable learners which will build on the current good practice already established in our school. This is because:

- We have the expertise in early intervention, resources and teaching pedagogy to support children who find learning difficult.
- We believe that our professional knowledge of how children learn will enable us to provide effective intervention.
- We will continue to support the provision for pupils with Autistic Spectrum Disorder.
- We will continue to support our 'Learning Centre' (Inclusion Centre) for pupils with social and behavioural difficulties.
- Pupils in the ASD and Learning Centre make good progress as recognised by Ofsted in our last inspection (December 2013).
- Our exceptionally effective and positive transition programme for pupils in Year 8 is easily transferable to Year 6.

SCHOOL CAPACITY

Streetfield Middle School currently has an admissions number of 130 pupils per year group from Year 5 to Year 8, 520 pupils in total. We also provide a 6 pupil specialist provision for pupils with Autistic Spectrum Disorder whose numbers are included in this figure.

We propose to change our PAN to 60 per year group (2 form entry age 4-11) with the addition of places to provide a nursery and pre-school provision. The 4-11 part of the school would have a maximum capacity of 420 pupils in the original main brick built footprint of the school. The reduction of the PAN from 520 to 420 would enable the temporary classrooms, that were introduced in 1997 – 2003 to accommodate a sudden influx of pupils experienced at the time, to be used for the Nursery and Pre-School provision we are proposing.

The school has enough available classrooms, utilities and facilities to cater for the age range proposed. There will be no need for significant capital spending on new buildings.

The proposal would involve the refurbishment of some classrooms, playground and toilets to meet the needs of younger children. We have a rolling programme for refurbishment maintenance and this will take into account furniture, utilities and equipment.

We will be organising imaginative and innovative ways to manage the differing needs regarding lunchtimes, playtime and arrival and departure times.

Any building /refurbishment work required for these changes would be subject to the normal planning permission process, which would include consulting local residents, the Highways Agency and other interested parties.

The cost for refurbishment will be covered by re-designating the rolling programme for general repairs and replacement of furniture and utilities in the budget.

TRANSITION

In implementing this proposal we would continue to look to provide opportunities and continuity for all children in our community and beyond. If pupils stay with us throughout the primary phase we will support the transition at age 11 to the secondary school of their parents' choice. Our aim is to provide the best education possible and to be fully committed to the raising of standards through high quality teaching and learning.

We have analysed our present staffing structure and expertise and we have considered the transitional arrangements accordingly.

EXTENDED SERVICES

The proposal will give the opportunity for joint extended school provision reflecting the needs of the community and the aspirations of school leaders, including:-

- Transition support for pupils, schools and families.
- Shared training for parents and staff.
- A range of after-school activities.
- A commitment to wrap around care with breakfast clubs and after school clubs that fit the needs and aspirations of busy parents.
- Holiday activities.
- Workshops to support adult learning and encourage family learning by developing a Parent Centre that will enable parents to share and learn from each other and to further their own aspirations in the wider world of 'learning for life'.
- Support for vulnerable families and pupils.

ALTERNATIVE OPTIONS

Remain a 9 - 13 Middle School?

Not viable – pupil numbers would be too small to provide an adequate curriculum.

Become 9 - 16? Or 11 - 16?

Not viable - expert research has shown that for a viable curriculum to operate at age 14 - 16 then the staffing structure requires around 900 pupils

Why? There is a viable 11-18 provision 50 metres across the road.

Closing Streetfield as an Educational Institution altogether?

The school is in exceptionally good, robust and usable condition, whole roof refurbishment is currently being completed as is the final round of replacement doors and windows. It should remain as an education institution. Its facilities are not suitable for students over the age of 14.

The Process

The alteration of type of school must follow a prescribed democratic decision making process. The following table outlines the indicative timeline to change Streetfield Middle School.

In addition we will commission an independent enquiry as to general parental preferences regarding our proposal to ensure the viability of our plans. 



4 - Description of proposed prescribed alteration

To change from a 9-13 middle school to a 4-11 primary school with additional provision for Nursery (6 months -4 years) and a provision for 6 statemented pupils with Autistic Spectrum Disorder age 5-11 years.

5 - The date on which the proposals are planned to be implemented - If they are to be implemented in stages, a description of what is planned for each stage and the number of stages intended and the dates of each stage

According to LA Data:

- September 2014 It is estimated that around half of our current Year 6 pupils will move to secondary school at the end of the school year. (Though CBC data indicates more than half may transfer the fact remains that the collection of this data did not allow for parents changing their minds or double booking so it is unclear if CBC numbers are accurate.) The remaining Year 7 children will complete their middle school education in the current setting.
- September 2015 Open enrolment for Nursery, Early Years and Years 1-6. Current Year 5 children
 to remain in present setting and move into Year 6. Remaining Year 7 pupils and Year 8 pupils
 continue their middle school education.
- September 2016 Remaining Year 7 and 8 pupils continue their middle school education if they so wish. Pupils in Year 6 will transfer to secondary school.
- September 2017 Remaining Year 8 pupils complete their middle school education and transfer to their chosen secondary provider.
- September 2018 Streetfield Lyceum has pupils from ages 6 months 11 years only.

Throughout this transition period 2015 - 2018:

We will continue to take children who have moved to the area from another school or who do not have a school provision through the usual mid phase admissions process, providing we do not exceed our admission number.

6 – Consideration of consultation and representation period - evidence of demand for the proposed alteration, including details of consultation(s) carried out, meetings held and responses received.

The consultation period started on 24th February 2014 and closed on 24th March 2014.

- Streetfield held meetings with staff (6/1/2014), parents (28/1/2014, 5/3/2014) to discuss the proposal and it was adopted by governors (3/2/2014).
- The consultation was advertised in Central Essentials No.192 dated 13th February 2014 together with a link to the school website to access the consultation document.
- The following documents were published on the school's website:-
 - Letter (24/1/2014) sent to all our current and prospective parents regarding the Consultation and inviting them to a meeting on 28^{th} January 2014 at the school.
 - Our "So ..." booklet explaining the background behind the Consultation
 - The presentation made at the parents' meeting on 28th January 2014 describing our plan for the future of Streetfield.
 - The letter sent to all parents on 31st January 2014 detailing our plans for the future
 - Our consultation document
 - The link to our on-line questionnaire.
- Every child in the school was issued with a paper copy of the Consultation Document (14/2/2014) and questionnaire (24/2/2014) to take home.
- Reminders to complete the survey have been sent out to parents via Newsletters and email.
- The proposal and survey were placed on the Schools Learning Platform for parents, governors and staff to access.
- The Consultation Document and survey were advertised on the Dunstable and District NCT
 website to invite expectant parents and parents of young children to take part so that the school
 could see if there was a demand for the Nursery, Early Years and future provision as well as
 current school age education.
- Flyers for the consultation and survey link were distributed through the Dunstable and District NCT Nearly New Sale goodie bags on 1st March 2014 to reach other/expectant parents who were not members of the NCT.
- Staff distributed flyers advertising the consultation and survey to playgroups and to friends and families with young children in the area.
- A half page advert was placed in the Dunstable Gazette on 26th February 2014 regarding the public meeting at the school on 5th March 2014 inviting people to come and find out what our plans were for the future.

Special note about our Consultation and the LA consultation process

Having listened to advice from Officers and learning that the consultation is NOT a referendum nor a vote and that what matters most is what people have to say, we made the following decisions regarding the process for both the LA and our own consultation:

- We would **not** ask pupils to contribute by filling in consultation forms (we are confident that we could get them to say whatever we wanted but the fact is they are not the decision makers and their view can only be about what they currently experience, or have experienced, and this is about the future).
- We would remain open and transparent with parents give them all the information and allow for a free contribution. (Whilst we encouraged everyone to take part we did NOT go out and pursue contributions.)
- We split the way our own consultation could be responded to into two methods using the same questionnaire and using an independent survey provider:
- 1. The paper copy was issued to each family currently in the school and to all staff
- 2. The online version was for members of the public and the local community.

This seemed to be a fairer way of ascertaining genuine views rather than engineering a skewed result.

The statistical details of our survey are under Section 8 – 'Demand'

The written comments received from parents and the general public are as follows:

Parent and general public comments on Survey to become Streetfield Lyceum in 2015

I think it should stay as it is three tier as kids understand from lower school to middle that they are growing and when going up to upper it is for growing into an adult.

I would like to know more detail before commenting on my own children but in principle I think this is a good idea. Streetfield has the potential to offer primary school education an outstanding boost with their resources and staff. This should be explored.

Our lower school cannot offer science labs, art dept, gym/sport, cookery dept etc that Streetfield could offer as a lower/primary school 4-11 years, R-Y6. We would be looking elsewhere when our youngest reaches Y4 and current lower if Streetfield cannot be an option. We want Streetfield to be a primary, our eldest at Manshead and youngest on same complex.

Unfortunately my child won't be at Streetfield in 2015 as he is currently in Year 8. However, as a parent of a current pupil who has made wonderful progress during his time at Streetfield I would still like my views on the future of the school to be heard. The closure of Streetfield would be a massive loss to the children and parents of Dunstable and the surrounding villages.

I do not know if I will leave my son in Years 7 & 8. He is happy at the school but I will see how my eldest suits Manshead and how my 10 year old performs at Streetfield.

My children are leaving the school this year. I would like to thank Streetfield staff for their fantastic teaching. I cannot fault the school at all. I wish you all the very best for future years and hope you are able to take Streetfield as a primary school as you are proposing.

Streetfield is an amazing school. The staff are equally amazing. My child since being in Streetfield, currently in Y6, has made a dramatic amount of progress. He has grown into a lovely young man and that is because of Streetfield. Their new plans will only encourage more children to develop into smart, proud, caring, well-educated young people - there is not a school like it for miles. Our community needs this school.

I only have one child currently in Y5 but I think the new proposal proposed by Streetfield is a fantastic idea which will solve many families' problems having their children on one site. If the proposal had been available earlier, I would have had no hesitation in sending him to the new provision being offered. I think it will be an asset to the town.

Good luck with the battle.

I feel Streetfield would offer a fantastic opportunity as a primary school for my daughter. It has great facilities and an excellent site. Space for a new primary would not be limited unlike some of the local lower schools that have changed to primary. I would be happy to transfer my daughter in 2015 especially as my oldest son will be at Manshead and therefore on the same campus which would be easier for getting both to and from school.

I would prefer that Streetfield go up to Year 8. I am not 100% happy for my child to go to Manshead at Y7 but I do understand that things are changing. I would find the after school facility very useful.

Although my daughter is in Y8 I still support Streetfield as I have a son in Y5.

My child is in Y6 so have decided to make for a secondary school if Streetfield had changed early he may have stayed. Good luck with future plans.

The education and social skills that my child has achieved whilst studying at Streetfield have been valuable and allowed him to deal/cope with all the changes that have been created with the uncertainties of Streetfield. I personally would have preferred for my child to continue with his education at middle school and would recommend Streetfield as a great school.

As a parent of a child with special needs I chose this school even though I live in Houghton Regis. I would be very worried if the LA lose this expertise to the detriment of our children. Streetfield support our family's and child's needs fantastically and I would not want him to go anywhere else.

I would be glad if Streetfield changed into a primary school. It has a lot to offer their students. I would send my three youngest to the school as I would hopefully have my other two daughters attending Manshead along with my eldest who by then will be attending 6th form.

Our child is currently in Y6 due to his SEN issues he would not be able to emotionally deal with a secondary at this stage and will be staying at Streetfield until the end of Y8. We would use breakfast and after schools as well as holiday provision.

Streetfield is a great school.

If I had children of primary school age I would love for them to attend Streetfield as a primary as I feel that the opportunities that they have to offer would be wonderful. The convenience of all children accessing the same site would be great.

I support Streetfield and I would send my 3 children to this school as I believe it has so much to offer its students as well as its parents.

Would much rather see the school kept open as a middle school.

Streetfield is a wonderful school with an inclusive ethos which has helped my son like school. I think that Streetfield needs to work with the other schools on the site to provide a 2-18 education option (along the lines of CVS). I think the fact that one school is a Catholic school, one a community school and one C of E school will make this complicated. Surely a joined up approach including safeguarding, family worker etc. is what is best for children and their families?

As a parent who has recently moved to Dunstable because of the original layout of the three tiered school system I am bitterly disappointed to witness the changes. Mixing 12 year old children with 18 year old (children) does not fill me with confidence in that younger children will be exposed to behaviours of young encouragable adults. If it ain't broke, don't fix it.

I believe the governors and SMT are acting in the best interests of the present and future pupils.

I am very happy for my child to continue his education at Streetfield as it is. I do not feel need for any changes. It is a well equipped school with some great teachers.

If the LA close the school what provisions will they put in place for children that attend the ASD unit? There is very little provision for children with learning disabilities in Bedfordshire as it is.

I have one daughter who will be leaving Streetfield this year to go to Manshead School. However if I had more children I would send them to Streetfield. It is an excellent school and my daughter has thrived there.

I support Streetfield in becoming a primary school because it has the specialist equipment and facilities to support children in all Key Stages. The staff at the school are dedicated to helping all children whatever their background. All staff encourage children no matter what level of learning by supporting and encouraging.

I hope a fantastic school (that Streetfield is) is allowed to survive and thrive. I am unhappy that schools such as Ardley Hill that do not have facilities for Year 5 & 6 children are seen as a suitable solution by the council. I want my child at Streetfield to make use of all the current facilities. New houses, 60 and 80 (proposed) are being built next to the school. New residents will need a school. Streetfield will need to remain an educational establishment. The council can't sell the site for development, when it is situated between two other schools.

My daughter is in Y6 so some of the questions don't apply to my situation. She is really happy at Streetfield and wants to stay until Year 8. I have my concerns regarding the numbers for Year 7 in September 2014 and worry about her education, but I am also concerned that she isn't ready to go to a secondary school in September 14 and requires more nurturing to prepare her for the transition in September 2016.

My child will leave Streetfield in July 2015 as she will be in Year 8 and my second daughter is already in a primary school. However, Streetfield would have been a choice as they have most definitely been a great choice for my eldest daughter who is doing extremely well (level 5/6 in Year 7) and loves going to school. It saddens me that Streetfield have been 'forced' into this situation and hope the LA can see what a valuable part of Dunstable community it really is and fully support it becoming a primary.

I think the way the school is at the moment should be left as it is works well and plenty of other schools around. Interrupts children and most importantly education especially children who have difficulties to change.

We currently have a child in Year 7 at Streetfield and have selected Streetfield as our school of choice for our youngest child to transfer to in September 2014 when he moves into Year 5. We have been thrilled with Streetfield from our eldest son's first day and haven't looked back since. He embraces everything that is on offer to him with such enthusiasm and pride it overwhelms us. He has such pride in his school it is breathtaking and Streetfield's ethos has meant that he has been given the opportunity to grow not just on an academic level but also on a personal one too. If it had been possible to transfer our youngest son to Streetfield any earlier we would have done so in a heartbeat, that is how strongly we support this school. The proposed change in age range from a middle to a primary are extremely exciting and will mean that Dunstable will finally have a primary school that will lead the way in the town! We do not have any younger children to follow our second son, but if we did we would have no hesitation in placing them at this new primary school also. Dunstable currently has lower schools trying to cram in extra classes into schools buildings that are not designed for that purpose, whereas Streetfield already has the facilities ready and waiting with plenty of space both inside and out to accommodate both Key Stage 1 and Key Stage 2 children with very little need for adaptation. Infant and junior pupils who attend this school would benefit from food tech rooms, an art studio, design tech rooms, science labs and exceptional sports facilities that are not available at the majority of the lower/primary schools in Dunstable. With the new housing currently being built on Streetfield's doorstep and the increasing numbers of primary school children needing places we believe Streetfield's new primary school would be perfectly placed and there would most definitely be a demand for places at this school. The vast majority of pupils who attend Streetfield naturally progress through to Manshead and with Manshead now being a secondary school this natural progression would be able to continue with children leaving Streetfield at Year 6 to join Manshead in Year 7. For those parents who have children in nursery, primary and secondary age groups having both schools on one site would be extremely advantageous both to the parents but also to the local traffic network as it would lessen the travelling around our town, by removing journeys to various different schools locations, a 'win win' situation on many levels! We know that Streetfield is the best place for our younger son to be in September and we truly hope that the school gets the opportunity they deserve to continue to provide a fantastic school experience to the children of Dunstable.

If you change my daughter will be moved to your school.

The proposal put forward is fantastic and would be a breath of fresh air for Dunstable a much needed provision. For years I have had to juggle childcare from when my children were young, as babies and starting school, travel times and childcare availability impacted on work commitments, so having a good facility like this on one campus would alleviate so much pressure and problems for parents. I would not hesitate to use this facility and don't think I would look at any others.

7 – Education standards and diversity of provision - the effect that this proposal would have on other schools, academies and educational institutions within the area and also on the local community

Diversity of Provision:

The location of the school serves a diverse community and provides for two quite distinct geographical and socio-economic areas.

The impact will be to provide an extremely rich and vibrant community that will encourage and promote social mobility and raise the aspirations and expectations of all pupils and parents.

It is also on the same campus site as a Roman Catholic primary school and a Church of England secondary school.

As a non-denominational school that provides for every creed and culture, Streetfield will complement not compromise the denominational aspirations and provision of the partner schools and their parents.

Educational Standards

The proposed provision dovetails with Government and Ofsted pronouncements about the joining up of pre-school opportunities with formal schooling at 4+.

The ability to provide high quality and tightly focussed broad learning opportunities for children from 6 months to 11 years has never been more important.

As the current curriculum changes and evolves Streetfield will be at the forefront – as a new provision staff will not have to 'unlearn' past practice – instead we will be able to focus intently upon the new teaching, learning and assessment curriculum expectations and aspirations from the outset.

The specialist provision and, specialist teaching, that we will provide will be second to none in the town and surrounding villages.

The school houses purpose built, fully maintained, fully equipped (and independent from general classrooms) facilities such as:

- Art
- Food
- Textiles
- and Design rooms

together with a very large, single purpose

- Gym
- two Science Labs
- two Computer Suites
- Music Room and two individual music practice rooms
- Modern Language specialist rooms.

We also have a fully functioning large, and well equipped school kitchen that can provide hot meals for

up to 500 pupils on a daily basis.

Extensive school grounds that include:

- play spaces for up to 500 children and can be easily adapted for the new proposed age ranges
- sport and play fields that will allow for every type of team, athletic field and track sport available with specialist sport teaching
- the sport premium is accruing to provide for Outside Adventurous Activities suitable for all age ranges 6 months to 11 years in a specially designated area of the school grounds.

8 - Demand

General Comments:

It is not clear what the impact of the new housing at Eleanor Gardens and proposed new housing adjacent to the campus site will have upon pupil numbers but it is unlikely to decrease them.

In the normal evolution of housing estates the 'fallow' period of lower pupil numbers that has beset Downside as the estate has grown up, is beginning to ease.

It looks likely that there will be an increase in younger families over the next 5 -10 years but this is notoriously difficult to pin down – it should however be an important consideration given past experiences.

In the meantime the additional choice offered to parents with the increased number of primary schools should encourage us all to raise standards further.

Specific Comments

There are two separate consultations:

- 1. The LA proposal to close Streetfield Middle School
- 2. Streetfield's proposal to restructure as Primary School

1. Broad Interpretations of our findings from our consultation;

There is significant demand and support for:

• An all through 6 months—11 years and 11-19 years provision on the same campus site that includes

Streetfield providing:

- Nursery
- Early Years
- 4-11
- Wrap around care breakfast
- Wrap around care after school
- Provision for children during the school holidays

There is little support (5%) for the closure of Streetfield altogether with 95% against.

The proposed process will begin in September 2015. It provides for a three year transition programme for those pupils who joined the school expecting a 'middle school 9-13 experience'. Pupils who enrol in September 2014 (and those who enrolled in 2013, 2012 and 2011) can remain in a middle school environment at Streetfield if that is their wish. From September 2018 Streetfield will have fully converted to a 4-11 primary school with nursery provision for 6 months – 4 years.

It is proposed that there would be the following stages of implementation starting in September 2014:

The figures/numbers used for 2013/2014 all years and 2015 Year 6, 7 and 8, 2016 Years 7 and 8 and 2017 Year 8 - are based on projected numbers provided by CBC .

10 – Proposed admission arrangements (including post-16 provision)

Central Bedfordshire Council, acting as the Local Authority, is the admission authority for all community schools including Streetfield Lyceum.

The following criteria will apply (in the rank order shown) to decide the order in which places will be allocated when there are more requests from parents/carers than the number of places available:

- 1. All 'looked after' children or children who were previously 'looked after';
- 2. Children living in the Dunstable and surrounding villages in Central Bedfordshire with siblings at the school;
- 3. Children living in Dunstable and the surrounding villages;
- 4. Other children with siblings in the school;
- 5. Children who live nearest to the school determined by straight line distance from the school site to the child's home address.

11 - National Curriculum

As a maintained school we will be following the revised National Curriculum that comes into force from September 2014 onwards. We will also incorporate any changes to early years and nursery education as suggested by Ofsted and adopted by the DFE.

12 - Equal opportunity issues

Streetfield Lyceum will be an equal opportunities school for all children aged between 6 months and 11 years.

The ethos of the Lyceum will remain unchanged as it works to:

- Eliminate all forms of discrimination that can cause barriers to learning and thus life chances
- Advance equality of opportunity for all pupils and families to ensure secure foundations for current and future learning
- Narrow and close gaps in prior attainment and achievement
- Foster good relations with all who are connected with the school to ensure that every child receives a 'top class' and positive educational, academic, social and emotional experience that prepares each and every child for the next stage of their schooling.

13 – Community cohesion

With our planned:

- Nursery 6 months -11 years
- Wrap around care for children before and after school
- 'School Holiday' child provision
- Parent Centre and
- Teacher Centre Resource for all Dunstable schools

Together with our work with charity and local community events and our partner schools our contribution and commitment to community cohesion can be in no doubt.

14 - Travel and accessibility

Transport issues would be eased by parents being able to deliver and collect their children on one educational site rather than crossing town, especially during morning rush hour, to visit different sites.

In the event that demand from villages continues then we would negotiate travel arrangements with the LA school transport services in the first instance.

15 - Capital

No new building costs would be incurred.

Some classrooms and toilets would need to be adapted to suit a lower age range and a new play area created for younger children.

The land and premises are each appropriate, fit for purpose and available for immediate use and implementation.

16 - School premises and playing fields

There is exceptional and suitable outdoor space that both enables the pursuit of all sporting activities and all pupils to play outside safely each day.

Though non statutory, there are sufficient facilities for sports pitches, games courts and athletic facilities on both hard and soft groundings.

17 – Changes to special educational need provision – the SEN improvement test

Streetfield currently has a very high proportion of SEN pupils at all stages and in addition:

- Specialist Provision for pupils with ASD.
- It is well regarded in the local community, with Assessment and Monitoring, Social Care, CAMH, for its commitment and effectiveness with children from a wide range of backgrounds.

It also has an enviable inclusion record for pupils with:

- ASD
- Emotional and Behavioural Issues
- Learning Needs including Literacy and Numeracy

One of the consequences of this success is high pupil mobility and unfortunately this has resulted in a disproportionately large number of children not able to reach national standards in reading, writing and maths by the end of Year 6.

Our proposal will enable us to redress this imbalance from a much earlier age.

Through our intended nursery, early years provision and parent centre we will be able to

- accurately identify needs earlier
- work in closer collaboration with parents at a crucial stage of child development and
- use our expertise to narrow and close the gaps for these vulnerable pupils.
- Whilst offering a broad and balanced curriculum that enables each child to thrive.

Furthermore, with our planned provision for ASD pupils aged 5 -11 we will be better able to meet the academic, social, emotional, transfer and transition needs of those ASD pupils in Dunstable which is now subject to primary and secondary transfer points. It is a facility that is sorely needed in the town.
