Licensing Sub-Committee Checklist

1. Introduction

- 1.1. Central Bedfordshire Council is the Licensing Authority for the grant of Sex Establishment Licences within the Central Bedfordshire Council area.
- 1.2. This document and the procedures detailed herein give information concerning the hearing and decision making process for Sex Establishment licensing.
- 1.3. This guidance is intended for all concerned in any way whatsoever with a hearing before a licensing panel (Licensing Sub-committee, the Licensing Committee or Council, as may be the case) in relation to the determination of applications under Sex Establishment licensing regulations.

2. General Principles

- 2.1. All Members sitting on the determination of an application will always promote the right of all parties to a fair hearing and only have regard to the evidence put before them by:
 - The applicant
 - The responsible authority (Police)
 - Any interested parties

2.2. Members will:

- have regard to the Local Government (Miscellaneous Provisions) Act 1982, Schedule 3 and any relevant secondary legislation
- have regard to the Council's own Statement of Licensing Policy for Sex Establishments
- treat each application on its own merits; and
- undertake its decision-making responsibilities honestly and fairly, in an open, transparent and accountable way.

PRE-HEARING

3. Licensing Panels

- 3.1. Generally, hearings will take place before a Licensing Sub-committee consisting of three Members of the Licensing Committee, although, to avoid unnecessary adjournments, a fourth Member may attend as a substitute Member.
- 3.2. If, for any reason whatsoever, it is not possible to have a matter determined by a Licensing Sub-Committee, the matter would be heard by the Licensing Committee. A Licensing Committee must consist of between ten and fifteen Members and at least one half of those Members must attend for a hearing to proceed before the Licensing Committee.
- 3.3. In the highly unlikely event of it not being possible, for any reason whatsoever, to have a matter determined by either a Licensing Sub-committee or the Licensing Committee, the matter would be heard by Council.

4. Timescales for Convening a Hearing

- 4.1. Most hearings must normally take place within 20 working days from the last date in which representations can be made.
- 4.2. Exceptions, with the agreement of the committee:
 - 4.2.1. Where the objections are withdrawn
 - 4.2.2. Where a party cannot attend on the day and it is in the interests of fairness to postpone the hearing to a later date
- 4.3. Hearings may be dispensed with where all relevant persons agree a hearing is unnecessary.

5. Notice of Hearing

5.1. Generally 10 clear days notice will be given of a hearing.

6. Persons to be Notified of a Hearing

- 6.1. The following persons must be notified of a hearing:
 - 6.1.1. Any applicant for a licence
 - 6.1.2. Any person who has made relevant representations;
 - 6.1.3. The Responsible Authority

7. Contents of Notice

- 7.1. The notice of a hearing must contain:
 - 7.1.1. The date, time and place of the hearing;
 - 7.1.2. The procedure to be followed at the hearing;
 - 7.1.3. The right of a party to attend and to be assisted or represented by any person whether legally qualified or not;
 - 7.1.4. Any points upon which the authority considers that it will want clarification from a party at the hearing;
 - 7.1.5. The right of the party to provide additional information to provide any clarification sought by the Authority;
 - 7.1.6. The consequences of failing to attend the hearing or not being represented at the hearing;
 - 7.1.7. Any information the Licensing Authority has received in support or opposition of the application.

8. Hearings to be open to the public

- 8.1. Hearings will generally be open to the public as the Licensing Authority is committed to taking decisions in an honest, accountable and transparent way, but on occasions a licensing panel may find it necessary to exclude a party or parties, the public and press from all or any part of a hearing.
- 8.2. A panel will only pass an exclusion resolution where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in public. Such decisions will be made on an individual basis.
- 8.3. The panel's deliberations, which do not form part of the hearing, will be conducted in private. The announcement of the panel's decision is part of the hearing and will generally be open to the public, subject to any exclusion resolution.

9. Failure to attend the hearing

- 9.1. No party is obliged to attend a hearing, although the Licensing Authority encourages all parties to attend hearings to make their application or representation, as may be the case.
- 9.2. Regardless of whether a party attends a hearing or not, the matter will generally be heard and determined by the licensing panel (the Council, the Licensing Committee or a Licensing Sub-committee). At the hearing, the panel will consider any application, representation or notice made by an absent party in the same way as it will of any application, representation or notice made by a party that attends the hearing.
- 9.3. If, however, the hearing is adjourned to a specified date, all parties will forthwith be notified of the date, time and place to which the hearing has been adjourned.

10. Disruptive behaviour

- 10.1. Any person who disrupts a hearing by the Council, the Licensing Committee or a Licensing Sub-committee of a matter being heard under Sex Establishment legislation may be required to leave the hearing.
- 10.2. It is for the panel hearing the matter to decide whether such person will be permitted to return to the hearing, but should they be allowed to do so, this may be on such conditions as the panel may specify.
- 10.3. If a disruptive person is a person who has a right to address the panel, then that person may, before the end of the hearing (i.e. before Stage 25 of the following procedure), put in writing any information they would have been entitled to give orally, had they not been required to leave the hearing.

SUB - COMMITTEE AGENDA

11. Licensing Sub-Committee agenda

- 11.1. The Licensing Sub-Committee Hearing shall be commenced in accordance with the Licensing Sub-Committee agenda. Any Committee matters shall be addressed at this stage.
- 11.2. The Licensing Sub-Committee Hearing procedure shall take over at the point at which the agenda item is called to be heard.
- 11.3. The Sub-Committee agenda shall deal with the issue of exclusion of press and public for the Licensing Sub-Committee Hearing.

HEARING PROCEDURE

12. Opening the Hearing

- 12.1. The Licensing Sub-Committee Hearing shall be formally opened by the Chair.
- 12.2. The Chair shall introduce Members of the licensing panel (a Licensing Subcommittee, the Licensing Committee or Council), officers present and all other parties present.
- 12.3. The Chair shall explain the procedure to be followed at the meeting and the nature of the decision to be taken by the panel.

13. Licensing Officer's Report

- 13.1. The Licensing Officer presents his / her Report, including an outline of the application, the representation(s) and any points upon which the Licensing Authority has given notice that it required clarification, and identifies anything relevant in the legislation and the Council's Statement of Licensing Policy.
- 13.2. Members of the panel may ask questions of the Licensing Officer with regards to the Report.

14. Licensing Authority's request(s) for clarification

- 14.1. If points of clarification have been asked for, the Chair invites the Licensing Officer or relevant party to provide necessary information.
- 14.2. Members of the panel may ask questions with regards to the further information provided.

15. Presentation of Case / Submissions from Parties

- 15.1. In the order of Applicant, Responsible Authority and Interested Party each party shall be invited to undertake the following:
 - 15.1.1. Set out their case;

- 15.1.2. Call Witnesses in support of their case (provided notification of the witnesses has previously been given to the Council);
- 15.1.3. Introduce documentary evidence in support of their case (provided notification of the documentary evidence has previously been given to the Council); and
- 15.1.4. Respond to any questions asked of them by Members of the Licensing Panel.
- 15.2. At the Sub-Committee and Chair's discretion each party may ask questions of other parties by directing them through the Chair.
- 15.3. The Sub-Committee shall have the absolute discretion to restrict the number of witnesses and documents that any party can introduce, or the time spent on submissions or oral evidence, to ensure the proper running of the hearing.
- 15.4. Any witnesses that any party is seeking to call that have not previously been notified to the Council, in advance of the hearing, shall only be allowed with the consent of all other parties at the hearing. The Sub-Committee shall have the sole discretion to refuse to allow any witnesses to be heard, even where the consent of all parties has been given. In reaching the decision the Sub-Committee may consider any circumstances they believe to be relevant, and will have regard to the relevance of the evidence to the matters before the Committee.
- 15.5. Any documents that any party is seeking to adduce that have not previously been notified to the Council, in advance of the hearing, shall only be allowed with the consent of all other parties at the hearing. The Sub-Committee shall have the sole discretion to refuse to allow any documents to be adduced, even where the consent of all parties has been given. In reaching the decision the Sub-Committee may consider any circumstances they believe to be relevant, and will have regard to the relevance of the evidence to the matters before the Committee.

16. Modification or Withdrawal of Application or Representation

- 16.1. The Chair shall ask the applicant whether the applicant wishes to modify or withdraw the application
- 16.2. The Chair shall ask each party making a representation whether such party would like to withdraw their representation

17. Closing Submissions

- 17.1. The Chair shall invite each of the parties to present a closing submission to the Sub-Committee.
- 17.2. The Chair shall invite the Licensing Officer to make any final representations.
- 17.3. At the end of the Closing Submissions the Chairman may ask the Legal Advisor if there is any clarification or points they wish to make.

18. Legal Advice

18.1. The role of the Legal Advisor is to provide Members with advice on:

- Questions of law;
- Matters of practice and procedure;
- The options available to the sub-committee in making their decision;
- Whether information or evidence is relevant to the licensing objectives;
- Any relevant case law or guidelines.
- 18.2. The hearing shall be directed by the Chair and assisted by the Legal Advisor as appropriate and necessary.
- 18.3. The Sub-Committee shall be entitled to vary the order and procedure for the hearing, at its absolute discretion.

19. Determination of the Application

- 19.1. After all representations have been heard, the Chair will inform all parties that the panel will retire in private to determine the matter.
- 19.2. Either the panel will retire alone to a private room or all parties, officers and members of the public will be required to leave the room, although the panel may invite their legal adviser to join them for the purpose of providing only legal advice the details of which will be disclosed upon the hearing reconvening.
- 19.3. Should the sub-committee need to ask any further questions of any party, all parties shall be invited to return for the purposes of asking and answering questions.

 The Sub-Committee will normally make its determination at the conclusion of the meeting
- 19.4. All decisions shall be made in line with the general principles as detailed in Appendix A, the range of options available.
- 19.5. The Sub-Committee shall complete the decision notice as shown at Appendix B.
- 19.6. The hearing will reconvene and the Chair will either:
 - announce the Sub-Committee determination including reasons for the determination; or
 - advise those persons present that the Sub-Committee has not reached a
 decision, but will make a determination as soon as it can and, in any event,
 within five working days. All parties will then be notified forthwith of the
 decision.

POST HEARING

20. Record of Proceedings

- 20.1. The authority shall ensure that a record is taken of the hearing.
- 20.2. The record shall be kept for a period of six years from the date of the final action on the matter.

21. Irregularities

- 21.1. Proceedings shall not be rendered void due to a failure to comply with the procedures set out in this document.
- 21.2. Any failure to comply with Hearing Regulations shall not render the process or the decision void.
- 21.3. Where the Authority considers any person to have been prejudiced from the irregularity it shall take such steps as it considers fit to remedy the irregularity, before reaching its determination.
- 21.4. Clerical mistakes may be corrected by the Authority.

22. Decision Notices

22.1. The Authority shall provide a written notice of its determination as soon as practicable after the hearing and within 5 working days.

23. Appeals

23.1. An appeal against the determination of the Authority must be made to the appropriate Magistrates Court within 21 days of the date of delivery of the decision.

24. Closing the Hearing

- 24.1. The Chair shall thank all parties for attending and draw the hearing to a close.
- 24.2. Should there be another hearing to be heard the Sub-Committee shall begin the procedure again.

The Police have received a copy of this application. We note that a premises Licence is already in force. There is no evidence of significant crime or disorder in the immediate area of the premises.

The Police have noted the Standard conditions contained within the Central Bedfordshire Council Statement of Licensing Policy with regard to Sex Establishments.

Should the Committee be minded to grant this application the Police would request that consideration be given to adding the below listed conditions to the Licence.

- 1. A minimum of 4 SIA registered door staff of whom one will be female will be on duty at the premises during operating hours and for a further 30 minutes after the terminal hour.
- 2. A suitable CCTV system to be installed to the satisfaction of Bedfordshire Police. The system to be operational at all times when licensed activities are being carried out. 1. Hearings to be open to the public

- 1.1. Hearings will generally be open to the public as the Licensing Authority is committed to taking decisions in an honest, accountable and transparent way, but on occasions a licensing panel may find it necessary to exclude a party or parties, the public and press from all or any part of a hearing.
- 1.2. A panel will only pass an exclusion resolution where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in public. Such decisions will be made on an individual basis.
- 1.3. The panel's deliberations, which do not form part of the hearing, will be conducted in private. The announcement of the panel's decision is part of the hearing and will generally be open to the public, subject to any exclusion resolution.

2. Failure to attend the hearing

- 2.1. No party is obliged to attend a hearing, although the Licensing Authority encourages all parties to attend hearings to make their application or representation, as may be the case.
- 2.2. Regardless of whether a party attends a hearing or not, the matter will generally be heard and determined by the licensing panel (the Council, the Licensing Committee or a Licensing Sub-committee). At the hearing, the panel will consider any application, representation or notice made by an absent party in the same way as it will of any application, representation or notice made by a party that attends the hearing.
- 2.3. If, however, the hearing is adjourned to a specified date, all parties will forthwith be notified of the date, time and place to which the hearing has been adjourned.

3. Disruptive behaviour

3.1. Any person who disrupts a hearing by the Council, the Licensing Committee or a Licensing Sub-committee of a matter being heard under Sex Establishment legislation may be required to leave the hearing.





This representation submits objections to the applicant being granted a Sexual Entertainment Venue (SEV) licence on the following grounds:

(a) Proximity to a residential area

"Shaylers" position on Market Square is located in very close proximity to residential accommodation adjacent and opposite the proposed strip club.

It is clear that a strip club sited in such close proximity to a residential area is neither acceptable nor appropriate, because of the potential fear of crime, anti-social behaviour, noise pollution and disturbance to residents and is incongruent with current Central Beds policy.

Such reasons reflect concerns raised by key stakeholders in consultations which led to the subsequent reform of licensing law governing the sex industry vis-à-vis strip clubs. Other reasons included the heightened statistical link to physical, verbal and sexual assaults against women who live or work in the vicinity of strip clubs.

Many of the towns 5,000 residents will be reluctant to walk through the centre of their own community for fear of suffering such abuse, as this application is made for premises at its heart in its small Market Square.

The premises are located in the centre of Ampthill on the Market Square, there is seating provided for residents, both young and old, and these are directly outside the premises.

(b) Character of the relevant locality

Central Beds policy also provides that SEV licences shall be considered with respect to the character of the relevant locality.

Ampthill is a market town with a long history, but it is struggling in the current economic climate with several local businesses closing down. The opening of a local strip club will counteract the efforts of hardworking local business people by tarnishing the area with a sleazy image, explicitly associated with prostitution, violent/sexual crime and anti-social behaviour.

The negative economic impact of operators such as the applicant will be acutely experienced by other local businesses who are struggling to survive in the recession as the sex industry devastates efforts to regenerate the area by driving away the couple, professional and family trade. Very few members of the public want to dine or shop in the vicinity of a strip club, especially those with infant children – irrespective of the operational hours of the applicant in question.

It is therefore submitted that efforts to maintain the area as a safe, welcoming and respectable area that attracts a broader segment of the retail market will be severely inhibited by the presence of the applicant operating as a strip club. In order to achieve the economic and social prosperity which the local area needs, the public image of the region would be improved by refusing the applicant an SEV licence.


A sex establishment in this location will increase the risk of crime and anti-social behaviour in the town centre and destroy the pleasant ambiance and utility of the town centre.

I have read with interest the notice in the window of 4 Church Street, Ampthill concerning the application to the licensing authority for a Sex Entertainment venue.

I would like to formally lodge my objection against the application for this license to be granted.

I understand when a Sexual Venue permit was issued for a similar establishment the Police figures quoted showed there were 69 reported sex crimes within a mile radius of the club between the dates Jan 2010 - Feb 2012. These attacks included 15 cases of indecent exposure and six "other" sexual offences. Five of the rapes and 16 sexual assaults were committed within half a mile.

I certainly would not feel safe or welcome in the vicinity of this venue. It would certainly exclude me from socialising at night in this location, which I currently do on a regular basis to support the local businesses in the town.

The location of this venue would, in my opinion, also fuel anti-social behaviour and unacceptable levels of noise.

The venue is also near to homes, nurseries, schools, playgrounds, parks and places of worship. More specifically it is close to St Andrews church in addition to the Methodist and Baptist churches.


Alameda Middle School and The Firs Lower School are also close by as is Russell Lower School, and, Ampthill Park, used by children of all ages, is also very close to the proposed venue. In addition, there is a children's toy shop – 'Fairies and Frogs', which has recently opened directly opposite the proposed venue

Location:

The location for such an establishment would not be suitable as it is the centre of the town, the market place and the main focus, such establishments should be on the outskirts of towns.

The Market Place is the main focus for community events, some involving children for eg turning the christmas tree lights, the fair etc with such an establishment in the background would not be suitable.

Premises used by children under 16:

Ampthill is a family oriented town, a childrens toy shop (Frogs & Fairies) are due to take over premises adjacent to the proposed establishment in Church St.

There is a childrens dance studio in Kings Arms Yard opposite the proposed establishment.

Children regularly use the public seating area outside the proposed establishment.

We would like to formally register our objection to the above application.

Ampthill is a small historical market town. The centre of which is a conservation area comprising narrow streets flanked by historical buildings and contains a substantial amount of residential properties populated by young families and elderly people.

The proposed premises for this sex establishment is set in the heart of Ampthill and it would have a significant detrimental effect on the town and would completely undermine its historical and cultural heritage and its family based community spirit and values. For example, many community events such as the Christmas Lights Switch On and the Christmas Carols event take place right in front of the proposed premises.

We find it impossible to believe that such an establishment would serve the needs of the community within which it is set. The opposite would be the case. It would attract undesirable people into the heart of the town, making life extremely intimidating for the people who actually live here. In turn, this would have a seriously detrimental effect on other businesses in Ampthill already struggling in hard economic times as people avoid the area.

It will further exacerbate problems with unruly behaviour in central Ampthill late at night. This is already a problem due to alcohol / late licensing at local pubs. Furthermore, there is no designated taxi rank in the centre of Ampthill and the narrow streets of the town are already clogged up with taxis parking illegally on Friday and Saturday nights. This establishment would intensify the problem.

We note that a similar license was recently turned down in Bedford and Bedford is a much bigger town. Accordingly, it would be incredulous for such a license to be granted for a premises in a much smaller, quieter town such as Ampthill.

Finally, many other successful businesses, which would serve the community of Ampthill, could easily operate from the proposed premises. Indeed, we are aware that other local businesses have been interested in the premises. Accordingly, refusing this license would not inhibit the applicant running an alternative business.

As a resident of Ampthill for over 40 years I strongly object to the application for a licence for a sex establishment, made by Lord John Shayler, for 4 Church Street Ampthill.

Ampthill is a historic Georgian market town, in a rural area, which offers a wealth of conservation areas and listed buildings. In Church street alone (which is one of the

conservation areas) there are 29 listed buildings including no 6, being the property next door to the property for which the application is made.

No 4 Church Street is a focal point in the town being that it stands in a central position on our small town square. The square is also a place where the youngsters congregate, without trouble, especially on a summers evening. There are already seven licensed premises in the immediate area as well as two licensed retailers and there are three churches within a short walking distance.

The area around Church Street is residential as most of the shops have living accommodation. The lives of the residents are already affected by the current social environment surrounding them and the opening of a club in their midst, would only be additional pressure. Plus, should they wish to sell, the likelihood is that their property would be devalued with a club on the doorstep.

Finally I fear that the club would attract an unsavour element and unseemly behaviour to the centre of the town. It would be totally inappropriate in the centre of any small, rural, historic town.

If Lord John Shayler, who as quoted in the paper does not want to open the club for the people of Ampthill but for himself, then perhaps he would be better served opening it nearer to where he lives in Woburn

Objection to Sex Entertainment Premises Licence

Central Beds Council Licensing Application: Shaylers - 4 Church Street - Sex Establishment Premises Licence - registered 15/06/2012.

I am writing to object to the granting of a 'Sex Entertainment Premises Licence' at Shaylers, 4 Church Street, Ampthill, on the following grounds:

Fear of crime, anti-social behaviour, noise pollution and other disturbance to residents.

I moved to Ampthill twenty-four years ago with my family to escape the crime and anti-social behaviour in Luton. I have had first hand experience of living in, a 'red light area', in Brook Street, Luton from 1981 – 1984. I was bitten and indecently assaulted in Moor Park, Luton at 7pm on a May evening in 1981 and I was constantly harassed by 'kerb crawlers' on my way to and from work during the evenings.

Although these men had not been drinking alcohol they were a persistent and frightening nuisance. What sort of state of sexual arousement are clients of the sex club going to be in when leaving the club, possibly compounded with the affects of alcohol? As brothels are not legal, then where will the sexual outlet be? The rules of the club will not extend to the streets. I am not suggesting that all clients are potential sex offenders but one or two will be and it is from this minority that we must protect our community. Ampthill would become a popular venue for 'lads nights out' fuelled by alcohol and the inevitable violence and possibility of sexually motivated crimes. Do the police have the resources to deal with large scale public disorder, which we so often see on police orientated documentaries? Having had experience of policing Ampthill, I think not.

I enjoy walking alone during the evenings in Ampthill and meetings friends in the town for meals and drinks. I feel safe. If the licence were to be granted I would no longer feel safe and would not feel able to walk unaccompanied anymore. I have a right to feel safe and be safe in my home town.

For years local youngsters have frequented Ampthill Park for under-age drinking sessions and they always will. The police can't stop this behaviour and the youth of Ampthill are not 'street-wise'. The park is a short walking distance from the town centre and has an ample car park. Isolated, drunken, vulnerable teenagers could potentially make an ideal victim.

I believe that there is a genuine concern for the safety of females to be unaccompanied in the town, particularly during the proposed opening hours and subsequent closing hours of the sex club. For example, the rear car parking area to the club, National Westminster's car park, The Oxlip, Kings Arms Path and other secluded alley ways around the town are potential areas for victims to be attacked. As a retired police officer having served in Luton and Ampthill, I am fully aware of the devastating effect of violent and sexual crime on victims and their families and the fear it causes within the community.

If the licence were granted, then there will of course be the novelty factor from younger members of the community hanging around the market square 'to see what's going on and who's going in'. I anticipate that this will increase the anti-social behaviour, noise pollution and other disturbance in the area for residents in the immediate area.

Schools, nurseries or any other premise substantially used by or for children under 16 years of age.

The market square where the proposed sex club may be located is in the heart of Ampthill. It is a beautiful square which is the focal point for the town. Its picturesque scenes can be seen on calendars, Christmas cards and promotions for Ampthill. Do the residents really want a sex club to become the focal point in future pictures? Not to mention that the annual 'Ampthill Christmas Lights Switch On' would have the back drop of a sex establishment!

The establishment would be located directly opposite a children's toy shop, 'Frogs 'n Fairies', the chemist, the post office and a café. All of these premises are frequented by children under the age of sixteen years. This age group also visit other businesses in close proximity to the square, such as the bakers, hairdressers, the dance studio, the music studio, the card and wool shop, opticians, cafes and the local markets.

Finally, the applicant, John Shaylor, has been quoted as saying,

"The purpose of me doing this is not to upset the people of Ampthill. The purpose of me doing this to have a commercial building that we own, to be put back to use. It costs me money by being closed. I'm not doing it for the Ampthill people, I'm doing it for me. I need to make that building earn money".

It has upset people and Mr Shaylor certainly has no consideration for the people of Ampthill. If he cannot find a reasonable use for his property then he should rent it out to someone who can.



RE:- Application for a Sex Entertainment Venue licence at Shaylers, 4 Church Street, Ampthill.

Having noted the above application, and your Statement of Licensing Policy effective from 13th April 2011, I make the following representations in respect of the implications of the application for certain key matters of policy. For the avoidance of doubt, this is an objection to the granting of such a licence to what I believe to be wholly inappropriate premises for the reasons stated, and is made not as a consequence of 'NIMBY ism'.

Residential areas

The applicant premises are directly opposite flats above Church Street, and are within a 100 metre radius of a large number of residential properties (both flats and houses) along Church Street, Bedford Street, Park Street, Woburn Street, and Dunstable Street. Residents of those properties would be unable to evade the public presence of such a venue; its advertising; and its patrons.

Premises used substantially by or for children under 16 years of age

The applicant premises are directly opposite a retail store which is shortly to be occupied by the popular "Fairies and Frogs" toy shop which is relocating from Dunstable Street. It would be deeply invidious for families and children to have to face such an establishment upon exiting a toy shop.

Churches of other places of religious worship

The applicant premises are within 250 meters of both St. Andrew's Church and Ampthill Methodist Church. It is likely that the overwhelming majority of members of those worshipping communities would find the proximity of commercial sexual entertainments disturbing, and would object on moral grounds to the objectification of the human form for the purpose of patrons' sexual gratification.

Community buildings

The applicant premises are within 50 metres of the public toilets owned and operated by Ampthill Town Council. Even if those toilets are locked at night, the potential implications and alarm which might be caused to users of those toilets by a sex establishment in such exceptionally close proximity speaks for itself.

"Gateway" location

The premises are at a crossroads through which virtually all traffic (both vehicular and pedestrian) must pass in order to access locations on the opposite side of the town. Many people have no viable alternative route, and this would include, by way of an example, women returning late at night to properties on the eastern side of the town from Flitwick Rail Station. Such people may well be distressed at having no choice but to pass such a venue in these circumstances.

For these reasons, I submit to the Council that the application should be refused.

This representation submits objections to the applicant being granted a Sexual Entertainment Venue (SEV) licence on the following grounds:

(a) Proximity to a residential area

"Shaylers" position on Market Square is located in very close proximity to residential accommodation adjacent and opposite the proposed strip club.

It is clear that a strip club sited in such close proximity to a residential area is neither acceptable nor appropriate, because of the potential fear of crime, anti-social behaviour, noise pollution and disturbance to residents and is incongruent with current Central Beds policy.

Such reasons reflect concerns raised by key stakeholders in consultations which led to the subsequent reform of licensing law governing the sex industry vis-à-vis strip clubs. Other reasons included the heightened statistical link to physical, verbal and sexual assaults against women who live or work in the vicinity of strip clubs.

Many of the towns 5,000 residents will be reluctant to walk through the centre of their own community for fear of suffering such abuse, as this application is made for premises at its heart in its small Market Square.


(b) Character of the relevant locality

Central Beds policy also provides that SEV licences shall be considered with respect to the character of the relevant locality.


Ampthill is a market town with a long history, but it is struggling in the current economic climate with several local businesses closing down. The opening of a local strip club will counteract the efforts of hardworking local business people by tarnishing the area with a sleazy image, explicitly associated with prostitution, violent/sexual crime and anti-social behaviour.

The negative economic impact of operators such as the applicant will be acutely experienced by other local businesses who are struggling to survive in the recession as the sex industry devastates efforts to regenerate the area by driving away the couple, professional and family trade. Very few members of the public want to dine or shop in the vicinity of a strip club, especially those with infant children – irrespective of the operational hours of the applicant in question.

It is therefore submitted that efforts to maintain the area as a safe, welcoming and respectable area that attracts a broader segment of the retail market will be severely inhibited by the presence of the applicant operating as a strip club. In order to achieve the economic and social prosperity which the local area needs, the public image of the region would be improved by refusing the applicant an SEV licence.

I am sending you this letter, so that I can formally register my objection to the above application. I do so for the following reasons:

- 1. Ampthill's town centre is one of the most iconic and significant areas of the town. It is often used in tourism literature to advertise the town as an interesting and historic place to visit. It is the most visible part of Ampthill where roads intersect, meaning that those passing the town see it as the 'shop window' of the town's character. The presence a sex establishment is very much at odds with the ethos of Ampthill which is a family-centric community with a rich history and cultural heritage.
- 2. Such an establishment would deter not only locals but certainly visitors from spending time (and money) in the town. Centre Parcs will be opening close to Ampthill and could potentially be a great boost to local business. Staples Garden Centre and the local Tesco in Flitwick have already begun refurbishments to prepare for the expected increase in visitors. A sex establishment in Ampthill could seriously affect the towns potential to attract the many thousands of holidaymakers that will visit Center Parcs each year.
- 3. Ampthill business is struggling as it is. Various shops are having to close down through lack of visitors. Again, the Centre Parcs venture may do a great deal to help revive that. However, there are still other businesses that are doing well, particularly the local coffee shops. The presence of a sex establishment might make visitors think twice about visiting, especially as many who use these places are with young families. Another vital feature of Ampthill is it's many restaurants. These are used most often in the evening when the Sex Establishment would be open. So visitors and locals may choose to shop and eat elsewhere, particularly if they are with children. It's

also worth pointing out that 'Faerie's & Frogs' a traditional children's toy shop is directly opposite the proposed site.

- 4. The town centre has long been used by the local churches and other community groups for events. Such as the annual Easter service, town carol singing and switching on of lights. Should the application go ahead, these events would be taking place on the very doorstep of a sex club.
- 5. This area of the town is used regularly by children. (Young families make up a sizeable amount of the footfall each day). This sex establishment would be at the very the focal point of the community. The club would be open at times when children would be using the area.
- There has already been problems with anti-social behaviour in central Ampthill late at night. The presence of this club could potentially make matters worse.
- 7. Ampthill is known as a friendly and safe community. The presence of a sex establishment in the very centre of town will create an uncomfortable and possibly threatening environment. This is perhaps the most important objection of all. In particular, women and young girls may find the town centre to be a no-go area at certain times of the day, though men also might feel concerned too. Also, workers in these establishments are often vulnerable and exploited. Recent newspaper articles about rape and indecent assault increasing in the vicinity of sex clubs must be taken into account.*1

"Every woman in our society feels the fear of rape - no woman is allowed to ignore it...The threat of violence is a total intrusion into women's personal space and transforms a routine and/or potential pleasurable activity (for example, a walk or journey)... into a potentially upsetting, disturbing and often threatening experience." Rape Crisis, England & Wales²

- Such a club will effect the value and future saleability of the surrounding properties.
- Granting consent for this establishment to go ahead will set a precedent for similar applications, which could further damage the towns reputation and attractiveness to vistors, house buyers and businesses.
- 10. Advertising for this establishment, including signage and frontages of premises and leaflet distribution in the area, will create an intimidating atmosphere and a real threat to the safety of women.
- 11. It is understood that moral issues are not recognised in these cases. However, from a purely practical point of view, if this application is approved it rather suggests to men, women, children and teenagers, that the town council

condones and promotes the sexual objectification of young women. Particularly when it is in such a high profile part of the town.

The Equalities Act 2010 states that

"A public authority must, in the exercise of its functions, have due regard to the need to ... eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act." 3

I hope that these objections will be given full and proper consideration. I also understand that my identity will not be passed to the applicant unless my permission is given.

Please note that I object to the granting of a licence to Shaylers, 4 Church Street, Ampthill, MK45 2EH for a Sex Entertainment Licence on the following grounds:

- 1) Close to residences Ampthill, by its very nature, has homes very close to the town centre. There is no distinction between residential, commercial and retail zones in fact. The proposed location is within just a few yards of homes with families, and small children will have no option but to be faced with the premises. Parents consequently will have to explain their use.
- 2) Identifiable locality This location for this type of establishment is completely inappropriate, right in the middle of town where it will dominate the street scene in the paved area around Richardson's. 

The location of the premises is completely unsuitable as this property is right in the heart of the village. Residents of all ages many of which certainly being elderly and vulnerable live within an immediate vicinity, to which this would be of grave concern as to the undesirable effect on the community which I would certainly echo.

Furthermore, as this is located right on the main concourse/centre of Ampthill, even in the daytime this would be intimidating for local residents and to the numerous visitors to the area who come to take in its history, heritage and architecture. Market stalls and community activities for the area are regularly based on the pavement immediately outside of this property along with a bench where local residents young and old regularly like to spend time which would be no longer desirable. The application for a license for 'sex entertainment' at the former Shaylers restaurant site in the middle of Ampthill has come to our attention as local residents.

We would like to strongly lodge our objections on the following grounds:

- the proximity to the venue of other late-license venues which already necessitates a high police presence in Ampthill at the weekends
- the density of residential accommodation in central Ampthill the majority of which are family residences

- the proximity to the venue of parks, community halls and churches which are well used, not just in the daytime, by local residents

In your consideration of this application, I would also draw your attention to the following points which are clearly of grave concern to local residents and which are substantiated by research:

- the introduction of lap dancing clubs creates a dangerous environment for women. Research has shown an increase of sexual assaults on women of up to 50% following the introduction of lap dancing clubs in an area (Eden, I. 2003)
- lap dancing clubs are linked to a wider system of prostitution. The presence of strip clubs in a locality has been shown to increase demand for nearby prostitution services. (Coy, M, Horvarth, M & Kelly L 2007)

Ed Milliband has lent his support to the belief that lap dancing clubs are linked to crime in his September 2010 response to the 'End Violence Against Women Coalition'.

Given these points, I am interested in the reasons why you are not setting a 'nil limit' on how many sexual entertainment venues can be licensed in areas such as Ampthill, as is your prerogative as a council under the Policing and Crime Act 2009?


Ampthill has a large number of families and a lot of children in the town would be walking past the club


tragic circumstances of the murder of Megan Leigh Peat recently.

I note the recent application for the premises in the centre of Ampthill, Shaylers, to be licensed as a sex establishment.

I would like to register my very strong objection to such an application. Ampthill is an historic Georgian market town and these premises are right in the heart of the old town, opposite the Georgian coaching inn. To have such an establishment in this position would I feel be most inappropriate for the ambiance of the town.

In the last few years, a great deal of money and effort has been spent in tidying up the town centre, installing new street furniture including benches, so that is is a pleasant and safe meeting place for all Ampthill residents. I believe that parents with young children would no longer wish to meet there.

In addition, I would like to highlight the fact that the centre of Ampthill is a residential area, with flats over the retail premises opposite the proposed site and also, just round the corner above the new retail premises. I suspect that the noise of people entering and leaving the premises late at night, particularly at weekends, would be most disruptive.

Finally, I would like to question the car parking arrangements for users of the sex establishment if the licence is granted. The only car park nearby is the one attached to the Waitrose supermarket. Although I accept that it is usual for Waitrose to close before the proposed establishment is open, this is not the case at festival times such as Christmas and New Year, when Waitrose have extended opening hours. As this time of year is likely to coincide with increased activity in the establishment for Christmas parties and the like, the result is likely to be somewhat chaotic. Parking elsewhere in the centre of Ampthill is not an option.

I reiterate my strong objection to this application.



I am writing to express my utmost objection to the application for a sex entertainment venue on the market square in Ampthill - address 4 Church Street, applicant John Shayler. I am not against these establishments per se but am of the opinion that they should be discretely sited away from residential areas. In this case, it is clearly an entirely inappropriate use of these premises.

My objection has three key facets.

This is a highly-visible and central location in a small market town. I understand that a person describing himself as "Lord John Shayler" has applied for a licence to operate a sex establishment at 4 Church Street Ampthill. According to your notice, he wishes to open until after midnight 6 nights per week. The purpose of this letter is to inform you that I object to the application.

Ampthill is a small market town, not an entertainment centre. The centre of the town is full of residents, many of them families with young children (I myself have two children aged 9 and 10). I suggest that the patrons of a late night sex establishments are unlikely to be the sort of people who will take care to come and go quietly, without disturbing the residents (my house is about 100 yards from 4 Church St). I have no doubt that the patrons of the business envisaged would contribute noise and general nuisance to the town centre late at night, when people who work for a living, in my case frequently seven days a week, and children who have to get up for school, need to sleep. Nor is the nature of the business of a sex establishment suitable for the centre of a residential area. For example, my own two children walk past 4 Church St every morning on their way to the bus stop. Would you want your children walking past a sex club on their way to school every morning, or at weekends on their way to buy something from the shops with their pocket money?

No doubt there is a place for late-night sex establishments, but it would be difficult to imagine a less suitable one than the middle of Ampthill. If the applicant wants to open a late night sex establishment, he should do it in some place such as an industrial estate where the activities of his customers will not cause problems for others who just want to get on with their lives without being confronted by the sex industry every time they step outside the front door.

I object to the establishment of the Sex Establishment Premises Licence proposed for 4 Church Street Ampthill. This would be totally out of character for Ampthill and would present dangers for local adults and children alike due to the unsavoury and potentially criminal element of society that would be attracted there. I would say that the council's own stated possible reasons for not allowing the proposed licence would <u>all</u> apply, namely:

- "....the council will consider the characteristics of a locality and shall particularly take account of the density and proximity of;
- Residential areas
- Schools, nurseries or any other premise substantially used by or for children under 16 years of age
- Parks or other recreational areas used by or for children under 16 years of age
- Churches or other places of religious worship
- Community buildings
- Gateways to an identifiable locality
- Alcohol or entertainment licensed premises "

The centre of Ampthill consists of all these types of area. The Pump area is used by children under 16 in the evenings and at weekends, for sitting on the chairs and skateboarding. Families gather there for many different reasons.

I am a secondary school teacher and father of three. We have lived here since 1987. As such, I care about the children of Ampthill and their safety above all other considerations mentioned. I object to this crazy proposal in the strongest possible terms.

- Whilst the council have not imposed a limit on the number of premises that may be licensed in an area, and
 whilst treating each application upon its own merits, the council will consider the characteristics of a locality and
 shall particularly take account of the density, and proximity of;
- Residential areas this building is at the very centre of the town through which everyone passes on their way to shoool, nursery, church, shops. It is hub and focal point of the town for all residents. There are shops and houses/flats adjacent and across the road, and the car park for everyone shopping is immediately behind. Ampthill is primarily a residential area.
- Schools, nurseries or any other premise substantially used by or for children under 16 years of age it is less than 100yds from childrens' toy shop, childrens' clothes shop, childrens' dance centre, childrens' art and craft school, childrens' gift shop, and two toddler group venues. Because the market square is at the core of Ampthill with 4 roads running from it everybody passes the applicant's building continuously, toddlers, pre-teen ballet dancers, teenagers walking to and from school, children going to brownies, scouts, guides, everybody. Cars park in the Waitrose car park to the rear of the building and children cross the road right in front of the building to go to dance classes, or art classes. There are regular school walking geography and history trips to and through the market square because of the history and architecture.
- Parks or other recreational areas used by or for children under 16 years of age as everything community based in Ampthill is within a 5 minute walk of the market place (where the building application is located) this means it is minutes away from Ampthill Park, 3 churches, 6 pubs, a night club, a social centre, elderly person sheltered housing, the Leonard Cheshire home, a community hall, 3 schools, 3 nurseries, 2 toddler group centres and the market square itself is a congregation/meeting area for many young teenagers between 12 16 before they go to the park, right outside the front door of the applicant's building. Many people meet on the square as it the natural centre and gateway to everywhere else in Ampthill.
- Churches or other places of religious worship there are 3 churches within minutes walk and the market square is used throughout the year for Easter processions of church/schools, rememberence services, carol services, civic services, christmas tree light festival and fair. All these take place outside the front door of this building.
- Community buildings within yards, apart from the above, there are 3 tea shops, the Rotary club, the Wingfield club, the dance studio, the music workshop, parkside hall community centre, the TA meeting centre, the football club, the rugby club and the cricket club, the citizens advice bureau, the police station, the council offices.
- Gateways to an identifiable locality already mentioned. Ampthill is also on the Greensand Ridge walkway so many walkers use the market square as a gateway for this walk. The carpark that the whole community uses is accessed next to the building in question.
- Alcohol or entertainment licensed premises apart from the number of pubs and restaurants minutes and yards away, there is considerable policing and patroling of the White Heart night club, across the road, which brings its own challenges to the community, and makes it very awkward to walk through Ampthill in the late evening because of anti social and threatening behaviour, and as a woman I especially feel very vulnerable.

Ampthill is a small residential community and many families move here because of this. One of the great benefits and pleasures of this it that you feel you can let your children get out and about on their own, there is a strong sense that everything is within a 5 minute radius and there is a familiar face around. This is very reassuring for parents in this day and age and the children thrive. The first thing they want to do when they are old enough is to meet up with their friends in the market square, then go to the park, then back to Waitrose, then back to the market square to say goodbye to each other. It is their 'gateway' and almost a right of passege for them.

Whilst the council does not recognise moral issues in these cases, allowing this application to be approved will send a clear message to the young people of Ampthill that sexual exploitation of women is something that the town council condones and promotes.

I would like to formally register my objection to the above application on the following grounds:

- There are already a number of licensed premises in the immediate vicinity of these premises, notably The White Hart Hotel, with a regular late licence, and the latter causes significant disruption in the town centre as it is.
- An additional premises with a late licence will render the town centre a no-go zone to many Ampthill residents, in particular women and girls, and encourage more anti-social behaviour, increasing policing requirements.
- The area immediately outside the premises is used regularly for family based community events, for example carol singing around the Christmas tree, Aragon Day events, market stalls, Gala Day processions, etc. An SEV operating in the proposed premises will convey an entirely inappropriate message to all the families with children of all ages attending such events, if, indeed, they continue to be organised.
- It is located at the very the focal point of the community, in a prominent and attractive building, in close proximity to areas used continuously by children e.g. on the way to school, to bus stops and churches, to use local amenities such as dancing schools, toy and sweet shops and cafes and to gather in communal areas in the centre of town.
- It is in close proximity to many residential properties where young children reside.

- A sexual entertainment venue is totally inappropriate in the context of the town's historical and cultural heritage.
- It will have a negative effect on other businesses in Ampthill (already struggling in hard economic times) as people avoid the area.
- Finally, allowing this application to be approved will send a clear message to the young women and girls of Ampthill that sexual exploitation of women is something that the council condones and promotes. In addition, an equally clear message will be sent to the boys and men of Ampthill that sexual objectification of women is not only acceptable but desirable. As a parent trying to raise my children (3 girls) to have healthy and respectful relationships, an establishment of this type in a visible and 'approved' position will totally undermine my best efforts.

I trust these objections will be given full and proper consideration. I also understand that my identity will not be passed to the applicant unless my permission is given.

I have read the notice in the window of 4 Church Street, Ampthill concerning the application to the licensing authority for a Sex Entertainment venue.

I would like to formally lodge my objection against the application for this licence to be granted.

These are based on a number of concerns about the impact of a sex entertainment venue on Ampthill.

- Commercial impact- Many of the town's small businesses and shops are clustered in the centre of Ampthill and the sex establishment would be situated in the middle of these. This would make it even harder for some of those businesses to attract customers and visitors and likely to impact on their revenue. E.g. there is a children's toy shop; a quaint cafe opposite and a jeweller adjacent. It will also make it more challenging for other landlords to rent out the remaining empty shops of which Ampthill has quite a few, unless Ampthill becomes a centre for other sex entertainment venues/shops etc
- Impact on Tourism- The proposed establishment seems out of kilter with local and general plans for the area. Ampthill is marketed as a historic market town which is currently trying to increase its commercial success as a tourist and commercial destination. The future links, for example, with the local Centerparcs and BMK Waterway are two projects which are very much seen to be part of Ampthill's sustainability as a tourist destination town. In addition, the current work and focus on the environment and historical importance of Ampthill Great Park is at odds with such an establishment. At least five of the premises currently providing food and drink for tourists and locals alike are in a direct line of sight or close to the proposed sex establishment.
- Impact on the conservation area- The proposed venue, which I understand is leased, is a listed building, and at the heart of the Georgian centre of the town. Most of the buildings in the centre and the adjacent roads are listed or in designated conservation area. The visual impact of having blacked out windows (or similar) as part of the town environment would stand out and be difficult to accommodate under current listed building regulations which dictate the appearance of external features such as signage, colours etc
- Impact on residents- My young family and I live very close (within 500 yards) to this proposed venue, as do many others, and suffer on a regular basis from the noise, disturbance and vandalism caused by the customers of the many licenced premises already in the town. There has been a huge effort by the police and other agencies to work with the licence holders to ensure that the impact of alcohol related crime and poor behaviour in Ampthill is reduced. With an establishment of this nature there will be a potential for an increase in crime and anti-social behaviour, noise pollution and of course disturbance to residents. The proposed venue is right in the middle of a number of residential properties, Churches, youth groups, playschools and schools and

the seats next to it are often populated by residents, including local teenagers as a convenient and safe place to meet and chat with friends. My own children walk past it each day on their way to school and as a parent I really don't want to explain to my kids the activities that go on behind closed doors or blacked out windows; they can read signs and notices and it's not something a young child should be ideally concerned or curious about.

• Impact on safety and crime figures - As a parent, one of the many concerns about this type of establishment, is the safety of children when in the vicinity of this venue and the impact on them of knowing that the sexual objectification of men and women is tolerated and accepted by those living and working close to them. I believe that we all have a duty of care in this respect. Sex entertainment is not legitimate topic in the workplace or schools, and I would press Central Bedfordshire to explore all avenues to stop this establishment from opening anywhere where they have jurisdiction. Recent evidence from other towns of the impact of such establishments e.g. Henley-on- Thames indicates that such venues do lead to an increase in crime, and particularly sex crimes e.g. rape and prostitution. Ampthill already has a large number of drink-related crimes, including a recent murder, and I feel this would add to the burden of the local policing authorities in an unacceptable and totally avoidable way.

Finally, the proprietor of the proposed sex establishment has mentioned in the press that wants to bring Disney fantasy to Ampthill. I am unclear why he believes that a lap dancing club would deliver this fantasy or that his market research shows that the people living in and visiting Ampthill would use it on this basis. If that means, by implication, that he will be using images that are normally associated with children in his entertainment or promotional materials, then I am gravely worried.

I appreciate that the proprietor would like a commercially viable business and I understand he has previously run it as an antique shop and a coffee shop. There may be more money in operating sex establishments but both the former types of business are operating currently in Ampthill and appear to be doing well in a recession.

I believe that the risks of bringing lap dancing to Ampthill would indeed to be too high for the town and residents for all the reasons outlined above and I strongly object to this application.



I would like to register my objection to Shaylers' application to become a lap dancing club. The premises occupy a unique and eye-cathcing setting in the very centre of Ampthill, which prides itself on being a Georgian market town. A lap dancing club would ridicule the town's heritage and its family based values. It also lies very close to the Anglian, Methodist and Baptist churches.

e-ices.

Ampthill's unique selling point is that is is a quaint market town. Retailers have been attracted to the town as a result and this would deter other retailers from setting up in Ampthill at a time when a number of retail premises lie empty.

The premises are in close proximity to family residential properties. Lap dancing clubs are demeaning to women and send the wrong message to teenagers of both sexes.

There is already a problem with drunkeness in Ampthill town centre late at night. I live on Dunstable Street and there are often fights outside my house and vomit outside it once or twice a month. Central Beds policing costs must be increased hugely by the need to have such a high police presence in the area on Friday and Saturday nights. A lapdancing club would attract more undesirable drunken behaviour and increase the burden on tax payers.

Disturbance

The proposed venue is very close to residential properties, on Church St., Park St. and Woburn St. There are no other premises open at the times applied for and noise and potential anti-social behaviour that could ensue at the 'chucking out' time of 1:30am is not appropriate for a residential area.


Fear of crime


The majority of the residents of Ampthill are either young families or older people. This venue is not being marketed at them and so will be attracting customers from outside the area. There is no public transport in the evenings in Ampthill and no local taxi company. There is very real danger of drink driving or groups of people who have been drinking hanging round late at night waiting for taxis from Flitwick. I understand a venue of this sort opened in Henley, but was promptly closed due to the increase in crime.

Not in keeping with local area

Ampthill is a picturesque Georgian market town with many listed buildings. I don't think it is possible to design any signage for an establishment of this sort that would be discrete and tasteful enough to be in keeping with the town centre of Ampthill. Its location opposite a toy shop and close schools and nurseries makes it even less appropriate.

I am writing to voice my concerns about the application for a sex entertainment venue on Church Street in Ampthill

As a resident of , I feel we already have enough publicly licensed premises available for people; The Whitfield Club, The White Hart, The Cellar Bar and The Old Magistrates Court. We already suffer from late night disturbances from the other clubs and pubs on Church Street and another one that is open until past midnight every night during the week will merely add to these disturbances and bring an unwanted element into the area. The venue is open so late at night that I feel it also heightens the possibility of crime in the centre of Ampthill.

There is a child's ballet school opposite the proposed location, a church on the same road and a child's toy shop over the road – do we want children to have to walk past this venue in order to get to their activities? It also opposite the main walkway to a local pre-school (Ladybirds) and a local Lower School (Russell Lower)

I would also like to add that Church Street is also a residential area. I have a 3 yr old daughter. I do not wish to have to walk her past such an establishment every day when we go to her Pre-school or to the shops, or to her ballet lessons and neither do we need further disruption in the evenings. People exiting The Magistrates Court after a party, or the Whitfield Club and The White Hart/Cellar Bar at closing time, already wake my child up late at night. We do not need the number of drunk people walking past our house increasing. On numerous occasions in the past I have already had to make reports to the local police about anti-social behavior, such as drinking in a non-drinking zone, flashing in front of my house, broken bottles, urination, and drunkards walking in the middle of the road causing traffic problems. Last time we had roadworks on Church Street there were several occasions where drunken people leaving the already established licensed properties on Church Street found it hilarious to completely block Church Street off with the traffic cones and barriers - it was us residents who went out and remedied the disturbance each time. We do not need more of this behavior.

Application for sex establishment - Shaylers Ampthill

We write to express our objections in relation to the above application. We are residents of Maulden and use Ampthill on a weekly basis to shop and frequent restaurants and other facilities.

It may be that the application is meant to drum up publicity and trade for Mr Shayler's other establishments rather than being entirely serious. Although we have no moral objections at all to 'sex establishments' such as lap dancing clubs in principle, we do not believe that the proposed site in Ampthill is the right place for many reasons.

Firstly, as a general point, Ampthill has a distinct identity as a Georgian market town and siting a lap dancing club right in the centre is plainly out of keeping with the character of the locality and could be damaging to its attempts to promote that Georgian heritage, for example in attracting greater footfall with the opening of the nearby Center Parcs.

More specifically, however, the site of the proposed premises is totally inappropriate for other reasons. The centre of Ampthill is, perhaps unusually, still a highly residential area occupied by a varied cross section of residents including families.

It already has many venues which are principally for drinking, including the White Hart which has a late licence and unfortunately already attracts many complaints about late night nuisance and anti-social behaviour.

Perhaps the most important point about the proposed site is that it could not be more central or conspicuous, right on the town square and opposite a toy shop and gift shop. This is an area which not only has a very high footfall of people of all kinds and ages passing by as

Page 151 they shop and go about their daily business, but also has benches for people to sit and enjoy the town. The benches are, more often than not, occupied by small groups of younger people enjoying the company of their friends.

As the prime spot in the whole of Ampthill, which should be available for enjoyment by the community as a whole, it is clearly the wrong place for a business of this type.

Finally, we would make the point in passing that the application form states that the premises should not have adverts and notices visible to the exterior. These premises have a notice in the window advertising for lap dancers which already appears to be flouting the letter and spirit of the rules.

I am writing to you to express my strong disapproval of the application made by "Lord" John Shayler to open a sex entertainment venue in Ampthill.

The property that "Lord" John Shayler occupies is central to the market square and as such is right at the heart of Ampthill. For this to become a sex entertainment venue, however discreet, would transform the feel of the town centre.

The area directly in front of the proposed club has benches at which teenagers and children commonly meet and they should not be exposed to the sort of imagery that is likely to be used.

The property is directly opposite a toyshop called "Fairies and Frogs". This award winning shop is one of the fastest growing and most thriving businesses in Ampthill. It would certainly not be in their interests to have a sex entertainment venue opposite.

I am not against the idea in principle of this sort of venue coming to Ampthill, since I am sure that it could be run successfully and bring employment to the town. However the location in this case is the issue and as such should be enough to make the idea a non-starter.

In my time in the town "Lord" John Shayler has run an antique shop and a restaurant/tapas/coffe shop in the premises, both seemingly without success. When his most recent venture closed down the property was left in chaos inside and with all the blinds fully open, blighting the appearance market square with little apparent thought for the residents of the town. I feel that this is clear evidence of his lack of concern for the residents of the town or his impact on the business community. This unwillingness to be part of the community would make him very unlikely to operate in a discreet or tasteful way that would benefit all traders.

If he is true to his word as printed on the front page Bedford Today then maybe he really should offer the building to any one of the many business owners who are thriving in Ampthill.





And he (John Shayler) says he will give the building rent-free to anyone else who can come up with a viable business plan and can financially run the business themselves.



We would like to make the following representations regarding this application, having read Central Bedfordshire's Statement of Licensing Policy for Sex Establishments - particularly page 31 which gives grounds for refusal on 'the character of the relevant locality', or 'the use to which premises in the vicinity are put.'

The character of the relevant locality

Residential areas

- The applicant premises very near a large number of residential areas - most of the area within a 100 metre radius is residential.

In particular, many elderly residents have no choice but to use Cheeseman's pharmacy, and many of them would be extremely offended by having to walk by such an establishment.

Central Location

- The sex establishment would be in a place where people who needed to travel from one end of the town to the other would be forced to pass, whether they wanted to or not. How could we force people to pass by something which they might be distressed at seeing?
- Women returning home from Flitwick train station may be put under stress and suffer harassment by having to walk past a queue of people who are exiting, or queuing up to enter, this establishment. Patrons of sex establishments tend to be almost exclusively male and often under the influence of alcohol; this would make the likelihood of harassment even greater.

The use to which any premises in the vicinity are put;

Churches

- St. Andrew's Church and Ampthill Methodist Church are within 200 metres. A sex establishment so close to places of worship would be a gross affront to the sensibilities of religious members of our

community and their families.

Children's establishments

The proposed sex establishment is directly opposite a retail store which is shortly to be occupied
by the popular "Fairies and Frogs" toy shop which is relocating from Dunstable Street. It would
be difficult to imagine a more inappropriate location in the vicinity.

Establishments used by families and the elderly

 The location is very close to coffee shops, a charity shop, restaurants, and a pharmacy, all of which are constantly frequented by elderly members of our community as well as families with small children.

In addition, the following is relevant:

Traffic and Parking

- The opening of another late opening / closing establishment in the centre of Ampthill would put yet more pressure on an already congested traffic system.
- Parking in the centre of Ampthill is already very crowded; this would add immeasurably to the problem.

Noise Pollution

 The late night noise from such an establishment, as well as from its patrons exiting and making their way home, would be to the significant detriment of Ampthill inhabitants' wellbeing.

For these reasons, we would like the application to be refused.

Application for Sex Establishment Licence – 4 Church Street, Ampthill.

This Society objects to the application for grant of a Sex Establishment Licence in respect of 4 Church Street, Ampthill, for the reasons set out below.

- The location of 4 Church Street is on the small Market Square which is at the heart of Ampthill and its town centre shopping area. Seating is provided on the square and it is a social area where people, especially children and young people, gather.
- The premises are about 80 yards from the Maurice Kachuk School of Dancing which is situated in Kings Arms Yard opposite the Market Square. The school's pupils are mostly young children. In addition to those who arrive on foot many pupils arrive and depart by parent-driven cars which use the nearby Waitrose town centre car park situated immediately behind 4 Church Street. The pedestrian route from the car park to the school is via the market square and a pedestrian crossing close to 4 Church Street.
- The Market Square is the venue for community events including the annual Civic Christmas Carol Service, and the formal Switching on of Christmas Lights with attendance of "Santa Claus" and many children. These events are held in front of 4 Church Street.
- A popular market stall is frequently erected on the Market Square in front of 4 Church Square as are fund-raising, table-top sales in support of various charities.
- Ampthill already attracts large numbers of revellers at night especially at weekends. There is frequent late-night noise, rowdy behaviour, occasional criminal damage and assaults in the town centre. A sex establishment will attract even more late-night visitors thereby escalating these problems.
- 6 4 Church Street is in the centre of the Ampthill Conservation Area which is wholly inappropriate for premises of the type proposed.

- 7 The premises are close to private dwelling houses and residential apartments in Church Street and Bedford Street.
- 8 There are bus stops in Church Street near the Market Square.

We submit that all the above reasons make the location in question wholly unsuitable for the activities which are proposed by virtue of the grant of a Sex Establishment Licence and we urge the Council to refuse the application.

- Ampthill park and playground (again we would need to walk directly past the sex establishment to gain access to the community park and buildings)


- The location is in the main square, therefore is located in the gateway to an identifable locality, ie this establishment could become what Ampthill is known for.



I wish to register my objections to the Central Beds Council Licensing Application for Shaylers - 4 Church Street - Sex Establishment Premises License registered on 15/06/2012.

The grounds of my objections are as follows:

Shaylers is situated in a Residential Area

Not only is the centre of Ampthill the retail centre of the town, but a great many of the shops have flats above them. Indeed a number of them are directly opposite Shaylers, namely above Bows & Cheesemans. In addition Church Street is largely residential for its length.

Shaylers is situated near to Schools, nurseries or any other premise substantially used by or for children under 16 years of age

4 Bedford Street is possibly the most focal shop unit in the town as it is situated on the Market Square & during term times is regularly passed (on foot & by car) by children making their way to the 4 schools in the town, namely the Firs Lower School, Russell Lower School, Alameda Middle School and Redborne

Upper School. In addition parents will pass the premises with their under 5's as they make their way to Ampthill Children's Centre in the nearby Methodist Church, as well as other nurseries at Merry Poppets (Ampthill Football Club), Jack and Jill (Houghton Close) & Ladybird (Russell Lower School). Furthermore, the premises are opposite a toy shop (Fairy's n Frogs) and a children's dance studio in Kings Arms Yard (just off of Church Street).

Shaylers is situated near Parks or other recreational areas used by or for children under 16 years of age

Although not a designated recreational area the market square has been adopted as a place where youngsters meet & often stay late into the evening on the set of seats that are located on the square outside 4 Bedford Street. Indeed with no Skate Park in the town young skateboarders have also adopted the area as one that they use. In addition young people will also pass through the town centre and thus pass Shaylers to access facilities in Ampthiil Park.

Shaylers is situated near Churches or other places of religious worship

4 Bedford Street is also situated a short distance from St. Andrew's Church of England Church on Church Street and parishloners will pass the premises to go to church on a Sunday. Furthermore, along Dunstable Street nearby are Ampthill Methodist Church & Ampthill Baptist Church. Indeed some religious events take place on the Market Square during the year outside of Shaylers, namely Carols Around the Christmas Tree on the Monday evening before Christmas & the 2 Minutes Silence on Remembrance Day (both led by Rev. Trodden from St. Andrew's. Furthermore, the Remembrance Sunday parade will pass by Shaylers.

Shaylers is situated near Community buildings

The premises are close to a number of community buildings, namely the Masonic Rooms on Church Street (used for a variety of community functions), Parkside Hall (along Woburn Street) and the aforementioned Churches (that also serve as community venues for such events as evening concerts). As mentioned before the Market Square also serves as a venue for community events (2 minutes silence, Carols around the Christmas Tree etc)

Shaylers is situated at many Gateways to facilities in the town

As the premise's are at such a focal point in the town most residents will pass by them a number of times in the day whether going to work, going to the shops (in particular nearby Waitrose) or taking their children to school/pre-school. I'm sure no other community would have such an establishment in such a prominent position!

Shaylers would add to an excess of premises with Alcohol or entertainment licenses in the town centre

Residents have for many years raised concern over antisocial behavior that emanates from the existing licensed premises in the town centre. Indeed the nearby White Hart acts as a late night entertainment venue with it's Cellar Bar open to the early hours. There is a real possibility that antisocial behavior will only increase with another licensed entertainments venue in such close proximity. I'm sure the Police will have a view on this issue as this could lead to more police having to be deployed to the town over the weekend.

For the aforementioned reasons I object to a Sex Establishments License being granted for 4 Church Street.

In addition I presume that Mr Shayler will also have to apply to the Planning Department for 'change of use' with regards the premise's, which I would also object to.

I hope you take my concerns into account in determining this application.

I would like to voice my concern about the above application. I have enjoyed living in Ampthill for the last 26 years and have found it to be a quiet, mainly law abiding, pleasant community. Residents enjoy the beautiful old buildings, especially those around the market square where many of the town's activities take place. The market square is also where people enjoy sitting on the benches and is a place where young people can congregate in the evenings.

The idea of a lap dancing club to be located in such a place is totally unacceptable and completely inappropriate for a small market town. Having spoken to a number of residents the main reason we all live here is because of its quiet nature and an establishment like this would change that completely.

The area is residential as well as commercial having the main shops such as the post office, café, bakers, bank, toy shop and chemist all in close proximity to the premises for the proposed club. There is also a public house very close by and an establishment of this nature would cause disturbances for residents late at night with clientele coming out of the public house and then possibly going to the lapdancing club. Also vacating the club at 1.30am will cause disturbance to residents.

Historically, when premises have been granted late opening hours in Ampthill it has caused a lot of

problems resulting in the premises being closed down because of the trouble caused. I hope that the Licensing Committee will see that this could happen again and decline permission for the lapdancing club to go ahead.

We wish to object to the above application for a sex establishment licence because in our view it will:

- · Adversely affect the character of the historic market town of Ampthill;
- Further distort the balance of commercial interests and the preservation of the town's proud and longstanding local heritage;
- Not be in the interests of the majority of local residents;
- Give an inappropriate message both to visitors to the town and to the large numbers of families with children of school age who regularly use the town centre for commercial and entertainment purposes.

We note that in your licensing policy statement that the Council will monitor the expansion of the leisure industry with a view to maintaining a balance between commercial interests and the interest of preserving local heritage as well as protecting the interests of local residents. You also state that you will consider the characteristics of the locality and shall particularly take account of the density and proximity of residential areas; schools; nurseries or any other premises substantially used by or for children under 16; as well as parks or other recreational areas used by

children; churches or other places of worship; alcohol or entertainment licensed premises.

Ampthill, while relatively larger than many of its surrounding towns and villages, is still in essence a small market town with a significant number of schools and churches, and a relatively large number of pubs and other licensed premises. Its heart, where Church Street, Bedford Street, Dunstable Street and Woburn Street meet is a very concentrated town centre which is the focus for most of its commercial and entertainment activities, all of which are very well used by local residents, often with their young families. The historic Ampthill park is nearby and is also a very popular area for residents and visitors of all ages. The four abovementioned main streets are all dense residential areas and are already overused by traffic during the day and, at night, all attract very lively (and often intrusively noisy) foot traffic well into the small hours.

While we regret that anyone feels the need for sex establishments, we are realistic enough to know that the sex industry in all its forms will always exist. Our objection in this case is based primarily on the fact that such places are more appropriately sited in larger urban areas, away from residential streets and facilities used by local residents (and, particularly, young people) and where the inevitably intrusive outflow late at night is more easily absorbed than it would be in a small town like Ampthill.

Ampthill residents are very proud of their town, its history and its attractive aspect and most of us welcome diversity in the local economy, especially in times of recession. However, this application, if approved, would strike a very discordant note and give off completely the wrong signals to visitors. It would also run a serious risk of increasing to even more unacceptable levels the amount of noise we have to endure on our streets at night while most of us are trying to sleep.

Please help us to protect our small and lively town from tackiness and reject this application.

We are happy for the applicant to be made aware of these views but would wish to retain our anonymity.

I am writing to you in connection with the application for a Sex Entertainment Venue in Church Street, Ampthill by John Shayler.

I feel that the sex industry has no place in Ampthill. It is not in keeping with the historic nature of the town and the community here is family based with 4 schools and more family housing, both being built, and due to be

built in the near future.

The noise and behaviour of those attending such a venue will disturb residents in very nearby streets and possibly in other areas of Ampthill too.

The nature of the business may also be detrimental to other business in Ampthill as people may feel 'uncomfortable' being near such a place and may prefer not to come into town in the evening when the sex entertainment venue is open. As a woman, I would find it intimidating to be near and would be concerned about the possible behaviour of the clients that frequent such an establishment. As a teacher, I would express concern about under age youngsters being both admitted to such premises and drinking there. The recent, tragic death of a 15 year old girl in Ampthill was preceded by 'drinking in local pubs' although she was clearly under age to do so. It is difficult enough to enforce the law in this area with the establishments already opening late in Ampthill without another venue to have to check on.

Ampthill has a wonderful reputation and people move here for good schools and a good community. I do not believe that a sex entertainment venue will add anything to the town and, such an establishment, could infact precipitate a decline in Ampthill as people move out to quieter areas which they feel are safer for their children and themselves.

I appreciate that you will only consider the nature of some of these objections but I trust that you will consider those you can with all due seriousness.

I am writing to raise my objection to the application for a proposed sex entertainment venue on Church Street in Ampthill

As a resident of Church Street, I must object on the basis that we already have enough publicly licensed premises available in Ampthill within a small area. Within 100 yards or so, we have the Prince Of Wales, The White Hart (with its night club), a Mexican bar, the Wingfield Club, The Queens' Head, The Old Sun, the Albion, the Engine And Tender and numerous restaurants all of which are licensed to serve alcohol. In short, we are already well-served for any form of alcoholic refreshment within walking distance of the proposed venue in any direction.

As a resident of Church Street, I have had to put up with drunken patrons of these establishments banging on my windows, urinating in my garage and exposing themselves to my wife on one occasion, as well as putting up with the shouting and screaming into the small hours of the morning. We have had people moving roadworks signs to block the road at night, causing chaos with traffic and it has been the residents who had to put them back in the middle of the night.

Minicabs required to service the patrons of the existing venues already cause a traffic hazard by parking in the narrow roadways where the roundabouts are at the junction of Church Street and Bedford Street, seemingly with the blessing of the local police, who deem that asking them to use Waitrose's car park out of hours is too difficult.

On a commercial basis, I would suggest that despite the applicant saying that he wants to drive trade into Ampthill, this venue is likely to do the opposite- it will not be open during normal shopping hours under the terms of the current license application and, this means a large commercial premises sitting closed at peak time in the middle of a historic market town. Better use would be something in the lines of the bistro it used to be before the owner shut it down for refurbishment and never re-opened it. This, I believe was done due to a drainage leak caused by Waitrose, so presumably the owner has received adequate recompense for any losses on that basis.

With the advent of Centre Parcs and the tourist trade it will bring, I cannot see a family holiday resort looking too kindly on its brochures advertising proximity to a historic place of interest and then finding it is driving customers to a high street where one of the biggest commercial properties is closed during the day and not family-suitable when it is open.

On a personal note, I have a 3 year old daughter and I do not wish to have her walked past such an establishment on her way to Pre-school or to the shops, or to her ballet lessons. There are lots of young children in the area during the day due to the number of pre-schools and activities on offer and I do not think any of them should be exposed to such an establishment and the questions it will raise.

I hope you will find that the location for this venture is ill advised and feel it would be better located somewhere which would not suffer from the impact of its presence in such a way. It would be preferable that is be somewhere that is not also a residential area with children living on it, due mainly to the type of clientele it will encourage and its very late and very regular opening times.

I would welcome the premises to be once again opened as a shop, or café, or restaurant, as it was in the past. That is something we could do with, as this would cater to the incoming tourist trade and be more in keeping with the values of this historic Market Town.



Having been a resident of Ampthill and Maulden for 15 years I would question whether another licenced premises in the centre of Ampthill is really viable? There are many pubs in Ampthill, one of which is the White Hart Hotel which holds an extended licence and is almost opposite the proposed venue. In light of this one has to question the need for a further licenced establishment and particularly one of this kind. It will almost certainly cause disturbance to local residents and increase the chances of antisocial behaviour in the town centre.

The property fronts onto a small paved area which is effectively our town square. We write to strongly object to the grant of a sex entertainment licence for these premises.

We do not feel that a sex establishment is appropriate for the locality for the reasons outlined below and with due regard to your Sex Entertainment Policy.

The whole of the proposed premises are situated in a prime location in the centre of the town. 4 Church Street is prominently situated fronting to the main town

square and the area to the rear is also prominently situated fronting onto the main town car park and supermarket, the access to the car park and The Oxlet, all of which are busy pedestrian and vehicular routes in the very centre of Ampthill - i.e both are gateway routes through the town used by local people and visitors.

4 Church Street is also situated in the central part of the conservation area and we question if this type of use is appropriate for such a historic and important building. Its positioning between quality retailers and service offerings and immediately opposite a toy shop and cafe seem wholly out of character for the locality.

The area to the front of 4 Church Street is an area used for public gatherings and in constant use by children and the general public. It is inappropriate for a sex entertainment venue to front to such an area which is extremely well used for amongst others; carol concerts, Christmas celebrations, Remembrance events, charity collections, market stalls, public seating and cycle parking. It is one of the main routes through the town for children walking to school and very much at the hub of the other businesses in Ampthill.

In addition to this being an inappropriate location, the hours of business proposed means that the property will be closed during the daytime hours which whilst is Mr Shaylers prerogative as owner of the premises will do little to help the economic viability and vitality of the town.

There is already significant noise pollution and anti-social behaviour emanating from local pubs and bars in the immediate area of these premises and these premises will add to the potential fear of crime, noise pollution and other disturbance to residents and businesses. The premises are very close to neighbouring flats and dwellings. There are a considerable number of residences in the locality that are not immediately obvious due to the nature of this area.

We note that Mr Shayler has obtained planning consent to change the use of the ground floor and basement into two retail units and that he has an existing planning use and premises licence for a wine bar. He will require planning consent for a sex establishment which we understand is a sui generis use and we will strongly object, on planning grounds for any amendment to the existing or A1 planning consents in place.

Your policy is very strict in terms of advertisements that can be placed in the window of a sex establishment and you require competent and respectful licensees to operate such businesses. We are therefore extremely disappointed with the nature of the current advertisement in the front window of the unit for staff of any sexual disposition. Due to the prominence of the notice and particular wording, we have now had to explain words and meanings to our daughters (aged 8 and 10) which we do not feel appropriate at their age. You may not be able to take this into account when determining the licence, but it does demonstrate a lack of tact and respect by the applicant.

This is a highly central, busy area of a historic market town. We feel it wholly inappropriate that there be a sex entertainment establishment in this location and implore you to reject the application.

However discreet the design, there will still be something that impinges on the consciousness of these children, and I think therefore that this is an area where this is certainly not appropriate, even if you're one of the people who think that these clubs add to the gaiety of the nation." We believe that these comments apply to the current Application.

 establishment will do nothing to encourage business in the town, and in my opinion, will

Representation regarding a Sex Entertainment Licence at Shaylers, 4 Church Street, Ampthill dated 15 June 2012

We hereby submit a representation against the granting of the above mentioned sex

entertainment licence. We note in the Council's Sex Establishment Policy that the Council will.... 'consider the characteristics of a locality and shall particularly take account of the density, and proximity of;

Residential areas
Schools, nurseries or any other premise substantially used by or for children under 16 years of age
Parks or other recreational areas used by or for children under 16 years of age
Churches or other places of religious worship
Community buildings
Gateways to an identifiable locality
Alcohol or entertainment licensed premises'

- Ampthill is a small Georgian market town and it's historic significance is noted through the Conservation Area designation. The location of the proposed sex entertainment venue is within the heart of this historic centre, in which are located numerous shops (many of which are independent shops), commercial enterprises and residential properties.
- 2. The market square on which the proposed venue is situated is the location for numerous community activities throughout the year such as a regular weekend market stall and annual celebrations including the Aragon Day parade, Christmas Lights Switch On and Christmas Carols with the Town Band. The market square therefore represents a 'gateway to an identifiable locality'. These events are well attended by many within the Ampthill and wider community including families and serve to add

- cohesion to the community. These community events would be taking place in front of a sex entertainment venue which is wholly inappropriate.
- 3. The proposed venue is cited in close proximity to several establishments which sell alcohol. There are already problems for the local residents and businesses, particularly on weekend evenings, from noise, litter and antisocial behaviour including exuberant and offensive behaviour and minor vandalism. For example, we have experienced disturbance along Woburn Street, especially on Friday and Saturday evenings, including dumping of litter on our doorstep and incidents of petty vandalism such as liquid thrown over the front door and bare foot prints on the front door. The provision of another such establishment where the consumption of alcohol will continue after the existing public houses close will only serve to exacerbate the problem for local residents and businesses and hence has the potential to increase the anti-social behaviour that we have experienced to date.
- 4. There are preschools and nurseries, two lower schools and a middle and upper school within Ampthill. Ladybird preschool takes the children on outings throughout the academic year to visit the shops and other facilities in the town centre as part of their education and will therefore pass the proposed venue. This is wholly inappropriate for such young children. In addition, the proposed venue is cited opposite a toy shop which is frequented by and for children under 16 years of age.
- 5. Ampthill Park is a focus for a range of leisure pursuits for all ages, including children under 16 years of age, and is in close proximity to the proposed venue. In addition there is a green recreation space to the rear of the Kings Arms Path which is used by local children, and visits are made from Ladybird preschool for sporting activities.
- 6. A recent initiative 'Totally Locally' encourages Ampthill residents and visitors to shop locally to maintain the economic vibrancy of the town. Much work has been put into this initiative by the local community and businesses. We feel that the citing of a sex entertainment venue in the retail centre will change the character of the town centre and hence may deter visitors and locals alike, with a subsequent adverse affect on businesses and hence jeopardizing this initiative.
- There are several places of religious worship in close proximity to the proposed venue. The nature of the proposed business is likely to be highly offensive to the people attending these places of worship.

 The applicant has been quoted in the local media as wanting to bring 'Disney' to Ampthill. However, we feel that Ampthill, as an historic market town with a strong community spirit does not want and would not benefit positively from the importing of 'Disney'.

In summary we feel that the citing of a sex entertainment venue within the heart of the historic and community town of Ampthill will be detrimental to the historic setting of the Ampthill Conservation Area and adversely affect the amenity value, the reasonable enjoyment of local residents, including families, and the viability of local businesses. We therefore strongly object to the granting of this licence.
