#### Introduction

- 1. The Council's framework for performance management supports the delivery of CBC's priorities.
- 2. The Council now has monthly performance reporting in place. Those indicators that the Directors have identified as 'critical' now form the quarterly corporate performance suite included at Appendix A.
- 3. The indicators for Central Bedfordshire's LAA are included at Appendix B. The report was discussed at the Local Strategic Partnership Board meeting on 22 September.
- 4. The final weighted Place Survey indicators have recently been released by DCLG. An analysis of these indicators is included at Appendix C. It should be noted that this survey was carried out in November 2008 by the legacy authorities; Mid and South Bedfordshire District Council. Therefore the data is now almost 12 months old and some of the survey questions relate to the legacy councils, not Central Bedfordshire Council. However, this data still provides useful intelligence on public perceptions of the area and has been used by the inspectorates to help form their judgement for the Comprehensive Area Assessment (CAA) inspection.

#### Quarter 1 – Key Messages

- 3. For the first quarter of 2009/10 there have been difficulties (linked to the nature of many of the new measures) in collecting national indicator data. This is a consistent issue across the 3 other new District based Unitary Councils and no Quarter 1 Performance Reports have been produced so far by these Councils. In fact Cheshire East Council's first Performance Report will be a mid-year report in November.
- 4. Consequently, there are several indicators contained within this report where performance information is not yet available.

Work is ongoing to ensure this is addressed for Quarter 2.
