Summary:	To update the Schools Forum on the current position with regards to schools that have passed the FMSiS.

RECOMMENDATIONS:

Background

1. The Forum was presented with position statements in June and September 2009 on the progress of the Authority in assessing schools against the Financial Management Standard in Schools (FMSiS). Since then, further work has been completed on the backlog of 2008-09 assessments, as well as commencement of the programmed assessments for 2009-10.

Current position

2. The summary table below indicates the current status of Central Bedfordshire Council's schools in terms of passing the FMSiS. Assessments are completed by Internal Audit and Schools Finance staff. Please note that Northfields Technology College is now an Academy and no longer subject to FMSiS compliance, hence the number of schools has been reduced from 139 to 138.

2008-09 Assessments

3. The backlog of 2008-09 assessments is almost cleared as indicated in the table below:

4. The 19 assessments showing as in progress above include a further 5 assessments awaiting review (which are substantially complete) and a Conditional Pass which is also substantially complete. This leaves a balance of 13 assessments from 2008-09 to be completed.

2009-10 Assessments

5. The schedule of 2009-10 assessments is as follows:

The progress on these is minimal as outlined below:

Schedule for 2009-10- Slippage

- 6. Following comments from the Forum concerning the delays in the 2008-09 assessments, it was agreed that the schools to be assessed in 2009-10 would be scheduled. This was completed at the end of the Summer Term and start of the Autumn Term 2009. The agreed dates for submission of evidence for assessment were confirmed with the Headteacher of each school in writing.
- 7. At 31 December 2009 we would have expected 20 submissions for assessment as agreed with individual schools. We had received at that date 13 submissions, the majority of which were received in the last week of term. This highlights the historical problems with scheduling the assessments and completing them in a timely manner, and is likely to lead to a backlog of assessments at the end of the financial year.

Funding for Assessments 2010-2013

8. The Forum will be aware that Internal Audit are developing a revised approach to the FMSiS assessments, and in addition are currently liaising with the School Improvement Team to develop a coordinated approach to school improvement including financial management. Once this approach has been determined, Internal Audit will discuss any proposals for changes to existing funding levels with the Schools Forum.

Summary and Conclusions

9. Further work continues to be made clearing the backlog of 2008-09 assessments.

10. Work on the scheduled 2009-10 assessments has commenced, despite some slippage on the part of schools scheduled for assessment this year.
