Buckinghamshire County Council (PPP Contract)	Final Tenders Stage	Buckinghamshire County Council had previously reached Preferred Bidder stage (Sept 2009) however, on 5 th March 2010 they announced that, due to legal issues surrounding the site proposed by their Preferred Bidder, they would be returning to a previous procurement stage. Expected to reach Preferred Bidder stage by September 2010.
Cambridgeshire County Council (PFI Contract)	Complete (Facility currently being commissioned)	£35 million of PFI credits awarded in 2007/08. A 28-year contract for Mechanical Biological Treatment solution let, opened in November 2009. Currently undergoing twelve month testing period. Full operation date expected November 2010.
Milton Keynes and Northamptonshire County Council (PFI Contract)	Detailed Solutions Stage	£138 million of PFI credits awarded in November 2008. Expect to reach Contract Award in November 2011. They have just entered the ISDS stage.
