- New emergent thinking The Minister for the Cabinet Office, Francis Maude said about the new national citizenship service (NCS)

"we know that across the country many young people are ready to stand up and make a difference to their local community. We see NCS as key to building a Big Society, to increasing engagement, cohesion and responsibility for young people across the country. This programme will allow a whole generation of young people to make a difference in their local area and play an active role in making society a better place"



Challenges

- Budget
- The role of Councils in the Big Society the emergent thinking on the engagement of voluntary sector and third sector
- Policy direction not yet clear
- Link with the three children's services work programmes
 - Child Poverty, Early Intervention & Prevention
 - Learning Transformation and transforming our relations with schools
 - Protecting truly vulnerable children
- Note: The Government has stopped using Every Child Matters themes of making a positive contribution and economic wellbeing, which was the locus of this work.
 We are asked to talk about local delivery and local solutions instead



Challenges

- Measuring performance will need to be re-configured as the Government has made changes to the way that performance measures will be available including dis-applying the requirement to consult young people through the "Tell Us" survey. Local Authorities have not been required to report on contacts, participation and recorded and accredited outcomes since 2008/09. At that time, the previous Bedfordshire CC was performing well above benchmark
- New delivery mechanisms for young people in the criminal justice system and the measurement of that performance is not clear
- 14 19 funding has been changed and early indications suggest that skills funding will be provided in line with regeneration initiatives built on local economic partnerships

Quality Assurance
