Arising from the previous Council year the Committee currently has the following Task Forces and Advisory Groups within its remit:-

#### 4. <u>Development Strategy Task Force</u>

The Development Strategy Task Force has met regularly since September 2009 to consider items including the Design Guide for Central Bedfordshire, site allocations for housing and employment, gypsy and traveller sites and Local Transport Plan 3. An indicative work programme for the Task Force for 2010 - 2011 is attached at **Appendix C**.

#### 5. <u>Cultural Strategy Task Force</u>

As a result of the Senior Management Review the Cultural Strategy Task Force is now covered in the remit of the Sustainable Communities Overview and Scrutiny Committee and it is this Committee that will receive a final report.

Following a meeting between the Director of Sustainable Communities, the

Assistant Director for Leisure and Culture, the Portfolio Holder, the Chairman of the Task Force, the Chairman of the Children, Families and Learning Overview and Scrutiny Committee it was agreed that the next scheduled meetings of the Task Force be suspended pending the completion of the Senior Management Review.

### 6. <u>Member Advisory Group</u>

The Committee has also established a Member Advisory Group for the purpose of consultation on the proposed programme of highway works and local improvement schemes (**Minute SCOSC/10/33 refers**) composed by Councillors Bastable, Gale, Jamieson, Kane, Maudlin, Williams and Young.
