At its meeting on 14 December 2010 the Sustainable Communities Overview and Scrutiny Committee considered the pre-submission Joint Core Strategy for Luton and Southern Bedfordshire and agreed the following:-

That the Sustainable Communities Overview and Scrutiny Committee strongly supports the Luton and Southern Bedfordshire Joint Core Strategy Pre-Submission document, which is based on assessment of local need and recommend that the Executive endorse the document.

Executive Summary

The Core Strategy for the Luton and southern Central Bedfordshire has been produced by the Joint Committee, supported by the Joint Technical Unit. The Core Strategy is a strategic level document providing the overarching principles for development across the area through the provision of a spatial vision, objectives and policies. The Preferred Options report was presented to and agreed by the Council's Executive in June 2009 which has informed the production of the Pre Submission Core Strategy. However, the recent economic downturn and the election of the new Coalition Government have resulted in the scale of development being reduced to reflect natural growth projections and the timeframe of the plan being shortened to cover a 15 year period rather than 20 years. The publication of the Pre Submission Core Strategy is an opportunity to make representations on the Soundness of the strategy which will be submitted to and considered by an Inspector during the formal Examination process before adoption of the Core Strategy towards the end of 2011.

Background

- 1. The legacy authorities of Bedfordshire County and South Bedfordshire District with Luton Borough Council agreed to work together to formulate a joint approach to planning and transportation policies required to deliver the former Government's Sustainable Communities Agenda for Luton and southern Central Bedfordshire.
- 2. Since November 2005, the Local Authorities have been working together to produce the Luton and South Bedfordshire Local Development Framework (LDF) and in June 2007, the Joint Committee was established by statutory instrument. The Joint Committee now consists of 6 Members from Central Bedfordshire and 6 Members from Luton Borough Council, with observer rights extended to North Hertfordshire and Aylesbury Vale District Councils, the Bedfordshire Association of Town and Parish Councils and the Local Strategic Partnership. The Joint Committee is supported by the Joint Technical Unit, comprising officers from Central Bedfordshire Council and Luton Borough Council.
- 3. The Joint Committee has overseen progress on the Joint Core Strategy, one of the key Development Plan Documents (DPDs) which forms part of the LDF. Whilst the Core Strategy has been produced in part by Central Bedfordshire Council, both Local Authorities are statutory consultees and the process of seeking representations upon the Pre Submission Core Strategy could be flawed without having sought the views of the host authorities. This is the purpose of this report.

Previous Consultation - Luton and southern Central Bedfordshire Core Strategy

- 4. The Core Strategy is one of the Development Plan Documents that collectively form the LDF. It is a strategic level document providing the overarching principles for development through the provision of a spatial vision, objectives and policies. Future, more detailed site specific DPDs will expand on the principles of the Core Strategy and will include detailed policy guidance to enable specific decisions on planning applications to be made.
- 5. In 2007 a consultation exercise was undertaken on the Core Strategy Issues and Options Paper. This set out various strategic spatial options to secure the implementation of growth across the plan area.

6. This led onto and informed the production of the Core Strategy Preferred Options report which set out the preferred policy approach for delivering the level of growth envisaged. The key objectives of the Preferred Options included the provision of a framework of strategic transport infrastructure; concentrating development within existing urban areas and the main conurbation first; strategic urban extensions; and delivering locally appropriate rural development. The Preferred Options report was presented to and agreed by the Council's Executive in June 2009 on the basis that it would provide for the growth requirements of the Luton and southern Central Bedfordshire area in the most sustainable way.

Changes to the Planning Framework

- 7. Since the Preferred Options report was endorsed by the Council, a number of changes have taken place which has impacted upon the production of the Core Strategy.
- 8. Following the election of the new Coalition Government, on 27th May 2010 the Secretary of State for Communities and Local Government wrote to all Local Planning Authorities stating the Government's intention to abolish Regional Strategies in the Localism Bill and that he expected them to have regard to this as a material consideration in planning decisions. On 6th July 2010 the Secretary of State announced the revocation of Regional Strategies and the return of decision-making on housing and planning to local councils.
- 9. However, on 10th November 2010 the High Court upheld a challenge by Cala Homes and quashed the Secretary of State's original decision to revoke Regional Strategies. The East of England Plan, together with its minimum requirement for housing provision therefore remains as a matter of law part of the statutory Development Plan.
- 10. Notwithstanding this, it remains the Government's stated intention to abolish Regional Strategies and the Secretary of State's letter of 27th May 2010 remains a material consideration. Therefore, given the future direction of policy and particularly the Localism Bill which is expected to have been published by the time of this Executive meeting, while the East of England Plan remains a statutory document and cannot be ignored, it is sensible to begin planning on the basis of local need rather than the "minimum targets" approach the East of England Plan sets out.
- 11. On this basis, the Core Strategy now sets out the framework for the delivery across the whole of the Luton and southern Central Bedfordshire area of 23,000 dwellings between 2011 and 2026 along with 28,300 new jobs and all associated infrastructure to ensure the successful delivery of the strategy.
- 12. The timeframe for the Core Strategy has also been amended alongside the level of development to be provided as a result of the changing economic circumstances and the uncertainty surrounding the viability of developments and therefore their deliverability. Amending the length of the Strategy to cover the period 2011 to 2026 provides more certainty on the deliverability of the development proposals within the statutory requirements of providing a 15 year plan. Furthermore, it brings the Core Strategy for the south in line with the end date of the adopted Core Strategy for Northern Central Bedfordshire

- 13. The previous Preferred Options report proposed a total of 43,200 dwellings across the Luton and southern Central Bedfordshire area between 2001 and 2031. This reflected the requirements of the East of England Plan. The Pre-Submission Core Strategy now plans for 23,000 dwellings in the area between 2011 and 2026. This figure represents the "local housing need" as established through a "net nil migration" approach to demographic modelling i.e. setting aside the effects of migration in to and out from the area, the level of need for new homes from within the local community. This approach is consistent with the Coalition Government's Localism agenda in terms of returning decisions about the scale and location of new housing to the local level.
- 14. The reduction in the number of dwellings in line with the area's natural growth projections and the provision of this growth over a shorter time frame will allow the strategy to be delivered in a manner which supports and benefits existing communities, and with the delivery of key pieces of infrastructure, such as the A5-M1 link road, in line with significant housing and employment development.
- 15. The Pre Submission Core Strategy focuses upon the delivery of development in the first instance within the existing urban conurbation which consists of Luton, Dunstable and Houghton Regis. This is balanced with the identification of 3 strategic urban extensions – to the east of Leighton Linslade, north of Houghton Regis and north of Luton – for the delivery of mixed use developments comprising housing, employment, infrastructure and community facilities and services. A fourth urban extension is identified as an extension to Century Park to the east of Luton to accommodate strategic employment growth.
- 16. Through concentrating development within the existing urban areas, the Core Strategy aims to regenerate the town centres within the Plan area. Chapter 11 of the Core Strategy considers each of the towns on an individual basis by identifying specific and relevant visions and policies in order to create more vibrant locations for people to live as well as to forge stronger local economies.
- 17. A fundamental element of the Core Strategy is the inclusion of the infrastructure schedule which identifies the infrastructure that is considered to be either critical or essential to the delivery of the Core Strategy. It also identifies the timings of the required infrastructure within the lifetime of the Plan as well as identified and potential funding sources.
- 18. The inclusion of the Infrastructure Schedule within the Core Strategy is key to ensuring that no development takes place within Luton or southern Central Bedfordshire without the necessary and appropriate infrastructure being funded, or in place, beforehand. The Infrastructure Schedule is supported further within the Core Strategy through Policy CS3 'Developer Contributions for Infrastructure'.

Implications for Central Bedfordshire

- 19. The Luton and southern Central Bedfordshire Core Strategy, once adopted by the Joint Committee, will provide a number of benefits for the southern part of Central Bedfordshire. The key benefits of the Core Strategy are considered to be:
 - It will provide a positive and balanced approach to the delivery of sustainable development across the southern Central Bedfordshire area;
 - (b) It will contribute to achieving Central Bedfordshire Council's Economic Powerhouse Agenda;
 - (c) It will be instrumental in achieving the successful delivery of the A5-M1 link road;
 - It will be a fundamental element in the delivery of key strategic infrastructure across the southern area to the benefit of existing as well as future communities;
 - (e) It will play an essential role in providing for the regeneration of two key urban areas within southern Central Bedfordshire, namely Dunstable and Houghton Regis, as well as contributing to the regeneration of the wider urban conurbation which includes Luton.
- 20. The benefits of the Core Strategy for the southern part of Central Bedfordshire are therefore wide ranging and will contribute significantly to improving the area as a whole for all Central Bedfordshire's current and future residents.

Next Steps

- 21. The following timetable sets out that which will lead to the adoption of the Luton and southern Central Bedfordshire Core Strategy.
 - Publication of the Pre Submission Core Strategy 29th Nov 2010.
 - 7 week period until mid-January 2011 for `representations to the Core Strategy to be submitted
 - Collation of representations received
 - Submission of Core Strategy for Examination early March 2011
 - Examination of Core Strategy for 3 to 4 weeks June/July 2011
 - Receipt of Inspectors Report Autumn 2011
 - Adoption of the Luton and southern Central Bedfordshire Core Strategy end 2011.
