Following our application, made by my wife, to fell the Silver Birch tree in our front garden and the subsequent Tree Preservation Order 12/2010, I would like to appeal against the decision on the following grounds:

- 1) This tree was planted by us 35 years ago when we first moved in (there was just a grassy slope at the front) and at that time we had no idea about gardening or the ultimate size that the tree would grow to, nor the problems that would ensue.
- 2) We applied to the council to fell it because that was what we felt was the appropriate action to take and it is ironic that had we not followed the appropriate channels the tree would have been taken down by now and replaced with another species.
- 3) The tree is in a narrow bed at the right hand side of our property and overhangs the driveway of two adjacent properties. The tree leans towards our property and has grown far too high.
- 4) As you are aware, this species deposits significant twig and leaf debris during the whole season, as well as sticky deposits in Spring and excessive seed fall in the Autumn. The seed fall has been particularly bad this year with cloqued house and car drainage systems.
- 5) The clogging of the car drainage system has previously proved to be a very expensive exercise due to water ingress when parked or being driven in heavy rain, knocking out the car's gearbox computer and other electronic systems.
- 6) We have pruned and reduced the height of the tree a few years ago but as this now appears not to be a possibility due to the TPO, we would prefer to replace the tree with one of the following or possibly one that you would prefer as an alternative suggestion.

Fagus Sylvatica 'Purpurea Pendula' Sorbus Aucuparia 'Sheerwater Seedling' Acer Triflorium Acer Japonicum 'Vitifolium'

7} There are many Silver Birch trees in the immediate area and as most are much more attractive and in far better condition than ours, we think it would enhance the visual aspect if our tree was replaced.

Finally, I enclose photographs to support our application together with signatures from those neighbours who are affected by this tree, giving us their support for replacing it or at the very least to be permitted to significantly prune it.

Can I now please ask that you reconsider your decision?


