#### CORPORATE IMPLICATIONS

### **Council Priorities:**

The Council's over-arching priority is to efficiently and effectively provide a range of services to the citizens of Central Bedfordshire, and through those services make a significant improvement to the lives of all those people.

In delivering its core services, the Council needs to be businesslike and responsive. A modern local authority relies heavily on ICT systems both to run the organisation and to deliver its services, often in real-time where the protection of vulnerable clients is concerned. The ICT Stability Programme has been designed to bring the CBC ICT infrastructure to a state where it supports the Council in delivering its services, and continues to operate in a safe and stable fashion into the future, through continuing good operational practices.

### Financial:

Additional capital funding will be required to accommodate the implementation costs by increasing the existing ICT Infrastructure Capital Scheme. The financial details are contained in the attached Business Case. This capital scheme will be funded through additional capital borrowing or use of our own funds.

### Legal:

As the value of the individual work streams and work packages will be below the EU threshold, a full Official Journal of European Union (OJEU) tendering process will not be required. Suppliers will be chosen from existing contracts and procurement frameworks.

### **Risk Management:**

The Council suffered a major (6-day) ICT outage in February 2010 and a significant number of shorter outages since that time. The instability of the ICT infrastructure was identified as a top priority issue to be addressed by the Authority at the beginning of 2011, and this programme addresses the highest risk items within that infrastructure and the ICT service, through a carefully assessed and externally-assured approach.

## Staffing (including Trades Unions):

No staffing reductions are planned as part of this programme.

# **Equalities/Human Rights:**

In developing the ICT Infrastructure Capital Scheme for ICT Stability, the Council must ensure that decisions are made in such a way as to minimise unfairness, and that there is not a disproportionately negative effect on people from different ethnic groups, disabled people, and men and women.

The statutory equality duties must be exercised in substance, with rigour and an open mind. To ensure that they have complied with the equality duties, and to ensure that any decision made does not unfairly discriminate, public authorities should:
