### **Background**

### **Director's Summary**

- 4. Across the board, Sustainable Communities continue to deliver high performance across a range of indicators. The Economic Growth indicators continue to show the impact of the economic downturn and show that Central Bedfordshire appeared to fair well through and maintain above average performance in comparison to our neighbouring authorities. Success areas from the services include the launch of the ESF Prospectus offering a £1.9 million programme to support access to work, training and skills development and the adoption of the Dunstable Master Plan by Executive during March.
- 5. Highways and Transport indicators continue to perform well across the service. The winter maintenance plan was completed without any stock problems and 100% of planned gritting routes were made despite the winter weather experienced and over £750k has been secured from the DfT for winter maintenance repairs to the road network.
- 6. Planning also continues to perform well across the service with high levels of customer satisfaction being reported.
- Performance in Public Protection, Community Safety, Waste and Leisure continue to show solid performance in each area. Areas of success from the service include work undertaken by the Financial Investigation Unit on behalf of the Environment Agency for a confiscation case and a commendation from the Police for the CCTV team for the assistance given in relation to the investigation and support in the arrest of a murder suspect in Dunstable.
