1 Introduction

The Minerals and Waste Development Framework

- 1.1 This is the Minerals and Waste Development Scheme. It is the Council's project plan and programme for the production of all documents to be included within the Minerals and Waste Development Framework. The Framework consists of a number of Minerals and Waste Development Plan Documents, and together these set out the detailed land use policies and proposals for the extraction of minerals and management of waste in the area of Bedford Borough Council, Central Bedfordshire Council, and Luton Borough Council.
- 1.2 This document can be made available in a range of languages, large print, Braille, on tape, electronic and accessible formats.

The 2004 Act and Localism Bill 2011

- 1.5 The Planning and Compulsory Purchase Act (2004) brought about major changes in the planning system. Specific to minerals and waste, the Bedfordshire and Luton Minerals and Waste Local Plan is being replaced by the Development Plan Documents within the Minerals and Waste Development Plan Framework. Until all of the existing policies are replaced by policies in the LDF, the Minerals and Waste Local Plan Policies have been saved, and will remain part of the development plan. Diagram 1 shows the contents of the Minerals and Waste Development Framework, including the Minerals and Waste Local Development Scheme, which has the role of a project plan. The object is to show the range of documents that will be produced and the timescale for their production.
- 1.6 The Localism Bill 2011 proposes a range of changes to the planing system, some of which are significant to minerals and waste planning. Regional Spatial Strategies are to be abolished, although there will be a new duty on Local Authorities to co-operate on strategic issues. Government Offices have already been disbanded, and the Secretary of State will no longer approve Local Development Schemes. There will be a new power to enable the Secretary of State to fine Local Planning Authorities who do not have in place an adopted waste plan which is compliant with the European Union Waste Framework Directive.

Changes in Circumstances following Local Re-Organisation


- 1.7 The first Minerals and Waste Development Scheme was approved in 2005, and amended in 2006, 2007, and 2009. Bedford Borough Council, Central Bedfordshire Council, and Luton Borough Council are now the Councils responsible for minerals and waste planning in their areas ("Minerals and Waste Planning Authorities"), as well as responsible for progressing the Minerals and Waste Development Framework. This Framework is jointly owned between the three Councils, and will consist of a collection of documents that bring forward the spatial strategies, strategic land use policies, and Strategic sites for the extraction of minerals and management of waste in their areas.
- 1.8 Since the adoption of the 2009 Local Development Scheme the progress on the Minerals and Waste Local Development Framework has been slower than expected, and has significantly diverged from the adopted timescales. Consequently this revised Local Development Scheme is brought forward, and sets out more realistic timescales for the further progress of the Minerals and Waste Local Development documents.

Shared Service

- 1.9 The Minerals and Waste Development Framework is being produced and progressed by a Joint Minerals and Waste Planning Team, employed by Central Bedfordshire Council, but working on behalf of the three unitary authorities. In respect of minerals and waste developments it will provide relevant areas of policy for guiding decisions on these forms of developments. Unlike the Minerals and Waste Local plan, which was a single document, the Minerals and Waste Development Framework (MWDF) comprises a portfolio of documents as shown in Diagram 1. The programme for production of these plans is set out in this document, which is the Minerals and Waste Local Development Scheme (MWLDS). Along with this MWLDS, the Minerals and Waste Development Framework will contain Minerals and Waste Development Documents (MWDD's). These consist of Development Plan Documents (DPD's), which are subject to independent examination, and Supplementary Planning Documents (SPD's) which provide more detailed guidance for DPD policies, not subject to independent examination.
- 1.10 Within the Minerals and Waste Development Framework, there is also another document that sets out the how the local community will be involved in the development of the MWLDF, which is known as the Statement of Community Involvement (SCI), which for Bedfordshire was adopted in 2006. This is not a Minerals and Waste Development Document, although it has been subject to consultation and independent examination. The Statement of Community Involvement is also part of the statutory development plan,

which is the basis for future minerals and waste planning decisions. The Minerals and Waste Development Plan Documents (MWDPDs), as they are adopted, will progressively replace the adopted Bedfordshire and Luton Minerals and Waste Local Plan.

- 1.11 The 2007 Local Development Scheme proposed the preparation of five DPDs:
- Minerals Core Strategy
- Minerals Site Allocation Plan
- Waste Core Strategy
- Waste Site Allocation Plan
- General Environment Policies
- 1.12 The latest version of PPS12 produced in June 2008, indicated that Strategic sites may be included in Core Strategies. "Strategic" sites are defined as those essential for the successful implementation of the Plan. In addition it is considered feasible to combine the documents containing preparatory work for the Minerals and Waste Core Strategies, into a single combined Minerals and Waste Core Strategy, since issues of the restoration of mineral void spaces, and the production of secondary aggregates, relate to both. It is also intended to produce a General and Environmental Policy DPD, concerning issues about the location and impacts of new mineral extraction and waste management sites. This is a separate document since alterations to national policy concerning planning controls, and changes of local circumstances, will continue to evolve at a different timescale to that of the strategic policies contained in the Core Strategy.
- 1.13 This MWLDS sets out the detailed timetable for the preparation of the above mentioned planning policy documents that will make up the Minerals and Waste Development Framework. Along with setting out which documents are to be produced, this MWLDS highlights the main stages when stakeholders and the public may wish to be involved in the production of each plan. It is available to purchase from the respective Councils and is available to download free of charge via the Councils' websites.



2 Objectives and Content of the Minerals and Waste Development Scheme

Objectives

2.1 This Minerals and Waste Development Scheme has two main objectives. Firstly it acts as a starting point for the community and stakeholders to find out about the Councils planning policies in respect of minerals and waste issues, and what status these policies will have. Secondly, it outlines the details of, and timetable for, the production of minerals and waste development documents in detail, including timetables which will inform people when the various stages in the preparation of any particular local development document are intended to be carried out.

The Minerals and Waste Development Scheme sets out:

- A brief analysis of what will be contained within the portfolio of the Minerals and Waste Development Framework (MWDF);
- A description of all the documents within the MWDF to be prepared and the content and geographic areas to which they will relate;
- Which Minerals and Waste Development Documents(MWDD) will be development plan documents (DPDs) and which will be supplementary planning documents (SPDs);
- In the transitional period, which of the saved policies and proposals of the Bedfordshire and Luton Minerals and Waste Local Plan will be replaced by MWDD's;
- An explanation of the relationship between the documents within the MWDF;
- The planned timetable for preparing each document and the key milestones to be achieved;
- The resources required and the approach to be used for the MWDF Documents;
- An explanation of how progress against the MWDD's will be monitored and reviewed.
- 2.2 In addition to the Minerals and Waste Development Documents, there will also be a number of Technical Evidence Papers, and Evidence Base documents. These documents will accompany the Core Strategy when it is Submitted to the Secretary of State.

Content

The Regional Spatial Strategy

2.3 The East of England Plan (the Regional Spatial Strategy) provides the context for preparation of the local level Development Plan Documents. The regional plan encompasses minerals planning policy statements, accompanying guidance and other relevant national policies to provide a strategic framework for the minerals planning authorities to prepare Development Plan Documents. Concerning the provision of aggregates, Policy M1: Land won Aggregates and Rock - requires Bedfordshire and Luton to maintain

an annual average level of 1.93 million tonnes pa of land-won sand and gravel 2001-16. There are eight waste management policies, including Policy WM4: Regional Waste Apportionment, which for Bedfordshire & Luton sets out annual tonnages of waste to be managed to 2021. A function of the proposed DPDs is to demonstrate how these strategic policies can be implemented at the sub-regional and local level.

- 2.4 The East of England Aggregates Working Party considered the 2005 to 2020 Guidelines in 2009, and carried out a further sub-regional apportionment of provision. For the Plan area it was agreed that the annual apportionment would be 1.84 million tonnes of sand and gravel. These figures were incorporated into the review of the Regional Spatial Strategy, which was published in March 2010 by the East of England Regional Assembly, before its demise. It should be noted that the Localism Bill proposes to abolish Regional Spatial Strategies. The revised National and local guidelines for aggregates provision in England 2005 to 2020 were formally published in September 2011, and set out the sub-regional apportionment which confirms that the apportionment for the Plan area is 1.84 million tonnes of sand and gravel per annum.
- 2.5 Concerning waste the East of England Plan 2008 sets out eight Policies in relation to the provision of waste management facilities, waste minimisation and prevention measures.

Minerals and Waste Development Plan Documents (MWDPDs)

- 2.6 The proposed Development Plan Documents shown in Diagram 1 are statutory policy documents which will form the basis for development control decisions on Minerals and Waste planning applications within the Plan area. Decisions will be made in accordance with these Policies, and any other material considerations. These Plans will carry a similar status to the former Minerals and Waste Local Plan. Development Plan Documents will be produced in consultation with stakeholders and the public, and will be subject to independent Examination. The key stages in producing MWDPDs are:
- Evidence Gathering
- The identification of key issues and policy options
- Preferred Options published for consultation (optional)
- Consideration of comments and preparation draft Core Strategy or other DPD
- Pre- Submission Publicity
- Submission of Core Strategy (or other DPD) to the Secretary of State
- Examination by Inspector
- Inspectors Binding Report
- Adoption
- Monitoring
- 2.7 The Town and Country Planning (Local Development) (England) Regulations 2004 and Amendment Regulations 2008 also require, for each Plan, production of:-
- A Statement of Conformity with the East of England Plan (this will no longer be required after the formal abolition of the Regional Spatial Strategy);

- An explanation of how a new Plan relates to "saved" planning policies contained in the current Minerals and Waste Local Plan; and
- A description of the stakeholder and public involvement undertaken and how this accords with the Statement of Community Involvement.

Proposals Map

2.8 A Proposals map will be produced in parallel with the production of the MWDPDs and updated as plans are adopted. It will illustrate all the proposals and policies contained within the Minerals and Waste DPD's and be in conformity with the Minerals and Waste Core Strategy, and the General and Environmental Policies DPD, as well as National and Regional Guidelines. This is in accordance with Regulation 9 of the Town and Country Planning (Local Development) (England) Regulations 2004.

Minerals and Waste Supplementary Planning Documents (MWSPDs)

- 2.9 Supplementary Planning Documents (SPDs) are intended to elaborate on adopted policies. While they are subject to public consultation, there is no formal Examination stage, and have the status of being a material consideration in the determination of a planning application.
- 2.10 The former Bedfordshire County Council and Luton Borough Council adopted an SPD entitled "Managing Waste in New Facilities" in April 2006. It provides further detail regarding saved policies W5 and W6 of the adopted Minerals and Waste Local Plan of 2005. This Document provides guidance on reducing, recycling, and recovering waste during demolition, construction and occupation of new developments, and embedding waste storage and collection facilities into new developments. The adopted SPD is intended to remain in force, and fulfil the vital function of assisting in waste reduction and promoting storage of recyclable materials and wastes. It will be reviewed at a later date when saved policies W5 and W6 have been replaced. No additional SPDs are proposed.

Bedfordshire Minerals and Waste Statement of Community Involvement (SCI)

- 2.11 Bedfordshire County Council adopted their Statement of Community Involvement (SCI) in October 2006. It explains how the general public and others with a interest in development plans can be involved in the Minerals and Waste Development Framework process. This SCI is still in force in each of the successor Minerals and Waste Planning Authorities.
- **2.12** Since the adoption of the Statement of Community Involvement the Councils are monitoring its use, so that techniques for community engagement and involvement, and the range of organisations engaged, are sufficient and appropriate. If necessary, the SCI will be reviewed and revised.

Sustainability Appraisal

2.13 The Sustainability Appraisal (SA) of Plans, required by section 19 (5) of the Planning and Compulsory Purchase Act 2004, is an appraisal of the economic, social and environmental sustainability of a plan. This also incorporates the requirements of the European Directive on Strategic Environmental Assessment. The SA should perform a key role in providing a sound evidence base for the plan, and form an integrated part of the plan preparation process. Each of the preceding consultation documents has been subject to Sustainability Appraisal. The SA informs the evaluation of alternatives so as to demonstrate that the eventual plan is the most appropriate, given the reasonable alternatives. This will be carried out by Consultants.

Technical Evidence Papers and Evidence Base

Minerals and Waste Local Development Scheme 2011

- **2.14** A series of Technical Evidence Papers and an Evidence Base will accompany the Minerals and Waste Combined Core Strategy, and the later General Environment Policies DPD. A preliminary list is set out here. However, this list will continue to evolve as the documents are progressed.

- 2. East of England Regional Spatial Strategy Waste Policies 2008
- 3. Site Assessment Information concerning the suggested Strategic sites
- 4. Bedfordshire and Luton Municipal Waste Management Strategy
- 5. Water Cycle Strategy for Bedford and northern Central Bedfordshire
- 5. Municipal waste management contracts and arrangements

Minerals Evidence Base:

1. Permitted mineral workings (operational, non-operational and dormant)

2. Extent of Minerals to be Safeguarded

Minerals and Waste Evidence Base:

- 1. Saved Policies from the Bedfordshire and Luton Minerals and Waste Local Plan
- 2. Progress on the Minerals and Waste Local Development Framework
- 3. Progress on the non-minerals and waste Local Development Frameworks of the three Councils within the Plan area.
- 4. Bedford Borough Council and Central Bedfordshire Council Annual Monitoring Reports for 2006 to 2010.

Annual Monitoring Report

- **2.16** A further document which is required to be produced is an Annual Monitoring Report (AMR). This will assess, for each financial year, the progress made in Plan preparation, and monitor the effectiveness of policies and proposals. An Annual Monitoring Report is particularly useful in determining:-
- Whether targets and milestones have been met, and identifying changing circumstances;
- Policy effectiveness, particularly regarding minerals and waste targets;
- The need to review any policies in the light of findings above; and
- The need to review this Development Scheme, due to monitoring implications or legislative changes.

Indicators

- **2.17** Appropriate indicators will be identified with which to monitor and assess progress against targets. Guidance indicates that there needs to be an objective-led approach to MWDF monitoring, which should:
- Ensure clear links from objectives through to policies, implementation programmes and to output targets and related indicators;
- Focus on key objectives rather than monitoring a wide range of indicators not directly relevant to policy performance;
- Provide sufficient consistency in terms of local authority monitoring approaches to enable comparisons to be made;
- Allow transparency and accountability in terms of delivery;
- Facilitate more informed policy and decision making.

3 The Minerals and Waste Development Documents: Programme Management for Preparation

Saved Policies

- 3.1 The Bedfordshire and Luton Minerals and Waste Local Plan, 2000 2015, was adopted in January 2005, and was automatically saved until January 2008. A Government Protocol was published in August 2006, setting out how policies could be saved over the longer term, and which involved giving the Government Office sufficient notice of intent, and making a formal request. Confirmation was received from Government Office for the East of England on the 14th September 2007 that all minerals and waste policies from the BLMWLP had been saved until they are replaced by the Policies within the Development Plan Documents of the Minerals and Waste Local Development Frameworks. The only exceptions were two of the waste Policies, which were not saved and are now considered "expired", namely:
- W10 (Household Waste Recycling Centres); and
- W15 (Pre-landfill treatments for biodegradable waste).

Minerals

- 3.2 In relation to minerals, the following preparatory work has been undertaken:-
- Minerals Core Strategy and Site Allocations Plans Issues and Options stage Consultation documents which underwent public consultation beginning in February 2006.
- A Minerals Core Strategy Preferred Options Consultation Paper (published for consultation 19th September 2007-31st October 2007) which set out Core Policy proposals for mineral development; and
- A Minerals Site Allocations Plan Preferred Options Consultation Paper (published at the same time for public comment) which set out Preferred site allocations for future mineral working.
- A new site proposal (Clipstone Brook: reference MD50) was brought forward, which necessitated additional consultation. This took place between 28th April and 2nd June 2008.
- Mineral Safeguarding Area public consultation took place between the 28th February and 10th April 2011.

Waste

- 3.3 In relation to waste the following preparatory work has already been undertaken:-
- Waste Core Strategy Issues & Options Consultation Paper I which addressed policy issues underwent public consultation from 1st October to 30th November 2007.
- Waste Site Allocations Plan Issues & Options Consultation Paper II set out a portfolio of potential new sites for waste facilities nominated by waste operators and landowners. This underwent public consultation from 1st October to 30th November 2007. The Consultation Paper also called for additional

- site nominations. Following this Paper, a further eight waste sites were put forward for possible inclusion within the MWLDF, and there was also an amendment to a suggested site regarding its capacity. This led to additional public consultation from between 28th April and 2nd June 2008.
- Waste Core strategy Preferred Options consultation document (which included Strategic waste sites) underwent public consultation from 1st June to 12th July 2010.

Combined Minerals and Waste Core Strategy

3.4 A combined Minerals and Waste Core Strategy, including Strategic Mineral Extraction and Waste Management Sites, is being developed, based on the preceding consultation documents. This is further discussed in Chapter 4. In deciding to create a combined Minerals and Waste Core Strategy it should be remembered that there are cross connecting issues such as the restoration of mineral voids, and the provision of secondary aggregates from construction and demolition wastes, which mean that it is appropriate for the previously separate Waste and Mineral Core Strategies to be merged into a single Core Strategy DPD.

General and Environmental Policies

3.5 The General and Environmental Policies form a separate section in the Bedfordshire and Luton Minerals and Waste Local Plan adopted in 2005. These Policies provide the basis for considering site specific issues concerning the location and impacts of minerals and waste developments, including schemes for their reclamation during the determination of applications. The current policies from the adopted Minerals and Waste Local Plan are saved by Direction from the Secretary of State until they are replaced by Policies in the later General Environment Policy DPD, which is intended to be adopted during 2014.

Supplementary Planning Document

3.6 Saved Policies W5 and W6 of the adopted Local Plan underpin the Supplementary Planning Document 'Managing Waste in New Developments' as indicated in paragraph 2.9. Specifically, the SPD aims to encourage the reduction of waste at source in the construction and development process (and especially construction and demolition wastes), through Waste Audits; as well as providing guidance on the provision of waste collection and storage facilities in households, Centralised Facilities, Household Waste Recycling Centres, Commercial Developments, and Mixed Developments.

Other Development Plans

3.7 Bedford Borough Council, Central Bedfordshire Council, and Luton Borough Council, are each producing Local Development Frameworks for their areas, which cover non-mineral and waste planning matters. Bedford Borough Council has adopted a Core Strategy in April 2008. The Core Strategy for the northern area of Central Bedfordshire was adopted in November 2009. Finally, Under the terms of a statutory instrument ('The Luton and South Bedfordshire Joint Committee Order 2007') the functions of that joint committee excluded minerals and waste development planning. This meant that Luton Borough Council retained responsibility for these subject areas. A joint Core Strategy for Luton and the southern area of Central Bedfordshire was submitted to the Secretary of State in March 2011, but was withdrawn in September 2011. Central Bedfordshire Council now intends to review its adopted LDF, and when it reviews the adopted Core Strategy for the north of its area will begin to develop a Local Development Framework covering all of its geographical area.

4 Minerals and Waste Development Document Profiles

Combined Minerals and Waste Core Strategy, including Strategic Sites.

- **4.1** Separate Minerals and Waste Core Strategies and Site Allocations Plans were consulted on from the beginning of the preparation work on the Minerals and Waste Local Development Framework in 2006. Information concerning each of these documents is set out below. The preparatory work carried out so far concerning the separate Core Strategies for Minerals, and for Waste, and Site Allocation Plans for Minerals and for Waste, has been merged into a single Minerals and Waste Core Strategy Development Plan Document.
- **4.2** The Minerals and Waste Core Strategy will include the identification of Strategic Sites, for both mineral working and waste management, and contain Spatial Distributions for both Strategic and Non-Strategic minerals and waste facilities. This will eliminate the need for separate Site Specific Proposals DPDs. Non-strategic sites that come forward as planning applications, will be considered on their merits, according to specific criteria based Policies.


