Annex 1 - Mandatory conditions

a) MANDATORY CONDITIONS WHERE A LICENCE AUTHORISES THE SUPPLY OF ALCOHOL

- 1. No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

NEW MANDATORY CONDITIONS

- 1.
- 1. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –
- a. games or other activities which require or encourage, or are designed to require or encourage individuals to -
- i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b. provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- c. provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
- d. provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on –
- i) the outcome of a race, competition or other event or process, or
- ii) the likelihood of anything occurring or not occurring;
- e. selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2.

The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3.

The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

4.

- 1. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 2. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i) beer or cider: ½ pint
 - ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - iii) still wine in a glass: 125ml; and
- b) customers are made aware of the availability of these measures.

Annex 2 – Conditions consistent with the operating schedule

a) General – all four licensing objectives

- 1) The Licensee shall in all things conduct the premises in a decent sober and orderly manner and take whatever steps are necessary to ensure that there is no profanity nor obscene, immoral, licentious or indecent behaviour likely to cause a breach of the peace.
- 2) No persons aged under 18 by way of staff, visitors, customers, entertainers or any others are to be present whilst the premise is operating.
- 3) When striptease/table dancing is being provided there shall be no physical contact between dancers and customers other than initial introductions (handshake) or when placing a tip in a dancers hand/garter.
- 4) Dancers shall re-dress at the conclusion of the performance and are to remain fully clothed (minimum bikini top and bottom) at all times except when giving a performance.
- 5) No persons other than dancers shall be in the licensed area in a state of undress.
- 6) Access to the dressing rooms shall be restricted and monitored at all times.
- 7) External advertising shall not show photographs or any visual representation of women and shall be in accordance with the advertising code.

- 8) A nominated person should supervise the dancers' cloakroom.
- 9) Management rules of conduct apply to all dancers.
- 10) There should be a minimum charge per table dancing.
- 11) Last time of entry to the premises to be 01.00am.
- 12) Dancers must not be propositioned in any manner.
- 13) Other than arrival, departure, visiting the cloakroom or tipping as mentioned, customers are required to remain seated at all times in the table side of the dancing area.
- 14) A member of staff shall escort dancers arriving and exiting the club.
- 15) No dancer shall arrange to meet with, whether it is inside or outside of the premises, or have any correspondence (notes or business cards) with customers.
- 16) Employees, entertainers or dancers may not sit with customers unless all persons are fully clothed.
- 17) Dancers/entertainers may not leave the premises until the end of the agreed shift or performance, and must not be re-admitted that day or night unless as a part of a written contract.
- 18) Any person who can be observed from outside the premises must be properly and decently dressed, scantily clad persons must not exhibit in the entrance way or in the area surrounding the premises.
- 19) Persons performing table side striptease/dancing shall wear a G-string or bikini bottoms which shall at all times be worn covering the genitalia and should be made of opaque material. With exception to performances conducted in the designated private dance areas where full nudity is permitted.
- 20) There shall be no tableside performances to customers seated at a bar or standing.
- 21) When tableside striptease is taking place no performer shall dance with or towards any other performer and shall make no physical contact with another performer.
- 22) Tableside striptease performers are to remain standing during a performance of striptease.

b) The prevention of crime and disorder

By using registered licensed door staff with SIA badge. Use of CCTV cameras inside and outside the premises. An accident report book kept and available for inspection.

c) Public safety

All health and safety and fire regulations, procedures and risk assessment implemented. Fire action notices displayed. Adequate lighting inside and outside the premises. Staff training in the event of an emergency. Safety certificated up to date and available for inspection. Procedures in place to ensure the safe evacuation of disabled people. First aid boxes kept stocked and first aider on premises at all times.

d) The prevention of public nuisance

By changing the mood of the music half an hour before closing time. Lollipops issued to the public on leaving the premises. Signs displayed asking customers to leave quietly. An announcement by DJ, and a doorman at the exit. Liasing with Taxi firms where to pick up customers to limit disturbance to neighbouring properties.

e) The protection of children from harm

Implementation of prove ID scheme. Proof of ID by way of photographic evidence. Posters regarding under age drinking and the effect of drugs.
