

As there was no reply, I put the papers through his front door. I received a telephone call later that day from Management and explained what the warning meant and that it was best if he stayed away from Leighton Buzzard town centre. I produce the CPN warning paperwork in evidence labelled as Exhibit AM-2 I was subsequently made aware by PCSO Dodkins on Thursday 3 rd March 2016 that following complaints from members of the public about a male being rude and aggressive to members of the public in the town centre, he approached a person who he recognised as being This was a clear breach of the public and on the Thursday 1 received PCSO Dodkins statement of evidence on 9 th March 2016 and on the Thursday 10 th March 2016, I wrote to National Amagement of the public. I produce the CPN paperwork in evidence labelled as Exhibit AM-3 I have subsequently been made aware by PCSO Elliott Weedon that on Sunday 10 th April 2016 he and another officer had seen in an alleyway in the High Street of Leighton Buzzard. This is clearly within the area he is excluded from and therefore
is a clear breach of the Community Protection Notice. The Notice was put in place to prevent and and his friends getting drunk in a public place, shouting and being aggressive to other people and being a general nuisance to passers-by and workers in the area. is only the second person to have breached the Notice and the
effectiveness of the other CPN warnings has made a real difference to the atmosphere of the Town Centre and made it a much more pleasant and safe place to be. If
