That a piece of work be undertaken in conjunction with Special School and Mainstream Head Teacher to map out provision and capacity of SEND schools in Central Bedfordshire and the potential future forecast of SEN needs. 2. That there is the need for an overarching strategy to support the SEND in Central Bedfordshire. 3. That further dialogue would take place with Head Teacher of Oakbank and the DfE about the future of the free school site with this dialogue focusing on ensuring any future provision is based on the needs of children in Central Bedfordshire, with current projections demonstrating a pressing need for ASD and SLD rather than SEMH for CBC children 4.
