Background and Information

- 1 The Central Bedfordshire Local Area Transport Plan (LATP) for Ampthill and Flitwick notes that Flitwick has a very different feel to Ampthill in terms of negotiating the town centre as a pedestrian, notwithstanding the fact that both share similar problems of being traffic dominated in their central areas. The Plan notes that Flitwick town centre is disjointed as a result of being split by the railway line and the roads running through the centre, making the point ...

“...this creates a poor environment for pedestrians and difficulties in accessing shops and services on either side of the railway line.”

- 2 The LATP further notes that where crossing points are provided, these are often away from the desire lines of pedestrians. Specific attention is drawn to locations within the town centre where there is evidence of pedestrians opting to cross at more convenient (uncontrolled) locations, raising road safety concerns.
- 3 The provision of funding through the Market Town Regeneration Fund (MTRF) provided the opportunity to address these issues through improvements to the highway and public realm. These improvements to be designed in partnership with Flitwick Town Council with the objective of improving the longer-term health and vitality of the town centre through an increase in pedestrian footfall.

Market Town Regeneration Fund Programme

- 4 In November 2015, CBC invited bids from 11 town councils for a slice of £4m in capital funding to help reinvigorate their market towns. The money provided the opportunity for town councils to work in partnership with CBC to implement improvements.
- 5 The Market Town Regeneration Fund proposal submitted by Flitwick Town Council sought to support and help revitalise Flitwick town centre. There was a particular focus on rejuvenating the High Street. This complemented a linked improvement scheme being promoted by CBC to develop a multi-modal transport interchange at Flitwick Railway Station.
- 6 Flitwick has an important role as a transport hub and broader gateway for Central Bedfordshire. However, it is faced with a number of ongoing challenges. Many of these are based on how the layout of Flitwick has developed over time. The town centre is, in effect, divided in two due to the presence of the railway line. The traditional High Street is on one side of the rail line, while the more modern expansion of the town is on the other, which is dominated by a large Tesco store and car park.
- 7 The centre does benefit from the presence of the mainline train station linking Central Bedfordshire to London St. Pancras and beyond. It acts as an important commuter hub and generates over 1.6 million passenger journeys per year.
- 8 Flitwick also provides the home station for the Center Parks Woburn Forest and as a consequence its profile is now significantly higher with considerable promotion of transport links to Center Parcs via Flitwick in locations such as Waterloo and King Cross.
- 9 Flitwick Station also links and provides an important facility to the Millbrook Testing Facility and Technology Park, which has developed major proposals for growth that are supported by the South-East Midlands Local Enterprise Partnership and other major employers including Lockheed Martin.
- 10 Due to the railway station, Flitwick generates considerable footfall for a location of its size. Alongside plans to regenerate the area around the railway station, the ambition is to improve the retail offer, capturing an increased share of commuter spend. Further, to improve the overall experience of visiting Flitwick through public realm and accessibility improvements, encouraging residents to use the town centre.

The Scheme Proposal

- 11 The MTRF scheme proposal was developed in partnership and at the request of Flitwick Town Council. To focus is on enhancing the public realm in order to help regenerate and promote the local economy on the east (High Street) side of Flitwick.

12 This scheme proposal comprised:

- Replacing the pelican crossing of the High Street with a zebra crossing, relocating it closer to the High Street roundabout to better serve the pedestrian desire line to/from the railway station.
- Decluttering the public realm through the removal of redundant street furniture.

13 The design proposal was subject to a Stage 1-2 Road Safety Audit (RSA) process, considering the needs of all users of the highway. The conclusion of the assessment process was that the scheme would not introduce any conflicts beyond those already in existence between users of the highway.

Statutory Consultation

14 The proposals were formally advertised by public notice in February 2018. Consultations were carried out with the emergency services and other statutory bodies including Flitwick Town Council and CBC Ward members.

15 Residents and businesses located in the areas where restrictions are proposed were individually consulted by letter. Public notices were displayed at various locations on High Street. The public notice was also advertised in the local newspaper and on the CBC website.

Representations

16 A total of 27 representations were received. Of these representations 1 supported the proposal, 21 expressed concerns and 5 objected to the proposals.

17 Flitwick Town Council responded that their Members felt that the relocation of the crossing would pose additional dangers because of its proximity to the roundabout and vehicles turning from the railway bridge. Members expressed a particular concern that it would put children and older people at greater risk and objected to the crossing being moved on safety grounds.

18 Of the statutory consultees, only The Bedfordshire, Cambridgeshire & Hertfordshire Traffic Management Unit responded to the consultation. They had no objection.

Conclusion

- 19 A scheme to enhance the street scene and improve pedestrian access to the eastern side of Flitwick has been developed in partnership with Flitwick Town Council. These works are designed to facilitate the regeneration of the market town in accord with the brief issued by the MTRF team.
- 20 The proposed works accord with the priorities set within the Ampthill and Flitwick Local Area Transport Plan, specifically to increase pedestrian priority.
- 21 The authority favours zebra crossings in town centres as these have a good safety record and contribute to a more pedestrian-friendly environment. The design of such crossings meet legislative and technical guidance set out by the Department for Transport and are subject to an independent road safety audit process.
- 22 Owing to the strength of public feeling there has been a direction to withdraw the proposal to replace the existing pelican crossing with a zebra crossing and that planned improvement scheme should proceed without this element.

CENTRAL BEDFORDSHIRE COUNCIL PROPOSES TO REMOVE A PELICAN CROSSING IN HIGH STREET, FLITWICK AND TO INSTALL A ZEBRA CROSSING IN HIGH STREET, FLITWICK

Notice is hereby given that Central Bedfordshire Council, in exercise of its powers under Section 23 of the Road Traffic Regulation Act 1984, Section 90 A-I of the Highways Act 1980 and all other enabling powers, proposes to remove the existing Pelican crossing and to establish a Zebra crossing in High Street, Flitwick. The reason is to improve pedestrian access to local amenities, Flitwick Railway Station and local schools. The works are being proposed as part of a highway improvement scheme associated with measures to improve the street scene in Flitwick.

Remove the Pelican Crossing across the full width of the road sited at the following location in Flitwick:

High Street, at a point approximately 47 metres north of its junction with The Avenue.

A Zebra Crossing extending across the full width of the road is proposed to be sited at the following location in Flitwick:-

High Street, at a point approximately 24 metres north of its junction with The Avenue.



Subject: Zebra crossing - High Street Flitwick

I have only just seen the notice for this proposed change and although the time has lapsed to oppose the change I still think I need to explain why this is such a bad proposal.

1. There are already traffic tail backs caused by the traffic lights but at least that only happens at regular intervals, as the traffic lights control the traffic. These tail backs cause problems, along all routes leading to the two central roundabouts, sometimes causing problems all the way back to Temple Way.
2. This is extremely dangerous to put a zebra crossing so close to a roundabout, many people driving the cars are so busy trying to judge traffic they won't even have time to look before they hit someone on the zebra crossing. Children are extremely vulnerable as they are inexperienced road users and you, as a council, are putting them in danger of injury and even death.
3. Many children use this route to school alone and at school times traffic will be having to stop every few minutes at an already busy time of day.

My husband had someone drive into the back of his car at the current traffic lights because the driver was so busy concentrating on the other traffic.
4. Buses cause major tail backs already, they block the road which means congestion builds up on all major roads in the area.
5. The current traffic light crossing has been there as long as I can remember, so at least 30 years and there has never been a problem, why are you wasting taxpayers money changing something that isn't broken.

My son currently attends Flitwick Lower school and the commuter and arrogant parents parking and complete lack of crossing facilities is very dangerous but nothing seems to be done about it, despite petitions and children almost being knocked down.

Please stop wasting our money changing things we don't need to change and think about fixing the things that are actually broken.

I wish to register my opposition to this absurd idea. High Street is an A Class road with no restrictions on HGVs. Replacement of a pelican crossing (with demarcated times when vehicles are stopped to allow pedestrians to cross) with the less safe system of a zebra crossing will put my children at risk when they walk to Redborne School.

A zebra crossing also is far more dangerous for blind people than a pelican crossing (which has an audible safe to cross signal).

Subject: Proposed Pedestrian Crossing Changes, High Street, Flitwick

Traffic Management Team

We are concerned about the proposal to remove the existing Pelican crossing in the High Street, Flitwick and replace it with a Zebra crossing. The proposed Zebra crossing is a lot closer to the roundabout than the existing Pelican crossing, roughly half the current distance of 47 metres. This means that drivers exiting the roundabout will have less distance and therefore time to react to pedestrians crossing the road.

Changing the type of crossing from a Pelican to Zebra is also a concern. Lots of pedestrians, including children on their way to/from school, use the crossing. The traffic lights for vehicles combined with a clear green signal for pedestrians means that the road can be crossed safely. A Zebra crossing will not provide such clear signals to traffic and vehicles. Our children who use the crossing to go to/from school far prefer using Pelican crossings to Zebra crossings and view Pelican crossings to be a lot safer.

In our view, the proposed Zebra crossing will not be as safe for pedestrians as the existing Pelican crossing. The Public Notice does mention safety. Has this been considered?

The Public Notice does state that the reason is to improve pedestrian access to local amenities, Flitwick Railway Station and local schools. We struggle to see how this can be the case when there will be no change in the number of pedestrian crossings between the East and West sides of Flitwick.

I just wanted to comment on the proposed removal of the crossing on High St Flitwick, and replacement with a Zebra crossing. I understand the benefit of a zebra crossing, as it will likely result in shorter periods of stationary traffic, but don't understand the logic of it being moved closer to the roundabout from the current crossing point. With the crossing so close to

the roundabout, would this not result in the traffic backing up to the roundabout and blocking it every time a pedestrian crosses? I would have thought having it at the current location would give scope for traffic to queue without backing up as far as the roundabout. Also, I would expect some occurrences of people accelerating to cross the roundabout when there is a short opportunity, and then being immediately on top of the roundabout, with a risk of not seeing waiting pedestrians in time.

It's good to see some measures to manage traffic in Flitwick being proposed, I just wondered if the logic of the relocation closer to the roundabout could be further considered please.

Sirs

the proposals to remove the current pelican crossing and install a zebra crossing nearer to the bridge and roundabout are short-sighted and dangerous.

Your stated reason is to improve pedestrian access to local amenities, the station and schools. The degree to which this will be achieved is negligible compared to the outlay and the disruption caused. But the resultant new zebra crossing will in fact be dangerous to use.

Traffic coming off the railway bridge will have so little fore-warning of having to stop. Will there be signage on the bridge warning of the crossing? There is so much traffic that uses Flitwick that is unfamiliar with the local area- a crossing at such close proximity to the roundabout will be a surprise. When exiting the bridge and turning left, you are required to look at traffic coming from all other directions, but not in the direction in which you are turning, i.e. towards the crossing.

Large and articulated lorries use that route and often have to drive over the roundabout in order to make the turn. If they are forced to stop at the new crossing, they will be an obstruction to traffic exiting onto the roundabout from other roads.

Stopping at zebra crossings has become optional with the current standard of driving. At least with lights, it is a more definable offence to ignore them.

Please reconsider this proposal- it makes no sense at all.

With reference to the attached, could I ask as to what consideration has been given to slow traffic down as it exits the roundabout onto High Street towards the proposed Zebra crossing? My concern as a parent whose children use the current Pelican crossing is that some drivers will simply ignore or not see pedestrians (especially children) waiting to cross and simply drive through the Zebra crossing.

As a resident of Princess Close (approx 160m from the railway bridge, off Kings Road) we unfortunately witness all too often speeding and ignorant motorists who seem to revel in accelerating away from the centre of town, be it along either the High Street or Kings Road and so feel at least that the red light of the Pelican crossing gives the driver the clear instruction to stop that a flashing amber zebra crossing does not (although it should of course).

Furthermore, I notice too that there is a planned tabletop for the junction of Kings Road with Station Road/Square, which is welcome to see as it will undoubtedly force drivers to slow down to negotiate it, however I feel that without further traffic calming measures further down Kings Road this will only again enrage some idiotic drivers to speed down Kings Road (as they often do presently) away from the centre. There is currently in place a crossing point opposite the footpath to Kingsmoor Close which is heavily used by lower school children and parents, who have witnessed speeding motorists as the speed either down (more commonly) or up Kings Road.

Consideration to introduce further calming measures down the length of Kings Road into Greenfield Road would be a welcome addition to the calming measures already proposed for the town centre.

Hi,

I'd like to voice some concerns regarding the proposal to replace the pelican crossing by Flitwick post office with a zebra crossing.

I've viewed the plans and am concerned that the crossing will be much closer to the roundabout. I regularly drive this route and find that when I am crossing the railway line and turning left at the roundabout to go north, crossing this area, that due to the height of the bridge walls it is a blind corner. Even as things currently stand, and being aware of the road layout, I find that it's difficult to see if cars have stopped for the current crossing until nearly round the corner.

The current crossing is very noticeable and there is plenty of space to stop if the lights are red for traffic, however even at the current distance from the roundabout traffic can quickly build up and block the roundabout.

The new zebra crossing seems to close to the roundabout. Not only will it be difficult for drivers to stop in time for someone crossing, but the traffic will build up and block the roundabout more quickly.

I'm not sure why it's felt that a zebra crossing will be better than the current pelican crossing, but if this is a necessary change, why can the new crossing not be in the same place at a safe distance from the roundabout?

I would like to raise my concerns with removing the current traffic lights at the pelican crossing and replacing with a zebra crossing.

The current scheme allows both traffic and pedestrians to 'have their turn', whereas a zebra crossing tends to halt the traffic for individual pedestrians and doesn't operate in such an efficient manner. At certain times of the day, there are school children, commuters and others using the crossing and as it is not usual for people to wait and cross in a group, traffic will be backing up whilst individuals cross continuously. There is an assumption that vehicles will stop if a pedestrian is waiting at a zebra crossing and I therefore feel it is not as safe as the current scheme.

My main concern is that it will dramatically slow the flow of traffic particularly at peak times when Flitwick already has congestion problems, and more sitting traffic will result in more car fumes.

Good afternoon,

I noticed several proposals for traffic measures in the Times and Citizen, 25th January.

I appreciate anything that will aid traffic calming in the area, but am puzzled by the above proposal, and wonder if you could clarify it for me.

As I see it:

- The present crossing is controlled. It is therefore safer for children, families, and people with poor mobility or vision. Am I right that 'zebra crossing' means no push-button control, or audio indication of when it is safe to cross?
- The present crossing leads to the Post Office, which is probably the busiest building in that row of shops and offices. It is therefore a natural choice of crossing point.
- Is the intention partly to improve traffic flow? The pelican crossing can cause temporary hold-ups on the High Street, particularly to the Station Square roundabout, and therefore the railway bridge. However, the bus stop and deliveries also cause blockages.
- My main concern, however, is the road layout nearest to the proposed zebra crossing. When northbound traffic is stopped at the moment, there is room for about 4 cars before a tailback begins at the Station Square roundabout and bridge. The proposed crossing would reduce this space and therefore push the tailback further into already congested areas. Along with this, I feel that cars

coming off the bridge on to the High Street, which have to concentrate on the traffic at several approaches to the Station Square roundabout, and make quick decisions about turning, may drive straight on to the crossing.

I hope I have understood your proposals correctly, and that you can give me further information.

Sir,

As a regular user of the Ampthill to Flitwick and beyond route I find it strange that you are to further congest the centre of Flitwick by changing the nature of this crossing. You may well be aware that congestion close to Redborne school in Ampthill is caused each morning and evening as children heading to and from school use the zebra crossing at the junction of Tavistock Avenue and Flitwick Road in twos and threes with short gaps between each little group. The traffic crawls along, often backing up to Glebe Road to the north and the 101 roundabout to the south. In Flitwick the pelican crossing holds people for a while and allows a better flow. This area also has bus stops on either side of the road often with buses waiting at both. Large lorries coming over the railway bridge sometimes block the mini roundabouts and traffic heading to and from Tesco, the station and the M1 is often very heavy. I anticipate that a zebra crossing will make an already bad situation even worse for car drivers and add polluting exhaust fumes to the air. To my mind a better proposition would be to change the Ampthill crossing to a pelican from the existing zebra.
