## **Background**

- The Bedfordshire (Structural Changes) Order 2008 came into force on 28 March 2008. Article 22 of that Order requires that not later than 21 days after coming into force of the Order that the Shadow Authority shall form a team of officers (the Central Implementation Team CIT) for the purpose of assisting the Authority in the transformation process. The members of the team shall comprise of officers of both the County Council and each of the District Councils. The Leader of the Joint Implementation Team shall be an officer of one of the District Councils.
- 2. The transition to the 2 new unitary authorities must take into account the wider sub-regional and partner agenda. It is important that we do not lose momentum on key aspects of our current joint work such as the growth agenda and improving performance through the mechanism of the Local Area Agreement. We have therefore invited representatives from our key partners to the first meeting of CIT which has been called for 15 April 2008 at Priory House. At that meeting partner colleagues will be asked to nominate representatives and to consider the proposed Implementation Strategy and how best they can influence making the transition a successful one for all of us. The CIT will, as can be seen below, comprise of officers from all three Councils and will support the work of the Shadow They will liaise closely with Bedford Borough's Joint Executive. Implementation Team, particularly in relation to disaggregation matters. They will consider matters referred from the Programme Board or Proper Officers.
- 3. We have started discussions with Bedford Borough and will be seeking to make sure that our demands upon partners are kept to a minimum by meeting and working jointly wherever possible. A representative of Bedford Borough (normally the Chief Executive) will join the CIT and there will be a reciprocal arrangement on the Bedford Borough Joint Implementation Team.
- 4. To meet the requirements of the Order and to provide support for the Shadow Executive it is proposed that the core members of the CIT are the officers from Mid Beds, South Beds and the County Council with the Bedford Borough Chief Executive joining whenever matters relate to the formation of the 2 new unitaries. They will consider matters referred from the Programme Board or the designated Proper Officers. The core membership is recommended as:

6. At the first meeting partners will be asked to consider the Implementation Strategy and the key issues that have been identified for the CIT to focus on. Once we have confirmed partners views we will finalise the CIT and its priorities in consultation with the Leader.

Members are therefore requested to confirm the appointment of the officers to form the core of the CIT, as set out above.
