RECOMMENDATION:

That a further report on ICT related matters be made to the next meeting of the Shadow Executive.

Reason for So that Shadow Executive can monitor progress and comply with the requirement of the Implementation Order regarding the need to maintain an implementation plan to deliver the new unitary authority.

Background

1. This is the fifth progress report to Shadow Executive since the Implementation Plan was agreed at the meeting on 10 June. The report follows the previously used format. 2. The Implementation Plan has continued to be used at the monthly meeting with DCLG officials to report on progress and updates have been considered by the meetings of the Central Bedfordshire Implementation Team which includes key partners.

Overall Progress and Variances

- 3. As Members may be aware a visit by the Local Government Minister, John Healey, scheduled for 7 October was rearranged to 21 October. The Minister's meeting with stakeholders did, however, take place on the 7th. Feedback from attendees and CLG officials has been very positive. The Chief Executive of Aragon Housing Association, who was present, has said that the approach being followed to create Central Bedfordshire "was praised by all concerned for the way it is involving stakeholders in the formation of the new council".
- 4. A copy of the latest Implementation Plan is copied at Appendix "A" and shows which targets are completed, on track, at risk, or delayed.
- 5. A major achievement since the last monitoring report has been reaching agreement at officer level with Bedford Borough on transitional service arrangements. The Implementation Plan targeted the completion of this work for the end of July. The next step is for the Interim Chief Executive to consult the Leader, Deputy Leader, relevant portfolio holder and Lead Member of the relevant Transitional Task Force as required by the Shadow Executive when it met in June (minute SE/07/11).

Expenditure on Creating Central Bedfordshire

7. All expenditure on the transition to Central Bedfordshire is managed centrally. The table below shows the transitional budget breakdown included in the December 2007 submission and commitments as at 7 October against that budget. As reported to the last meeting, expenditure on change management has exceeded the amount identified for this element of the cost of transition. Officers will continue to keep expenditure within the overall total of £18.2m under review in order to contain costs within the amount budgeted.

ICT Transition Issues

- 8. The meeting of Shadow Executive on 30 September heard an oral report from Deloitte about the outcome of an officer workshop held on 29 September. The workshop had considered how best to deal with the children's and adult electronic records currently used by Bedfordshire County Council. Deloitte have prepared a subsequent note which is attached at Appendix "B".
- 9. That meeting of the Shadow Executive also requested that a more detailed report on ICT transition issues be made to this meeting. Deloitte are currently preparing the report and officers hope to be in a position to circulate it on Friday 24 October. In the meantime the portfolio holder is being kept informed about its likely contents.
