#### Introduction

#### The 2004 Act

1.1 The Planning and Compulsory Purchase Act (2004) has brought about major changes in the planning system. The overall aim of the new system is to speed up the planning process, as well as to increase community involvement within the process. Regional Spatial Strategies are replacing Structure Plans, and for the Plan area this means the East of England Plan (published on May 2008) which replaces the Bedfordshire Structure Plan. Local Plans are being replaced by Local Development Frameworks (LDF), which will contain a suite of documents called Development Plan Documents and Supplementary Planning Documents (see 'diagram 1' below). Specific to minerals and waste, the Bedfordshire and Luton Minerals and Waste Local Plan will be replaced by the Development Plan Documents within the Minerals and Waste Development Plan Framework. Until existing policies are replaced by policies in the LDF, Local Plans retain development plan status and their policies are automatically "saved" for 3 years. Diagram 1 shows the contents of the Minerals and Waste Development Framework, including the Minerals and Waste Local Development Scheme, which has the role of a project plan. The object is to show the range of documents that will be produced and the timescale for their production.

#### **Changed Circumstances**

- 1.2 The first Minerals and Waste Development Scheme was approved in 2005, and then amended in 2006 and again in 2007. Changed circumstances include revised guidance concerning the production of Local Development Frameworks (Planning Policy Statement 12 creating strong safe and prosperous communities through Local Spatial Planning), and local government reorganisation. The revised PPS12 published in June 2008, amended the form and content of Local Development Documents, and how they are to be produced. In addition, a new Waste Strategy for England was published in 2007 which will help to guide the work.
- 1.3 The second reason an amended Local Development Scheme is brought forward relates to the reorganisation of Local Government in Bedfordshire, which has resulted in three unitary Authorities. Bedford Borough Council, Central Bedfordshire Council, and Luton Borough Council are now the Councils responsible for minerals and waste planning in their areas ("Minerals and Waste Planning Authorities"), as well as for progressing the Minerals and Waste Development Framework jointly. This Framework will consist of a collection of documents that bring forward the spatial strategies, detailed land use policies, and proposals for the extraction of minerals and management of waste in their areas.

#### Shared Service

1.4 The Minerals and Waste Development Framework will be produced and progressed by a Joint Minerals and Waste Planning Team, employed by Central Bedfordshire, but working on behalf of the three unitary authorities. In respect of minerals and waste developments it will provide the most specifically relevant areas of policy for guiding decisions on these forms of developments by the three Councils. Unlike the Minerals and Waste Local plan, which was a single document, the Minerals and Waste

Development Framework (MWDF) comprises a portfolio of documents as shown in Diagram 1.The programme for production of these plans is set out in this document, which is the Minerals and Waste Local Development Scheme (MWLDS). Along with this MWLDS, the Minerals and Waste Development Framework will contain Minerals and Waste Development Documents (MWDD's). These consist of Development Plan Documents (DPD's), which are subject to independent examination, and Supplementary Planning Documents (SPD's) which provide more detailed guidance for DPD policies, and are not subject to independent examination.

- 1.5 Within the Minerals and Waste Development Framework, there is also another document that sets out the how the local community will be involved in the development of the MWLDF, known as the Statement of Community Involvement (SCI), which for Bedfordshire was adopted in 2006. This is not a Minerals and Waste Development Document, though it is subject to consultation and independent examination. Together with the Regional Spatial Strategy (East of England Plan), these documents will comprise the statutory development plan, which will be the basis for future minerals and waste planning decisions. The Minerals and Waste Development Plan Documents (MWDPDs), as they are adopted, will progressively replace the adopted Bedfordshire and Luton Minerals and Waste Local Plan.
- 1.6 The 2007 Local Development Scheme proposed the preparation of five DPDs:
  - Minerals Core Strategy
  - Minerals Site Allocation Plan
  - Waste Core Strategy
  - Waste Site Allocation Plan
  - General Environment Policies

The latest version of PPS12 produced in June 2008, suggests that Strategic sites may be included in Core Strategies. "Strategic" sites are defined as those essential for the successful implementation of the Plan. Since the majority of waste and mineral sites are essential to achieve the objectives of those Plans, they will be included in the working draft Core Strategies. In addition it is considered feasible to combine the documents containing preparatory work for the Minerals and Waste Core Strategies, into a single combined Minerals and Waste Core Strategy, since issues of the restoration of mineral void spaces, and the production of secondary aggregates, relate to both. In addition it is intended to produce a General Environment Policy DPD, concerning issues about the location and impacts of new mineral extraction and waste management sites. This is being prepared separately since alterations to national policy concerning planning controls, and changes of local circumstances, will continue to evolve at a different timescale to that of the strategic policies contained in the Core Strategy.

1.7 This MWLDS sets out the detailed timetable for the preparation of the above mentioned planning policy documents that will make up the Minerals and Waste Development Framework. Along with setting out which documents are to be produced, this MWDS highlights the main stages when stakeholders and the public may wish to be involved in the production of each plan. This MWLDS is available to purchase from the Councils or is available to download free of charge via the Councils' websites.



#### 2 Objectives and Content of the Minerals and Waste Development Scheme

#### Objectives

- 2.1 This Minerals and Waste Development Scheme has two main objectives. Firstly it acts as a starting point for the community and stakeholders to find out about the Councils planning policies in respect of minerals and waste issues, and what status these policies will have. Secondly, it outlines the details of, and timetable for, the production of minerals and waste development documents in detail, including timetables which will inform people when the various stages in the preparation of any particular local development document are intended to be carried out.
- 2.2 The Minerals and Waste Development Scheme sets out:
  - .A brief analysis of what will be contained within the portfolio of the Minerals and Waste Development Framework (MWDF);
  - A description of all the documents within the MWDF to be prepared and the content and geographic areas to which they will relate;
  - Which Minerals and Waste Development Documents( MWDD) will be development plan documents (DPDs) and which will be supplementary planning documents (SPDs);
  - In the transitional period, which of the saved policies and proposals of the Bedfordshire and Luton Minerals and Waste Local Plan will be replaced by MWDD's;
  - An explanation of the relationship between the documents within the MWDF;
  - The planned timetable for preparing each document and the key milestones to be achieved;
  - The resources required and the approach to be used for the MWDF Documents;
  - An explanation of how progress against the MWDD's will be monitored and reviewed.
- 2.3 In addition to the Minerals and Waste Development Documents, there will also be a number of Technical Evidence Papers which will be produced for inclusion in the evidence base as to the 'soundness' of these plans at Examination.

#### CONTENT

#### **Regional Spatial Strategy**

2.4 The East of England Plan (the Regional Spatial Strategy) provides the context for preparation of the local level Development Plan Documents. The regional plan encompasses minerals planning policy statements, accompanying guidance and other relevant national policies to provide a strategic framework for the minerals planning authorities to prepare Development Plan Documents. For example, Policy M1: Land won Aggregates and Rock - requires Bedfordshire and Luton to maintain an annual average level of 1.93 million tonnes pa of land-won sand and gravel 2001-16. There are eight waste management policies, including Policy WM4: Regional Waste Apportionment, which for Bedfordshire & Luton sets out annual tonnages of waste to be managed to 2021. A function of the proposed DPDs is to demonstrate how these strategic policies can be implemented at the sub-regional and local level.

#### Minerals and Waste Development Plan Documents (MWDPDs)

- 2.5 The proposed Development Plan Documents shown in Diagram 1 are statutory policy documents which will form the basis for development control decisions on Minerals and Waste planning applications will be made in accordance with them, subject to any other material considerations. These Plans will carry a similar status to the former Minerals and Waste Local Plan. Development Plan Documents will be produced in consultation with stakeholders and the public, and will be subject to independent Examination. The key stages in producing MWDPDs are:-
  - Evidence Gathering
  - Identification of key issues and policy options
  - Preferred Options published for consultation (optional)
  - Consideration of comments and preparation draft Core Strategy or other DPD
  - Pre-Submission Publicity
  - Submission of Core Strategy (or other DPD) to Secretary of State
  - Examination by Inspector
  - Inspectors Binding Report
  - Adoption
  - Monitoring
- 2.6 The Town and Country Planning (Local Development) (England) Regulations 2004 and Amendment Regulations 2008 also require, for each Plan, production of:-
  - A Statement of Conformity with the East of England Plan;
  - An explanation of how a new Plan relates to "saved" planning policies contained in the current Minerals and Waste Local Plan; and
  - A description of the stakeholder and public involvement undertaken and how this accords with the Statement of Community Involvement.

#### **Proposals Map**

2.7 A Proposals map will be produced in parallel with the production of the MWDPDs and updated as plans are adopted. It will illustrate all the proposals and policies contained within the Minerals and Waste DPD's and be in conformity with the Minerals and Waste Core Strategy, and the General and Environmental Policies DPD, as well as National and Regional Guidelines. This is in accordance with Regulation 9 of the Town and Country Planning (Local Development) (England) Regulations 2004.

#### Minerals and Waste Supplementary Planning Documents (MWSPDs)

- 2.8 Supplementary Planning Documents (SPDs) are intended to elaborate on adopted policies. While they are subject to public consultation, there is no formal Examination stage, and have the status of being a" material consideration" in the determination of a planning application.
- 2.9 Bedfordshire County Council and Luton Borough Council adopted an SPD entitled "Managing Waste in New Facilities" in April 2006. It provides further detail regarding saved policies W5 and W6 of the adopted Minerals and Waste Local Plan of 2005. This Document provides guidance on reducing, recycling, and recovering waste during demolition, construction and occupation of new developments, and embedding waste storage and collection facilities into new developments. The adopted SPD is intended to remain in force, and fulfil the vital function of assisting in waste reduction and promoting storage of recyclable materials and wastes. It will be reviewed at a later date when saved policies W5 and W6 have been replaced. No additional SPDs are proposed.

#### Bedfordshire Statement of Community Involvement (SCI)

2.10 Bedfordshire County Council adopted their Statement of Community Involvement in October 2006. It explains how the general public and others with interest in development plans can be involved in the Minerals and Waste Development Framework process.

The stages involved in producing the Statement of Community Involvement were:

- Scoping
- Pre Production Consultation (Required by Regulation 25)
- Production of preferred options (Required by Regulation 26)
- Revised Document Submitted to Secretary of State
- Public Consultation Period
- Examination
- Inspectors Binding Report
- Adoption
- Monitoring
- 2.11 Now that this Statement of Community Involvement is adopted, the Councils will be monitoring its use, so that techniques for community engagement and involvement, and the range of organisations engaged, are sufficient and appropriate. If necessary, the SCI will be reviewed and revised.

#### Sustainability Appraisal

2.12 The Sustainability Appraisal (SA) of Plans, required by S.19 (5) of the Planning and Compulsory Purchase Act 2004, is an appraisal of the economic, social and environmental sustainability of a plan. This also incorporates the requirements of the European Directive on Strategic Environmental Assessment. The SA should perform a key role in providing a sound evidence base for the plan and form an integrated part of the plan preparation process. The SA informs the evaluation of alternatives so as to demonstrate that the eventual plan is the most appropriate, given the reasonable alternatives. This will be carried out by Consultants.

#### **Technical Evidence Papers**

2.13 A series of Technical Evidence Papers will accompany the Minerals and Waste Combined Core Strategy and the General Environment Policies DPD. A preliminary list is set out here. However, this list will continue to evolve as the documents are progressed.

Minerals and Waste Core Strategy DPD includes:

- 1. Statement of Conformity with the Regional Spatial Strategy.
- 2. The relationship between the Minerals and Waste Core Strategy and the saved policies of the Minerals and Waste Local Plan.

- 5. The Need for additional Waste Management Facilities
- 6. A Summary of the alternative options considered.
- 7. Appropriate Assessment
- 8. Sustainability Assessment
- 9. Strategic Flood Risk Assessment
- 10. Relationship between the Waste Core Strategy and the Community Strategies.
- 11. Equalities Impact Assessment.
- 12. Bedfordshire Silica Sands Study 2006/06 (by Cuesta Consulting Limited)
- 13. Bedfordshire Aggregates Landbank Study 2005 (by Cuesta Consulting Limited)
- 14. Reports of Annual Monitoring Surveys for Aggregates and Wastes.
- 15. Annual Monitoring Reports.

General Environment Policies DPD:

- 1. Statement of conformity with the Regional Spatial Strategy.
- 2. The relationship between the General Environment Policies DPD and the saved policies of the Minerals and Waste Local Plan.
- 3. Summary of Community Engagement undertaken and its compliance with the adopted Statement of Community Involvement.
- 4. A Summary of the alternative options considered.
- 5. Appropriate Assessment
- 6. Sustainability Assessment
- 7. Relationship between the Waste Core Strategy and the Community Strategies.
- 8. Equalities Impact Assessment.

#### Annual Monitoring Report

- 2.14 A further document which is required to be produced is an Annual Monitoring Report (AMR). This will assess, for each financial year, the progress made in Plan preparation, and monitor the effectiveness of policies and proposals. An AMR is particularly useful in determining:-
  - Whether targets and milestones have been met, and changing circumstances;
  - Policy effectiveness, particularly regarding minerals and waste targets;
  - The need to review any policies in the light of findings above; and
  - The need to review this Development Scheme, due to monitoring implications or legislative changes.

#### Indicators

- 2.15 To enable monitoring, appropriate indicators to monitor and assess actual progress against targets will be set. Guidance sets out that there needs to be an objective led approach to MWDF monitoring, which should:
  - Ensure clear links from objectives through to policies, implementation programmes and to output targets and related indicators;
  - Focus on key objectives rather than monitoring a wide range of indicators not directly relevant to policy performance;
  - Provide sufficient consistency in terms of local authority monitoring approaches to enable comparisons to be made;
  - Allow transparency and accountability in terms of delivery;
  - Facilitate more informed policy and decision making.

#### 3 THE MINERALS AND WASTE DEVELOPMENT DOCUMENTS: PROGRAMME MANAGEMENT FOR PREPARATION

#### **OVERVIEW**

#### Saved Policies

3.1 The Bedfordshire and Luton Minerals and Waste Local Plan, 2000 – 2015, was adopted in January 2005, and was automatically saved until January 2008. However, it is anticipated that the new generation of plans will not be adopted until 2011, which could have left a potential three year 'gap' in terms of planning policies. A Government Protocol was published in August 2006, setting out how policies could be saved over the longer term, and which involved giving the Government Office sufficient notice of intent, and making a formal request. Confirmation was received from Go-East on the 14<sup>th</sup> September 2007 that all minerals and waste policies have been saved until replaced by the new MWDF policies, except two waste policies considered "expired", namely:

- W10 (Household Waste Recycling Centres); and
- W15 (Pre-landfill treatments for biodegradable waste).

#### **Minerals**

3.2 In relation to minerals the following preparatory work has been undertaken:-

- Minerals Core Strategy and Site Allocations Plans Issues and Options stage Consultation documents underwent public consultation in February 2006.
- A Minerals Core Strategy Preferred Options Consultation Paper (published for consultation 19<sup>th</sup> September 2007-31<sup>st</sup> October 2007) which set out core policy proposals for mineral development; and
- A Minerals Site Allocations Plan Preferred Options Consultation Paper (published at the same time for public comment) which set out preferred site allocations for future mineral working.
- A new site proposal (Clipstone-reference MD50) necessitated additional consultation 28<sup>th</sup> April-2<sup>nd</sup> June 2008.

#### Waste

3.3 In relation to waste the following preparatory work has already been undertaken:-

- Waste Core Strategy Issues & Options Consultation Paper I with policy issues presented for comment which underwent public consultation from 1st October to 30<sup>th</sup> November 2007.
- Waste Site Allocations Plan Issues & Options Consultation Paper II (same dates) which set out a portfolio of potential new sites for waste facilities nominated by waste operators and landowners. The Paper also acted as a call for new site nominations. Following this Paper, a further eight waste sites were put forward for possible inclusion within the Plan, and there was also a site amendment regarding capacity. This led to additional consultation from 28<sup>th</sup> April –2<sup>nd</sup> June, 2008, with an intended next stage of preparing Preferred Options Waste DPDs.

#### **Combined Minerals and Waste Core Strategy**

- 3.4 It is now envisaged that a combined Minerals and Waste Core Strategy, including Strategic Sites, will be produced, which will further develop the work already carried out, as described above. The intended programme anticipates adoption of the Plan by January 2012.
- 3.5 There are cross connecting issues such as the restoration of mineral voids, and the provision of secondary aggregates from construction and demolition wastes, which mean that it is appropriate for the Waste and Mineral Core Strategies to merge into a single Core Strategy DPD.

#### **General Environmental Policies**

3.6 The General and Environmental Policies form a separate section in the Bedfordshire and Luton Minerals and Waste Local Plan 2000 - 2015. These Policies provide the basis for assessing site specific issues concerning the location and impacts of minerals and waste developments, including schemes for their reclamation. The current policies from the adopted Minerals and Waste Local Plan are saved, until replaced by a General Environment Policy DPD, scheduled to be adopted by June 2014.

#### **Supplementary Planning Document**

3.7 Saved Policies W5 and W6 of the adopted Local Plan underpin the Supplementary Planning Document 'Managing Waste in New Developments' as indicated in paragraph 2.9. Specifically, the SPD aims to encourage the reduction of waste at source in the construction and development process (and especially construction and demolition wastes), through Waste Audits; as well as providing guidance on the provision of waste collection and storage facilities in households, Centralised Facilities, Household Waste Recycling Centres, Commercial Developments, and Mixed Developments.

#### **Other Development Plans**

3.8 Bedford Borough Council, Central Bedfordshire Council, and Luton Borough Council, are each producing Local Development Frameworks for their areas, which cover non-mineral and waste planning matters. Under the terms of a statutory instrument ('The Luton and South Bedfordshire Joint Committee Order 2007') the functions of this joint committee excluded minerals and waste development planning. This meant that Luton Borough Council retained responsibility for these subject areas.

#### 4. Minerals and Waste Development Document Profiles

#### Combined Minerals and Waste Core Strategy, including Strategic Sites.

- 4.1 The preparatory work carried out so far will be merged into one Minerals and Waste Core Strategy Development Plan Document. However, prior to merging these DPDs into one, the key work will be to:
  - undergo public consultation and engagement on the preparatory work for a working draft Waste Core Strategy, in the autumn of 2009;
  - carry out preparatory work on Mineral Safeguarding Areas and, as part of the preparatory work for a working draft Mineral Core Strategy, undergo publicity and consultation, during 2009;
  - following which a combined Minerals and Waste Core Strategy will be prepared, for Submission to the Secretary of State
- 4.2 The Minerals and Waste Core Strategy will include Strategic Sites, for both mineral working and waste management, and eliminate the need for separate Site Specific Proposals DPDs. Non-strategic sites that come forward as planning applications, will be considered on their merits, according to specific criteria.

Consultants were previously successfully employed in the production of the Statement of Community Involvement, and the Supplementary Planning Document 'Managing Waste in New Developments'.

-Temporary staff may be required to assist with the public consultation stages where there are heavy workloads.

#### 6. Risk Assessment

In preparing the Local Development Scheme, it was found that the main areas of risk relate to:

• Staffing Levels: Currently there are three full time members of staff working on the Minerals and Waste Development Framework. There are risks to the timetable, should officers leave service or fall ill, or there may be problems in recruiting staff. These risks will be mitigated by prompt action to re-deploy resources if necessary.


• Arrangements for engaging and seeking the approval of Members of the three Authorities to proceed to the next stage in the adoption of a Development Plan Document: This may contribute to potential delay, since three authorities have ownership of the Minerals and Waste Local Development Documents.

• The Capacity of Outside Agencies: A number of external agencies will be involved in the production of the Minerals and Waste Development Framework. An issue relates to the capacity of the consultancy sector in general to cope with widespread demand nationally. In order to try and reduce this risk, the Councils will try and engage with the various organisations as soon as possible, to enable them to plan their work, and programme their timing for responding to consultation and engagement.

• Provision of information by key stakeholders and organisations: There may be instances when key organisations are unable to provide timely information essential to the production of Development Documents, including the Annual Monitoring Report. Project planning will seek to mitigate this potential problem.

• Legal challenge: This will be minimised by extensive work to ensure that the MWDPDs are "sound", prepared in accordance with relevant legislation and regulations, and founded on a robust evidence base, together with a well audited stakeholder and community engagement.

• Programme Slippage: Each stage of Plan preparation will be subject to Project planning, which will include making contingency allowances. For example, to allow for changes or additional evidence preparation before Submission of a DPD to the Secretary of State; and for adoption by three Councils. All plans will be subject to regular review related to circumstances current at the time.
